REQUESTED ACTION

Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300) on the basis of a low bid of \$2,986,596.30 for resurfacing of approximately 34 miles of various Tier 2, 3 and 4 roadways in District I in Coos County, from the date of Governor and Council approval through September 13, 2019, unless extended by the Department in accordance with the Standard Specifications. 100% Other Funds (77% Betterment Funds, 23% Agency Income).

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is included in the State's Ten Year Transportation Improvement Plan and part of the annual Maintenance District resurfacing program with additional funding for paving through SB 367 Road Toll Increase. This project involves resurfacing of various roadway segments located in Maintenance District I in Coos County. The resurfacing program consists of 15 sections totaling 34.0 miles in 11 towns.

This project is part of the CY 2019 District Resurfacing Program. The project will improve the roadway ride quality and therefore improve safety. The sections will be resurfaced via paver shim and spot paver drag shim. In addition to resurfacing, 10 existing sidewalk curb ramps in 1 section will be improved to comply with ADA regulations.

Although the bid costs exceeded the Department's estimate by 3%, the low bid of 2 bids received is felt to be reasonable for the work involved. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedures. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.


CONTINGENCY: There is no contingency for this project.

PROJECT INITIATED: The Pavement Management Section has reviewed the road segments included in this project and identified a need for a variety of pavement maintenance, preservation, and rehabilitation actions. This project will improve the roadway ride and increase safety.


PROJECT EXPLANATION: This project is part of the CY 2019 District Resurfacing Program. The sections will be resurfaced via paver shim and spot paver drag shim. In addition to resurfacing, 10 existing sidewalk curb ramps in 1 section will be improved to comply with ADA regulations. All impacted towns and utilities will be notified of the work.

TRAFFIC IMPLICATION: One lane will be closed at a time for construction activities with appropriate signage, portable changeable message signs, flaggers, and uniformed officers where required. Lane closure lengths will be limited to one mile with a 2 mile separation required between work zones. Traffic will be restored to normal operating patterns at the end of each work day. The eastern railroad crossing on Section 19144 will be closed completely to reconstruct the crossing. Traffic control for road closure will be completed by St Lawrence and Atlantic Railroad (SLRR). Contractor will coordinate with SLRR for paving operations. Work zone significance was determined to be non-significant at the December 21, 2018 TCC Meeting.
