REQUESTED ACTION

Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of Health and Human Services, Office of the Commissioner, to accept and expend federal funds from the American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) in the amount of \$5,005,000 that will be used to support emergency shelter and homelessness initiatives during the winter of 2022 and 2023, effective upon Fiscal Committee and Governor and Executive Council approval through June 30, 2023, and further authorize the allocation of these funds in the accounts below. This is an allowable use of ARPA SFRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts. 100% Federal Funds.

EXPLANATION

The purpose of this request is to accept and expend funds for a homeless shelter initiative that would provide one-time grants to support homeless shelter providers across New Hampshire, including short term cold weather shelters, to address pandemic related increased costs and anticipated demand as the winter months approach.

Shelters are safety net providers, and they often provide fatality prevention for those who do not have a home. This coming winter many shelters will still have COVID-19 related expenses to meet community need, e.g. they must maintain social distancing, have isolation and quarantine locations, and provide more PPE when needed. Moreover, many shelters do not have enough resources to cover the increased cost of food, electricity, and heat. Pre-pandemic, many shelters relied on volunteers for staffing. Due to the pandemic and the increased acuity of those at the shelters, there are fewer volunteers, increasing the reliance on paid staff who remain.

Even with existing shelters serving at capacity there is likely to still be a gap in accommodating people during the upcoming harsh winter months, and temporary cold weather shelters help bridge that gap.

Statewide, DHHS contracts with 19 shelter providers for 791 emergency shelter beds, but DHHS does not fund temporary cold weather shelters. Preliminary data for the 2022 Point-In-Time count shows 1,605 people experiencing homelessness, an increase of 7.6% from 2021.

These and other factors could have negative consequences with regard to these facilities being able to meet the anticipated need. This puts vulnerable New Hampshire residents at risk.

To help address the impending need and maximize the reach of these funds in both urban and rural areas of the State, the Department intends to utilize ARPA SFRF funding for the following:

- Provide \$4M in one-time grants to the existing homeless shelters under contract with the
 Department for COVID-19 related/impacted costs. Funds will be distributed across shelters
 currently on contract with DHHS, accounting for the known number of beds at each facility;
 and
- Provide \$1M in one-time grants to each county or municipality and/or nonprofits/coalitions
 to assist with the operation of cold weather shelters. Funds will be allocated based on the
 preliminary numbers for those experiencing homelessness from the January 2022 Point in
 Time Count in each county.

Funds will be budgeted as follows:

Class 041 - The funds will be used to pay for audit fund set aside per State requirement.

Class 102 - The funds will be used to pay for the contracted services.

Area served: Statewide

Source of Funds: These funds are 100% Federal.

In the event that these Federal Funds become no longer available, General Funds will not be requested to support this program.
