**NEW HAMPSHIRE DEMOCRATIC PARTY'S OBJECTION PURSUANT TO RSA
655:44 TO THE PLACEMENT ON THE GENERAL ELECTION BALLOT OF SHAWN
O'CONNOR FOR THE FIRST CONGRESSIONAL DISTRICT**

INTRODUCTION

1. This is an objection pursuant to RSA 655:44 to the placement on the general election ballot of Shawn O'Connor for the First Congressional District. On or about September 7, 2016, Shawn O'Connor submitted 1,508 nomination papers to the Secretary of State pursuant to RSA 655:40 et. seq. and the Secretary of State has presumptively certified that Mr. O'Connor has satisfied the statutory criteria for ballot placement. However, Mr. O'Connor submitted at least 6 nomination papers that are duplicates signed by the same registered voter and Mr. O'Connor submitted at least 26 nomination papers signed by registered voters who also signed nomination papers for another candidate for the same office, contrary to RSA 655:40. Additionally, Mr. O'Connor has submitted at least 14 additional nomination papers which do not conform to the requirements of RSA 655:40 in that they contain the incorrect domicile address or other deficiencies, his name should not be placed on the general election ballot. Mr. O'Connor, therefore, has not submitted 1,500 valid nomination papers required by RSA 655:42, II and, therefore, his name should not be placed on the general election ballot. The New Hampshire

Democratic Party reserves the right to supplement the number of nomination papers challenged prior to or at any hearing on this matter.

PARTIES

2. Petitioner, The New Hampshire Democratic Party ("NHDP"), is a political party as defined by N.H. RSA 652: 11. NHDP's address is 105 North State Street, Concord, New Hampshire 03301. Raymond Buckley is the duly elected chairman of the New Hampshire Democratic Party and is authorized to act on behalf of said party in this matter. Petitioner, New Hampshire Democratic Party, has a substantial interest in assuring that candidates for election to office in New Hampshire are legally qualified to serve in the office for which they seek election. Mr. Buckley is also a registered voter in the City of Manchester, New Hampshire and has a substantial interest in assuring candidate for election to office in New Hampshire are legally qualified to serve in office for which they seek election. NHDP and its Chairman appear through their undersigned representative, William E. Christie, Esquire, Shaheen & Gordon, P.A, 107 Storrs Street, P.O. Box 2703, Concord, New Hampshire 03302. Bal. 202.01(a).

3. Respondent, Shawn O'Connor ("Mr. O'Connor"), is a resident of Bedford, New Hampshire. Mr. O'Connor is an independent candidate for the United States Congress for the First Congressional District.

JURISDICTION

4. RSA 655 provides that the Ballot Law Commission shall hear and determine disputes arising over whether nomination papers or declarations of candidacy filed with the Secretary of State conform with the law.

5. RSA 655 provides objections to nomination papers made in accordance with RSA Ch. 655 are valid if filed no later than the Monday following the last day for the filing of such

papers. Because the last day for filing nomination papers was September 7, 2016, this Objection is timely filed.

RELEVANT STATUTORY AUTHORITY

6. “As an alternative to nomination by party primary, a candidate may have his or her name placed on the ballot for the state general election by submitting the requisite number of nomination papers.” RSA 655:40. “Such papers shall contain the name and domicile of the candidate, the office for which the candidate is nominated, and the political organization or principles the candidate represents.” Id. “Nomination papers shall be signed by such persons only as are registered to vote in the state general election.” Id. “**No voter shall sign more than one nomination paper for each office to be voted for**, and no nomination paper shall contain the names of more candidates than there are offices to be filed.” Id. (emphasis added). “Each voter shall sign and date an individual nomination paper.” Id. “Nomination papers shall be dated the year of the election.” Id.

7. Each nomination paper shall be submitted to the supervisors of the checklist of the town or ward in which the signer is domiciled or is registered for certification whether or not the signer is a registered voter in said town or ward. RSA 655:41.

8. Candidates for the United States Congress must submit at least 1,500 valid nomination papers in order to obtain placement on the general election ballot. RSA 655:42, II.

9. “Nomination papers shall be filed with the Secretary of State no later than 5:00 p.m. on the Wednesday one week before the primary.” RSA 655:43, I. “Nomination papers to be filed shall be grouped by municipality.” Id.

10. “Nomination papers made in accordance with the provisions of this chapter shall be regarded as valid and shall be received by the secretary of state unless objection thereto is

made in writing no later than the Monday following the last day for the filing of such papers.”
RSA 655:44.

DISCUSSION

11. Because Mr. O’Connor has not submitted at least 1,500 valid nomination papers, he does not satisfy the criteria for placement on the general election ballot as a candidate for the First Congressional District. The law is clear that “no voter shall sign more than one nomination paper for each office to be voted for ...” RSA 655:40. The purpose of such ballot access laws is to ensure a candidate has a “substantial measure of support as a prerequisite to appearing on the ballot.” Barr v. Galvin, 626 F.3d 99, 111 (1st Cir. 2010). New Hampshire has determined that limiting a voter to one signature for each office signifies that the voter in question has demonstrated a level of support for a particular candidate. Accordingly, in circumstances where a voter has signed more than one nomination paper for the same office, that nomination paper is not valid because the voter has not demonstrated support for a single candidate to appear on the ballot for the office in question. Mr. O’Connor has failed to submit at least 1,500 valid nomination papers.

12. Mr. O’Connor submitted 1,508 nomination papers. As demonstrated in the attached spreadsheet, Mr. O’Connor has submitted at least 6 nomination papers that are duplicates signed by the same registered voter. See Exhibit 1 incorporated fully herein. Mary Ann Lacroix, Sarah Potter and Sylvia Ouellette each signed two nomination papers for Mr. O’Connor that were certified by the supervisors of the checklist. Accordingly, these **6** nomination papers are not valid pursuant to RSA 655:40 et. seq. In the alternative, only one nomination paper per voter should be counted and therefore **3** of these nomination papers are not valid pursuant to RSA 655:40 et. seq.

13. Additionally, as demonstrated in Exhibit 1, at least **26** voters who signed nomination papers for Mr. O'Connor also signed nomination papers for another candidate seeking the same office:

Accordingly, these **26** nomination papers are not valid pursuant to RSA 655:40 et. seq.

14. Mr. O'Connor also submitted at least 14 additional nomination papers that do not comply with RSA 655:40 for a variety of reasons:

- a) 5 Nomination Papers that do not contain the correct domicile address within the town where the voter is apparently domiciled (James Thompson, Susan Svares, Nicole Mottola, Kevin Mitchell, Rayna Burke);
- b) 1 Nomination Paper that contains no street address (William Cole);

- c) 4 Nomination Papers that identify one town where the voter is domiciled, but were certified by a supervisor of the checklist in another town (Natalie Bean, Justin Vartanian, Alexis Moore, Copy Stanley);
- d) 2 Nomination Papers that listed a P.O. Box as the domicile address (Richard Goguen, Anne Pinciario);
- e) 1 Nomination Paper that did not date the form (Chris Cassamus); and
- f) 1 Nomination Paper containing two domicile address for one voter (Jenny Sinclair).


15. NHDP reserves the right to present additional objections, evidence and legal argument at any hearing scheduled on this Objection.

WHEREFORE, NHDP and its Chairman respectfully request that the Ballot Commission:

- a) Schedule a Hearing on the within Objection;
- b) Issue an Order that Mr. O'Connor has not submitted 1,500 valid nomination papers and, therefore, is not eligible to have his name placed on the ballot for the general election; and
- c) Grant such further relief as is necessary, just and fair.


