Stephen Appleby has been employed by the Department of Education (DOE) for over 2 years and is currently the Director of the Division of Educator Support and Higher Education. Stephen's responsibilities include administering the statewide standards for the credentialing of K-12 educators and educator preparation programs, supporting the Higher Education Commission, managing several scholarship funds, overseeing the regulation of New Hampshire licensed career schools, managing the closed school transcript fulfillment process, and U.S. Veterans Administration education fund institutional approvals.

The Department of Education encourages professional growth, which will be advantageous to both the employee and to the educators of New Hampshire.

This course will not be taken on State time.

THE STATE OF NEW HAMPSHIRE EDUCATIONAL TUITION AGREEMENT DEPARTMENT OF EDUCATION

Agreement dated this <u>31</u> day of <u>August 2020</u> by and through the Department of Education (hereinafter referred to as the "State) and <u>Stephen Appleby</u> (hereinafter referred to as the "Recipient"). The State and the Recipient do hereby mutually agree as follows:

- The State shall pay to the named institution the sum of \$2049.00, which monies shall be used for the purpose of enrolling the Recipient in: <u>PA 813 Human Resource Management in Public and Non-Profit Sectors (course name)</u>, which course(s) is being offered by <u>University of NH</u> and which course(s) shall commence on <u>October 13, 2020</u>, and terminate on <u>December 8, 2020</u>.
- 2. The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.
- 3. Should the Recipient fail to complete or achieve a passing grade in each course named in paragraph 1, the Recipient shall pay to the State the sum set forth in paragraph 1, provided, however, that if more than one course is named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rate basis.
- 4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of <u>six (6) months</u>.
- 5. The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.
- 6. Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.
- 7. The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.
- 8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
