REQUESTED ACTION

Authorize the Department of Health and Human Services, Office of the Commissioner to make a **retroactive** one-time payment from State Fiscal Year (SFY) 2022 funds to Zoitsa G. Cotnoir, Program Assistant II at the HHS: Commissioner's Office in the amount of \$2,508.18. This payment is to compensate the employee for wages that were not paid for State Fiscal Year 2020 & 2021. The funds to be paid will be one hundred percent (100%) Federal Funds. Funds are available in the following account as follows:

EXPLANATION

This is the fifth of five remaining requests, all to be presented to Governor & Council on June 1, 2022. This request is made retroactively because the Division of Public Health Services received permission from the Division of Personnel to apply retroactive temporary reclassifications to select staff who worked out of classification as part of the COVID-19 response. While discussions about the temporary reclassifications began as early as March 2021, they were not approved until August 2021. Relevant information about the affected employees, the dates of the temporary reclassifications and the appropriate titles was collected by the Division of Public Health Services in October 2021, and a process for applying the retroactive temporary reclassifications

was finalized in February 2022. Ms. Cotnoir served as a Laboratory Assistant II on behalf of the Division of Public Health Services from March 02, 2020 to March 26, 2021.
