Thank you for recently participating in the *Tour of Dental Therapy in Minnesota* sponsored by The Pew Charitable Trusts ("Pew"), which took place at various locations in Minneapolis, Minnesota on December 5-7, 2013.

You may recall that we notified you before the conference of Pew's lobbying status in your state and indicated that we would provide you with actual expenses paid on your behalf. As promised, we are pleased to provide you with the following information:

Pew paid a total of \$947.90, including tax and gratuities, for food, travel, lodging and ground transportation on your behalf in connection with your attendance at the *Tour of Dental Therapy in Minnesota*.
