REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Brox Industries, Inc. (Vendor 177569) of Dracut, MA, on the basis of a low bid of \$5,362,536.46 for roadway resurfacing in eight towns in Districts 5 and 6, from the date of Governor and Council approval through July 30, 2021, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2020 and Fiscal Year 2021, and is anticipated to be available in Fiscal Year 2022, upon the continued appropriation of funds in the future operating budget, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$268,126.82 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan. This project is part of the Tier 2 Federal Resurfacing program and involves 14.2 miles of pavement resurfacing on five sections in eight towns in Districts 5 and 6.

- 18518: Manchester-Hooksett, NH 3A, 1/2" leveling course and 1" full width high strength overlay (1.0 mile), 2" full width high strength inlay (1.4 miles), 2.40 miles
- 18537: Salem, NH 97, 2" full width high strength inlay (0.9 miles), 0.9 miles
- 19507: Goffstown, NH 114, ¹/₂" leveling course and 1" full width high strength overlay (2.5 miles), 2" full width high strength inlay at signalized intersections (0.4 miles), 4.0 miles
- 19509: Londonderry, NH 128, 1³/₄" full width high strength overlay (3.0 miles), 2" full width high strength inlay at signalized intersections (0.4 miles), 4.0
- 20604: Hampstead-Danville-Kingston, NH 111, ¼" full width paver shim (3.4 mi) 2" full width high strength inlay at signalized intersections (0.4 mi), 1½" full width high strength inlay (0.2 mile), 4.0 miles

Additional work involves bridge plug joint repair, drainage improvements, guardrail rehabilitation, and curb ramp reconstruction.

The purpose of this project is to extend the life of the existing pavement infrastructure and minimize the need for costlier improvements in the near future.

The proposed contingency amount is 5% of the contract amount. This project was quantified based on field observations, aerial photos, and as-built plans. Field adjustments may be required due to varying field conditions. In addition, the sections will continue to deteriorate through the 2019-2020 winter and asphalt prices are currently in escalation.

Although the bid costs exceeded the Department's estimate by 13.06%, the only bid received, is felt to be reasonable for the work involved. Nine items contributed to \$561,000 (90% of the overage; maintenance of traffic, mobilization, pavement marking, cold planning, guardrail, pavement (2), excavation (2). A significant amount of the work needs to be completed at night which likely contributed to limited interest (1 bidder) and influenced bid prices. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal (Pave-T2-Resurfacing), with anticipated utilization of Turnpike Toll Credit for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.

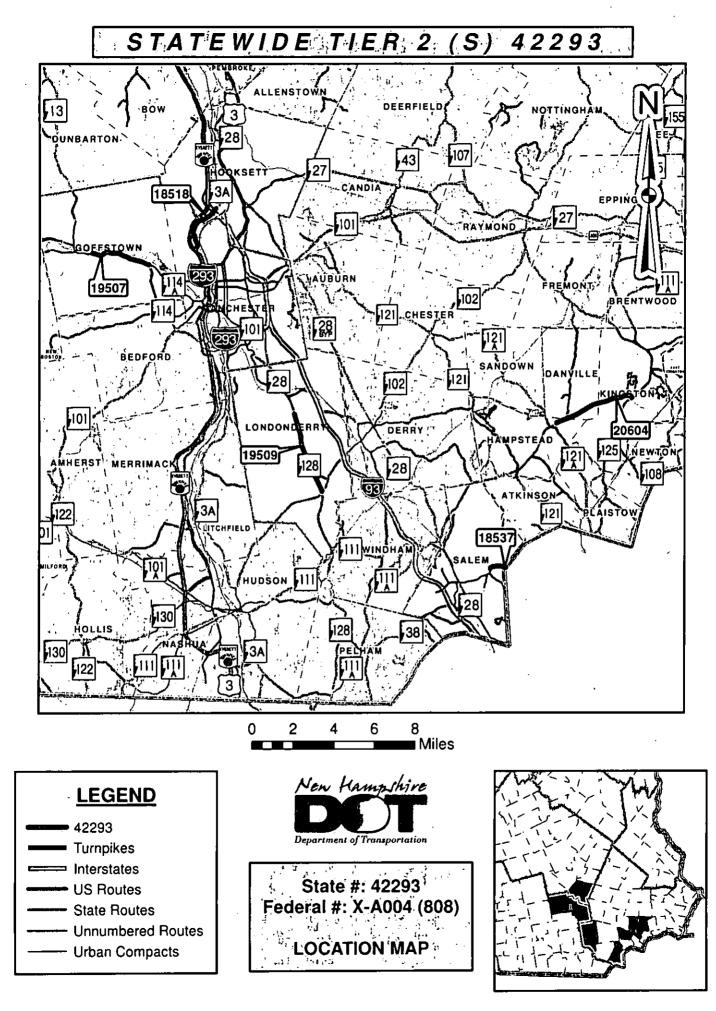
