REQUESTED ACTION

Pursuant to New Hampshire RSA 21-I:54, authorize the Department of Education to continue three full time temporary positions effective upon Governor and Council approval through June 30, 2023 as detailed in the requests dated April 15, 2022:

1. Division of Learner Support, Program Specialist IV position – 8T3068. Labor Grade 25, effective upon Governor and Executive Council approval from June 11, 2022 through June 30, 2023. (This position will expire on June 10, 2022).
