REQUESTED ACTION

Authorize the Department of Justice to enter into sub grants totaling \$101,000 with the agencies listed below, from the United States Department of Justice's Office of Juvenile Justice and Delinquency Prevention's FFY 2011 Enforcing Underage Drinking Laws Block Grant Program (EUDL) for increased enforcement of New Hampshire's underage drinking laws from the date of Governor and Executive Council approval through May 31, 2014.
