The Department of Transportation requests placing this item on the Consent Calendar.

Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed rehabilitation or replacement of the bridge carrying US 4 over NHRR- Br. No. 156/104 in the town of Danbury.

Since the Petition is not for the limitation or control of access, a Commission of Three Persons should be appointed by the Governor, with the advice of the Executive Council, to hold a hearing. The Commission of Three shall determine whether there is occasion for the rehabilitation or replacement of the bridge as presented at the hearing.

To His Excellency, the Governor, and the Honorable Executive Council:

I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:14, propose the rehabilitation or replacement of the red list bridge carrying US 4 over NHRR- Br. No. 156/104 and the improvement of the intersection of Spear Hill Road in the Town of Danbury.

DANBURY, A-A001 (230), 16303

This project will rchabilitate or replace the red list bridge carrying US 4 over NHRR – Br. No. 156/104 and improve the intersection of Spear Hill Road. The intersection improvements will improve traffic operations and safety. The US 4 improvements will extend approximately 1400' west and 700' east of the bridge, while the improvements to Spear Hill Road will extend approximately 400' from the US 4 intersection.

Wherefore, I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:14, propose the rehabilitation or replacement of the bridge carrying US 4 over NHRR- Br.
