REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Jessica A. EXPLANATION

In view of Ms. King's performance over the past year, I am requesting her current salary be increased by \$3,000 from \$63,437.50 to \$66,437.50.
