## **REQUESTED ACTION**

1. Authorize the Department of Justice to enter into subgrants with the agencies listed below totaling \$637,500 from the Federal Fiscal Year 2014 Violence Against Women Formula Grant, for the purpose of providing services for women in New Hampshire who are victims of violent crimes, from the period of Governor and Council approval through June 30, 2016. This is 100% Federal Funding.

<sup>\*</sup> The cumulative subgrants to the NH Department of Justice and Coos County are requested for approval because the total exceeds the approved contract level of \$25,000 for this fiscal year.

## **EXPLANATION**

These subgrants above are from the federal formula grants that New Hampshire receives from the US Department of Justice, Office on Violence Against Women (OVW). The Violence Against Women Program is targeted specifically at deterring crimes involving violence against women and aiding the victims of those crimes. A statutory requirement of the VAWA grant program is that agencies representing law enforcement will be allocated at least 25% of the award; prosecution will be allocated at least 25% of the award, with at least 10% of that to be distributed to culturally specific community-based services; and the courts are to be allocated at least 5% of the grant award.

The subgrant recipients have been awarded previous VAWA awards from this office. All have been selected through a competitive bid process and now represent our core service providers for the State of New Hampshire in the area of violence against women related services. As core service providers, these organizations have been selected to maximize the delivery of services throughout the State. These awards will allow the funded organizations to continue providing the vital services that New Hampshire's citizens have come to rely. Should New Hampshire's VAWA funding increase, we will again initiate a competitive bid process in order to increase our available services statewide.

Specific activities being performed through the awarding of these funds include: specially trained domestic violence and sexual assault prosecutors at county attorney offices, victim advocate positions in police departments and in county attorney offices, supervised visitation and exchange center staffing, funding to support staff positions for two DV Units in our largest police departments, a domestic violence officer/investigator at the Franklin Police Department, and continuation of emergency legal services to victims. The award to the NH Coalition Against Domestic and Sexual Violence will provide continued services to victims of domestic and sexual violence. Mandatory funding to the courts will be utilized to continue building judicial support to victims of crime.

The vast majority of the above VAWA funded projects support the retention of staff at these organizations. These projects are funded one hundred percent (100%) by federal dollars.

In the event that Federal Funds become no longer available, General Funds will not be requested to support these programs.
