Re: **PETITION – Deerfield – 24477 X-A002(898)**

The Department of Transportation requests placing this item on the Consent Calendar.

Pursuant to RSA 230:14, attached hereto is a petition for a hearing on the proposed, red-listed culvert on NH 107.

As the project does not involve the limitation or control of access, the Department is requesting a Commission of Three Persons (Commission) be appointed. The Commission shall determine whether there is occasion for the reconstruction of the culvert, pavement, and the underlying structure of the roadway to improve safety.

The Deerfield 24477 Project will address the red-listed culvert on NH 107 over Freeses Pond. The improvements will include replacement of the metal pipe arch culvert with a four-sided precast concrete box culvert. Additional improvements will include new bridge rail, bridge approach rail and guardrail in the location of the culvert. At this time, the project will not affect any identified historical properties immediately adjacent to the project.
