Biographical/Historical note

Meshech Weare is considered to be the first governor of the State of New Hampshire and was known as the "father of the his state". He was born on June 16, 1713, Meshech Weare was the son of Nathaniel Weare and his second wife, Mary Waite. He graduated from Harvard College in 1735. He began his political career in 1739 as town moderator for Hampton Falls. He was a representative of Hampton Falls in the General Assembly. He was also part of the New Hampshire House of Representatives, serving as both speaker and clerk. He was also one of the New Hampshire's delegates that attended the Albany Congress in 1754. In September 1772, Weare served as one of the four judges in the trial of those involved in the Pine Tree Riot, though the participants were found guilty the low fines they received inspired some other rebellious acts against the British government including the Boston Tea Party. Weare was also a leader in drafting the formal constitution that set of New Hampshire to become the first American State on January 5, 1776. Under this constitution, New Hampshire had no individual leader or executive but was run by the legislature. Executive power was appointed to the Committee of Safety, which had the power to act as an executive power when the legislature was not in session. We are was appointed chairman of this Committee from 1776 to 1784 when it was disbanded. He also served in dual roles as the chief justice for the state's highest court the "Superior Court of Judicature" from 1776 to 1782 and as presiding officer of the Governor's Council from 1776-1784, then part of the upper house of the legislature. Upon the adoption of the second New Hampshire Constitution in 1784, Weare was elected as the first governor or at the time "president" of New Hampshire. He ran unopposed and was only able to serve one year before resigning due to poor health. He died only months later on January 14, 1786. He was 73 years old.

Scope and Contents note

The collection does span the 18th century to the early 19th century. The collection makes up approximately 3.5 to 4 linear feet. The materials in the collection are comprised of but not limited to correspondence, military records and reports, judicial papers such as bonds, warrants, testimonies, etc. There are also deeds, bills of sale, surveys, maps, charts, illustrations, and journals. There are also government documents that belong to New Hampshire before and after it became a state of America that are from various committees, boards, and councils. Additionally, there are government documents that came from the national level such as documents from England from King George and documents from the Continental Congress after America declared independence.

Arrangement note

The arrangement of the collection has been rearranged several times since its initial creation and it is unknown what the original order was at this point in time. The current arrangement is that the series are listed in alphabetical order and within the series the materials are arranged chronologically. It is the hope that this arrangement will allow patrons to find documents more easily than past arrangements.
