#### **REQUESTED ACTION**

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300), on the basis of a low bid of \$6,839,152.50 for incremental widening and overlay of I-93 to a four lane facility from Exit 1 in Salem to just north of Exit 3 in Windham, from the date of Governor and Council approval through August 28, 2020, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2020 and Fiscal Year 2021 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$341,957.63 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

#### **EXPLANATION**

This project is part of the State's Ten Year Transportation Improvement Plan. This project involves addressing the I-93 NB and SB mainline construction elements to allow implementation of the full four lane facility from Exit 1 in Salem to just north of Exit 3 in Windham (approximately 6.1 miles along I-93 NB and 4.8 miles along I-93 SB). This work includes pavement widening, drainage, guardrail, pavement markings and signing elements. Additionally, the work includes completing the corridor wide ITS hardwire

infrastructure elements, extending to just north of Exit 5, for an overall project limit of work of approximately 14.4 miles.

These improvements are part of the overall Salem-Manchester I-93 expansion project. This project is the last in a long series of construction projection which completes the 4-lane construction (pavement, markings, and signage) from Exit 1 through Exit 5.

The proposed contingency amount is 5% of the contract amount. This is to account for unanticipated traffic control plan adjustments/modifications, and coordination efforts with the on-going 13933A and 14633D Contracts.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is as follows: <u>Construction Items</u> are 100% Transportation Infrastructure Finance Innovation Act (TIFIA) Credit up to \$2,354,266.03, with the remainder as 80% Federal Aid with 20% Tumpike Toll Credits, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.

### SUPPLEMENTAL PROJECT INFORMATION SHEET

**DESCRIPTION:** This project involves addressing the I-93 NB and SB mainline construction elements to allow implementation of the full four lane facility from Exit 1 in Salem to just north of Exit 3 in Windham (approximately 6.1 miles along I-93 NB and 4.8 miles along I-93 SB). This work includes pavement, drainage, guardrail, pavement markings and signing elements. Additionally, the work includes completing the corridor wide ITS hardwire infrastructure elements, extending to just north of Exit 5, for an overall project limit of work of approximately 14.4 miles.

**FEDERAL FUNDING:** Funding for the <u>Construction Items</u> are 100% Transportation Infrastructure Finance Innovation Act (TIFIA) Credit up to \$209,441.89, with the remainder as 80% Federal Aid (Program: NHS) with 20% Turnpike Toll Credits. <u>Construction Engineering (CE)</u> is 80% Federal Aid (Program: NHS) with 20% Turnpike Toll Credits. Debt Service is State funded with SB 367 revenue.

**CONTINGENCY:** The contingency amount is proposed to be 5% of the contract amount. This is necessary to account for unanticipated TCP adjustments/modifications, and coordination efforts with the on-going 13933A and 14633D Contracts.


PROJECT INITIATED: State's 10-Year Transportation Improvement Plan.

**PROJECT EXPLANATION:** These improvements are part of the overall Salem-Manchester I-93 expansion project. This project completes the 4-lane construction (pavement, markings, and signage) from Exit 1 through Exit 5.

**TRAFFIC IMPLICATIONS:** The fourth lane implementation work will be prosecuted from the existing median side shoulder reducing the shoulder width to 4 feet as required, utilizing traffic control barrier as specified in the Plans. Existing travel lanes on I-93 (NB and SB) will be maintained at all times (except as follows). Lane closures will be allowed on I-93 for certain construction activities, utilizing Uniformed Officers with Vehicles, as approved, and as specified in the TCP. Smart Work Zones are in place along the corridor, including the proposed work area for this project (under the Salem-Manchester 14633Z contract).
