REQUESTED ACTION

Authorize the Department of Justice to enter into a new subgrant, with the New Hampshire Department of Safety State Police (Vendor #177878) in the amount of \$90,000, from the FFY 2012 Byrne Justice Assistance Grant Program, to support ongoing efforts to halt illegal drug activities in the State of New Hampshire from the date of Governor and Executive Council approval to June 30, 2017. 100% Federal Funds.
