Application for Registration of Trade Name (RSA 349)

New Hampshire law requires that anyone doing business under any name other than his or her own must register that name with the Secretary of State. The fee for registration is \$50.00, payable to the State of New Hampshire.

Filling out the trade name application requires the following:

1. Exact trade name being registered.
2. Complete address of the business. If the mailing address for the business is different from the listed business address, please insert the complete mailing address on the line provided.
3. Brief description of type of business (e.g. real estate, hairdresser, etc.)
4. Date business was organized, cannot be a future date.
- 5-A & B. Applicants: may be an individual, corporation, limited liability company, limited liability partnership, group of partners, proprietorship or association.
Original signatures of all applicants: if a corporation, of an authorized officer; if a limited liability company, by the manager or if no manager, by a member; if a limited liability partnership, by one or more authorized partners.

PLEASE NOTE: The name will be searched for availability upon receipt of these documents. If the filing has been accepted, you will receive a filed-stamped copy within 30 days. If you do not receive an acknowledgement, please contact our office. Checks are deposited upon receipt. If the check has been cashed, it only indicates we have received the document.
