#### **EXPLANATION**

The Risk Management Unit budget in FY2019 includes amounts to pay for certain statewide insurance premiums. The annual insurance premiums are due in full upon the policy renewal date. The annual premium for the statewide State Employee Faithful Performance Bond policy is due in July and the annual premium for the statewide Cyber Security policy is due in August. Due to the timing of the annual policy renewals and premium due dates, the CR does not provide sufficient funding to make the total premium payments. If the Risk Management Unit cannot make the total premium payments on time, it will result in additional interest fees of 5-6% (up to approx. \$5,000) and could require additional contracting with the State's broker to allow for interest payments. Ultimately, failure to pay the full premium upon renewal for either policy will result in a cancelation of the policy.

1. Is the action required of this request a result of the Continuing Resolution for FY 2020?

This request is a result of the continuing resolution.

2. If this request is retroactive what is the significance and importance of the action being effective from an earlier date?

The request is not retroactive.

3. Is this a previously funded and ongoing program established through Fiscal Committee and Governor and Executive Council action? (If so, include as an attachment the original documents as approved and cite the specific dates of authorization and end dates for each action as part of your answer to this question.)

The State Employee Faithful Performance Bond is required by RSA 93-B. This Bond protects the State's property interests up to specified policy limits. If an employee steals or inadvertently loses state property, the State can file a claim to recover stolen/lost amounts. The Risk Management Unit budgeted for this Bond in accounting unit 2901 in the budget submitted for FY20/21.

The Cyber Security Insurance policy was first included in the State's FY18/19 budget. This policy limits the State's exposure to financial loss from a breach in our data security. The Risk Management Unit budgeted for the policy in the budget submitted for FY20/21. The policy in place today expires August 23, 2019 and the renewal policy must be paid in full in August. On August 8, 2018 the current Cyber Security Insurance contract, Item #63, was approved by G&C and is effective from August 23, 2018 – August 23, 2019. Risk Management Unit anticipates the August 23, 2019 – August 23, 2020 Cyber Security Insurance contract to be on the August 14, 2019 G&C agenda.

4. Was funding for this program included in the FY 2018-2019 enacted Budget or requested and denied?

Yes', funding for these insurance policies was included in the FY2018 - 2019 Budget.

Yes, funding for these insurance policies is included in total in the FY 2020-2021 Operating Budget proposal.

7. What would be the effect should this program be discontinued or not initiated as a result of this request being denied?

#### State Employee Faithful Performance Bond

If this bond is not renewed the State will lose coverage for and indemnification from losses up to \$200,000 arising from employee dishonesty or the failure of any employee to faithfully perform his or her duties as prescribed by law.

#### Cyber Security Insurance

If this policy is not renewed the State will lose \$10,000,000 worth of coverage for cyber privacy/media liability, incident (breach) response, network extortion, digital data recovery, business interruption costs, terrorism, and prior cyber security-related acts. The incident response coverage that would be lost includes forensics, notification response requirements, call centers, identity protection, and crisis management. Loss of prior acts coverage would expose the State to claims for unknown data breaches that occurred prior to inception of the policy.

#### **EXPLANATION**

The procurement of Data Security and Privacy Cyber Liability insurance for state government was included in the FY18/19 budget and is part of a strategic risk management plan to limit the State's exposure to financial loss from a breach in our data security. The Department of Information and Technology and Department of Administrative Services worked together to complete the application process and develop coverage specifications. This contract provides coverage to state government including the executive branch, legislative branch, judicial branch, State Treasury, and Secretary of State. Leadership from those entities were consulted during the application process.

USI Insurance Services (USI) arranged for this purchase in accordance with its contract with the State for *Producer Services*, approved by the Governor and Executive Council on May 16, 2018 (item #73). USI made inquiries to seven insurance markets about the program. Three markets responded with offers to provide coverage in compliance with specifications: Chubb ACE American Insurance Company thru Worldwide Facilities (wholesale market), Worldwide Facilities (retail market), and AIG.

Notice: This agreement and all of its attachments shall become public upon submission to Governor and Executive Council for approval. Any information that is private, confidential or proprietary must be clearly identified to the agency and agreed to in writing prior to signing the contract.

# Data Security and Privacy Cyber Liability Insurance Coverage for State Government Contract Agreement Between The Department of Administrative Services and USI Insurance Services, LLC

#### Exhibit A - Scope of Services

#### ARTICLE 1. SCOPE OF SERVICES

This EXHIBIT A, Scope of Services, is made a part of the P-37 Agreement (the "Agreement") and is made according to the terms of paragraph 2 of the Form P-37. This EXHIBIT A to the Agreement is between the State of New Hampshire ("State") and USI Insurance Services, LLC ("USI"). USI, hereinafter called the Contractor, agrees to provide Data Security and Privacy Cyber Liability insurance coverage for the State of New Hampshire to include the executive branch, legislative branch, judicial branch, state treasury, and secretary of state.

#### ARTICLE 2. EFFECTIVE DATE

Effective Date of Agreement: August 23, 2018 Expiration Date of Agreement: August 23, 2019

12:01AM Standard Time at the address of the State stated herein.

#### **ARTICLE 3.** INSURANCE COVERAGE DETAILS

The coverage consists of Data Security and Privacy Cyber Liability insurance coverage with an aggregate limit of \$10,000,000 and \$300,000 deductible for (1) Privacy Liability (including regulatory defense and penalty coverage Payment Card Industry [PCI] fines and penalty coverage); (2) Media Liability; (3) Incident Response (breach) Costs (notifications, call centers, identity protection, crisis management, public relations costs, and forensics); (4) Network Extortion; (5) Digital Data Recovery costs; (6) Business Interruption losses including extra expenses; (7) Terrorism coverage; and (8) Full Prior Acts coverage.

#### ARTICLE 4. ACCOUNT MANAGEMENT

USI shall manage this policy in accordance with the terms and conditions of the Producer Services and Safe Driving Program Administration, effective July 1, 2018.

#### Exhibit C - Special Provisions

- 2. Automobile Insurance coverage with combined single limits of \$1,000,000 per accident


