REQUESTED ACTION

Pursuant to RSA 14:30-a, VI, authorize the New Hampshire Department of Transportation (NHDOT) to accept and expend Federal revenue in the amount of \$485,194.00 from the Federal Highway Administration (FHWA) for the purpose of funding budgeted positions that support Federal programs within NHDOT. Effective upon the date of Fiscal Committee and Governor and Council approval through June 30, 2021. 100% Federal Funds.

In SFY 2021, funds shall be accepted and expended within 04-096-096-960315-2056 – Office of Federal Compliance, as follows:

EXPLANATION

The Department requests authorization to accept and expend \$485,194.00 from FHWA for the purpose of supplanting Highway Funds with Federal Funds to provide Federal compliance activities required by various Federal transportation agencies.

The New Hampshire Department of Transportation is a recipient of approximately \$204 Million in federal financial assistance from the FHWA, Federal Aviation Administration (FAA), and Federal Transit Administration (FTA). These funds serve as the primary funding sources for New Hampshire's Highway and Bridge Construction Programs, capital, operating and planning activities for transit programs and projects, and for planning, preservation, modernization and expansion of eligible airport facilities.

As a condition of receiving Federal financial assistance, all recipients are required to sign assurances of non-discrimination in all program areas. 23 CFR 200.9(b)(1) requires each recipient to establish a "civil rights unit" to enforce compliance with non-discrimination in all program activities. The CFR further requires that each civil rights unit be "adequately staffed" to effectively implement the department's responsibilities. At NHDOT, the Office of Federal Compliance, in the Commissioner's Office is established to comply with this provision.

No new positions are being requested and this action is to correct the funding source of these positions that were not funded correctly during the budget process. All positions are funded in the current budget with Highway Funds and the Department is requesting all positions and incidentals to support the Contractor Compliance program, Americans with Disabilities (ADA) program, Equal Employment Opportunity (EEO) program and the Disadvantaged Business (DBE) program at NHDOT, be funded with Federal funds (see attached organizational chart). This will ensure the Department meets compliance and audit standards for its Federal programs.


