Requested Action

Authorize the Community Development Finance Authority (CDFA), under the Community Development Block Grant (CDBG) program, to award a grant to the County of Grafton, 3855 Dartmouth College Highway, Box, 1, North Haverhill, New Hampshire, in the amount of \$500,000 for the purpose of assisting four organizations provide microenterprise training and technical assistance, direct grants and down payment assistance, and lending capital to micro businesses, upon Governor and Council approval for the period effective July 27, 2022 through June 30, 2023. 100% federal funds.

Explanation

The County of Grafton is requesting CDBG funds to assist with training and technical assistance, direct grants and down payment assistance, and lending capital to small microenterprise businesses. If approved, the funds will be subgranted to four organizations; Belknap Economic Development Council (BEDC) located in Laconia; Grafton Regional Development Corporation (GRDC) located in Haverhill; Northern Community Investment Corporation (NCIC) located in Lancaster; and the Women's Rural Entrepreneurial Network (WREN) located in Bethlehem. Microenterprise training and technical assistance funds will be used to increase the income and economic stability of self-employed people and microenterprise businesses by helping them access capital, provide business training and expanding market opportunities in Belknap, Carroll, Cheshire, Coos and Grafton counties. A minimum of one hundred eight (108) microenterprise businesses will be assisted collectively, and 100% of microenterprises served will be of low- and moderate-income.

This Agreement allocates a portion of the Community Development Block Grant (CDBG) funds provided to New Hampshire by the U. S. Department of Housing and Urban Development (HUD). CDFA is administering this program as provided by RSA 162-L. The funds for this contract are from the Community Development Block Grant Fund, which is intended to help municipalities solve development problems.

2. SCOPE OF WORK: In exchange for grant funds provided by the State of New Hampshire, acting through the Agency identified in block 1.1 (hereinafter referred to as "the State"), the Grantee identified in block 1.3 (hereinafter referred to as "the Grantee"), shall perform that work identified and more particularly described in the scope of work attached hereto as EXHIBIT B (the scope of work being hereinafter referred to as "the Project").

- AREA COVERED, Except as otherwise specifically provided for herein, the 3. Grantee shall perform the Project in, and with respect to, the State of New Hamoshira.
- BFFECTIVE DATE: COMPLETION OF PROJECT.
- 4.1. This Agreement, and all obligations of the parties hereunder, shall become effective on the date on the date of approval of this Agreement by the Governor and Council of the State of New Hampshire if required (block 1.16), or upon 9.3. signature by the State Agency as shown in block 1.14 ("the Effective Date").
- 4.2. Except as otherwise specifically provided herein, the Project, including all reports 9.4. required by this Agreement, shall be completed in ITS entirety prior to the date in block 1.7 (hereinafter referred to as "the Completion Date").
- GRANT AMOUNT: LIMITATION ON AMOUNT: YOUCHERS: PAYMENT.
- 5.1. The Grant Amount is Identified and more particularly described in EXHIBIT C, attached bereto.
- The manner of, and schedule of payment shall be as set forth in EXHIBIT C.
- 5.3. In accordance with the provisions set forth in EXHIBIT C, and in consideration 10. of the satisfactory performance of the Project, as determined by the State, and as limited by subperagraph 5.5 of these general provisions, the State shall pay the Grantee the Grant Amount. The State shall withhold from the amount otherwise payable to the Grance under this subparagraph 5.3 those sums required, or permitted, to be withheld pursuant to N.H. RSA 80.7 through 7-o.

 5.4. The payment by the State of the Grant amount shall be the only, and the complete
- payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee in the performance hereof, and shall be the only, and the complete, compensation to the Grantee for the Project. The State shall have no liabilities to 11. the Grantee other than the Grant Amount.
- 5.5. Notwithstanding anything in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, 11.1.1 Pailure to perform the Project satisfactorily or on schedule; or or actually made, hereunder exceed the Grant limitation set forth in block 1.8 of 11.1.2 Patture to submit any report required hereunder; or these searcal provisions.
- COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS. In 11.1.4 connection with the performance of the Project, the Grantes shall comply with all 11.2. statutes, laws regulations, and orders of federal, state, county, or municipal authorities which shall impose any obligations or duty upon the Grantee, including 11.2.1 the acquisition of any and all necessary permits and RSA 31-95-b.
- RECORDS and ACCOUNTS.
- 7.1. Between the Effective Date and the date seven (7) years after the Completion Date, unless otherwise required by the grant terms or the Agency, the Grantee shall keep detailed accounts of all expenses incurred in connection with the 11.2.2 Project, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and elerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.
- 7.2. Between the Effective Date and the date seven (7) years after the Completion Date, unless otherwise required by the grant terms or the Agency pursuant to 11.2.3 subparagraph 7.1, at any time during the Grantee's normal business hours, and as often as the State shall demand, the Grantee shall make available to the State all 11.2.4 records pertaining to matters covered by this Agreement. - 8.1. PERSONNEL
 - The Grantee shall, at its own expense, provide all personnel necessary to perform 12.2. the Project. The Grantee warrants that all personnel engaged in the Project shall be qualified to perform such Project, and shall be properly licensed and authorized to perform such Project under all applicable laws.
- The Grantee shall not hire, and it shall not permit any subcontractor, subgrantee, 12.3. or other person, firm or corporation with whom it is engaged in a combined effort to perform the Project, to hire any person who has a contractual relationship with
- the State, or who is a State officer or employee, elected or appointed. The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant 12.4. Officer, and his/her decision on any dispute, shall be final.
- 9.1. DATA: RETENTION OF DATA: ACCESS.
 - As used in this Agreement, the word "data" shall mean all information and things 13. developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations,

- computer programs, computer printouts, notes, letters, memoranda, paper, and documents, all whether finished or unfinished.
- Between the Effective Date and the Completion Date the Grantee shall grant to the State, or any person designated by it, imrestricted access to all data for examination, duplication, publication, translation, sale, disposal, or for any other purpose whatsoever.
- No data shall be subject to copyright in the United States or any other country by anyone other than the State.
- On and after the Effective Date all data, and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason, whichever shall first occur.
- The State, and anyone it shall designate, shall have unrestricted authority to publish, disclose, distribute and otherwise use, in whole or in part, all data.
- CONDITIONAL NATURE OR AGREEMENT. Notwithstanding anything in this Agreement to the contrary, all obligations of the State bereunder, including. without limitation, the continuence of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the State be liable for any payments herounder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.
- EVENT OF DEFAULT: REMEDIES.
- 11.1. Any one or more of the following acts or omissions of the Grantee shall constitute an event of default hereunder (hereinafter referred to as "Events of Default"):

- Feilure to maintain, or permit access to, the records required hereunder; or 11.1.3
- Pailure to perform any of the other covenants and conditions of this Agreement.
- Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:
- Give the Grantee a written notice specifying the Event of Default and requiring it to be remedled within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Grantee notice of termination; and
- Give the Grantee a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the Orant Amount which would otherwise accrue to the Grantee during the period from the date of such notice until such time as the State determines that the Grantee has cured the Event of Default shall never be paid to the Grantee; and
- Set off against any other obligation the State may owe to the Grantee any damages the State suffers by reason of any Event of Default; and
- Treat the agreement as breached and pursue any of its remedies at law or in equity, or both.
- TERMINATION.
- In the event of any early termination of this Agreement the any reason other than the completion of the Project, the Grantee shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Project Work performed, and the Grant Amount earned, to and including the date of termination. In the event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall entitle the Grantee to receive that portion of the Grant amount carned to and including the date of termination.
- In the event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall in no event relieve the Grantee from any and all liability for damages sustained or incurred by the State as a result of the Grantee's breach of its obligations herennder.
 - Notwithstanding anything in this Agreement to the contrary, either the State or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice. CONFLICT OF INTEREST. No officer, member of employee of the Grantee, and no representative, officer or employee of the State of New Hampshire or of the governing body of the locality or localities in which the Project is to be performed, who exercises any functions or responsibilities in the review or

- approval of the undertaking or carrying out of such Project, shall participate in 17.2. any decision relating to this Agreement which affects his or her personal interest or the interest of any corporation, partnership, or association in which he or the is directly or indirectly interested, nor shall he or she have any personal or pecuniary interest, direct or indirect, in this Agreement or the proceeds thereof.
- 14. GRANTER'S RELATION TO THE STATE. In the performance of this Agreement the Grantee, its employees, and any subcontractor or subgrantee of 18. the Grantee are in all respects independent contractors, and are neither agents nor employees of the State. Neither the Grantee nor any of its officers, employees, agents, toembers, subcontractors or subgrantees, shall have authority to bind the State nor are they entitled to any of the benefits, workmen's compensation or employees.
- 15. ASSIGNMENT AND SUBCONTRACTS. The Grantes shall not assign, or 19, otherwise transfer any interest in this Agreement without the prior written consent of the State. None of the Project Work shall be subcontracted or subgranted by the Grantee other than as set forth in Exhibit B without the prior written consent of the State.
- 16. <u>INDEMNIFICATION</u>. The Grantee shall defend, indemnify and hold harmless the State, its officers and employees, from and against any and all leasns suffered by the State, its officers and employees, and any and all claims, liabilities or penalties asserted against the State, its officers and employees, by or on bohalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or emissions of the Grantee or subcommetor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant shall survive the termination of this agreement.
- INSURANCE.
- 17.1 The Grantee shall, at its own expense, obtain and maintain in force, or shall 23. require any subcontractor, subgrantee or assignee performing Project work to obtain and maintain in force, both for the benefit of the State, the following insurance:
- 17.1.1 Statutory workers' compensation and employees liability insurance for all 24, employees engaged in the performance of the Project, and .
- 17.1.2 Ocnoral liability insurance against all claims of bodily injuries, death or property damage, in amounts not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for bodily injury or death any one incident, and \$500,000 for property damage in any one incident; and

- 17.2. The policies described in subparagraph 17.1 of this paragraph shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. Grantee shall furnish to the State, certificates of insurance for all renewal(s) of insurance required under this Agreement no later than ten (10) days prior to the expiration date of each insurance policy.
 - WAIVER OF BREACH. No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event, or any subsequent Event. No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee.
- 19. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duty delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses first above given.
- AMENDMENT. This Agreement may be amended, waived or discharged only
 by an instrument in writing signed by the parties herero and only after approval of
 such amendment, waiver or discharge by the Governor and Council of the State
 of Now Hampshire, if required or by the signing State Agency.
- 21. CONSTRUCTION OF AGREEMENT AND TERMS. This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions and contents of the "subject" blank are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intend of the parties hereto.
- THIRD PARTIES. The parties hereto do not inread to benefit any third parties
 and this Agreement shall not be construed to confer any such benefit.
 - ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.
 - SPECIAL PROVISIONS. The additional or modifying provisions set forth in Exhibit A hereto are incorporated as part of this agreement.

GRANT ACTIVITIES

PROJECT DESCRIPTION AND PURPOSE.

1.1 This project shall consist of the awarding of \$500,000 in Community Development Block Grant (CDBG) funds to the County of Grafton ("Grantee"), of which a total of \$452,700 is to be sub-granted as follows: Beiknap County Economic Development Council (BEDC) - \$182,200, Grafton Regional Development Corporation (GRDC) - \$120,000, Northern Community Investment Corporation (NCIC) - \$72,500 and Women's Rural Entrepreneurial Network (WREN) - \$78,000 (collectively referred to as "Subrecipient") for Microenterprise Development Assistance Grants. Sub-granted funds will be used by the Subrecipient to provide technical assistance and training services, direct grants, down payment assistance and micro-loans through the Subrecipients' and partner organizations' microenterprise programs, to a minimum of 108 microenterprises throughout the State of which 100% will be of low- and moderate-income. Sub-granted funds shall be set forth in each of the organization's Subrecipient Agreements attached hereto.

The microenterprise program mission is to increase the income and economic stability of self-employed people and microenterprises, by helping them to access capital, business training and expanded market opportunities. These funds will support technical assistance and training services; direct grants; down payment assistance and/or micro-loans to qualifying low- and moderate-income business owners. Non-CDBG fund loans may be made to credit-worthy participating businesses by the Subrecipients and/or partner organizations.

The specific reporting requirements, performance measures and goals for this grant are outlined in Attachments II-A, II-B, II-C and II-D Subrecipient Agreements.

1.2 Consistent with the National Objectives of the Community Development Block Grant Program under Title I of the Housing and Community Development Act of 1974, as amended, the Parties agree that the Subrecipients will collectively serve at least 108 microenterprise beneficiaries of which 100% will be of low-and moderate-income, as that term is defined in 24 CFR 570.483 and CDFA's Implementation Guida.

2. GRANT ADMINISTRATION.

- 2.1 Grantee shall perform all activities as necessary to administer the CDBG funds in accordance with the provisions of this Agreement, and particularly the state and federal requirements referenced in Section 3.
- 2.2 Grantee has agreed to an Implementation Schedule, which will provide for the completion of all grant activities, prior to the Grant Completion Date. All training and technical assistance shall be completed prior to the Grant Completion Date as stated in Section 1.7 of the General Provisions.
- 2.3 Grantee shall be permitted to request up to \$47,300 of CDBG funds for reimbursement of administrative Project Costs. In no event shall administrative costs reimbursable with Grant funds exceed fifteen percent (15%) of the total Grant Funds. Administrative costs shall be limited to the allowable costs as specified in OMB 2 CFR Part 200, as the same may be amended from time to time. Such costs include but are not limited to: preparation of environmental review, recordkeeping, reporting, audits and oversight of Project construction and compliance with all federal, state and local laws, rules and regulations.
- 2.4 Grantee shall enforce the terms and conditions of its Subrecipient Agreements, as provided herein. Grantee shall promptly notify Subrecipient in writing in the event of a default under the Subrecipient Agreements and shall aggressively pursue its remedies under said agreement for the benefit of the State.

- 2.5 Grantee shall send, at a minimum, its grant administrator, or a designated representative employee involved in the administration of this Grant, to the next CDBG Grant Administration Workshop to be offered by the Community Development Finance Authority.
- 2.6 Grantee shall submit to the CDFA all required reports as specified in this Agreement and shall monitor and enforce the reporting requirements of the Subrecipient Agreements as provided in this agreement or any Exhibits or attachments hereto.
- 2.7 Grantee or Grantee's consultant shall provide such training as is necessary to the Subrecipients to secure satisfactory performance of its duties and responsibilities under the Subrecipient Agreements.
- 2.8 Grantee shall enter into Closeout Agreements with the Subreciplents and CDFA, as required by CDFA.
- 2.9 Any construction undertaken in connection with the Project shall comply with all applicable state and local design, construction, building and safety codes.

3. FEDERAL COMPLIANCE

- 3.1 Grantee shall comply, and shall require any Subrecipient, contractor and subcontractor to comply, with the following federal and state laws and all applicable standards, rules, orders, or regulations issued pursuant thereto:
 - 3.1.1 <u>The Copeland "Anti-Kickback" Act</u>, as amended (118 USC 874) as supplemented in Department of Labor regulations (41 CFR Chapter 60).
 - 3.1.2 <u>Nondiscrimination</u>, Title VI of the Civil Rights Act of 1974 (PL 88- 352), as amended, (42 USC 2000d) the Fair Housing Act of 1968 (PL 90-284), Executive Orders 11063 and 12259, and the requirements imposed by the Regulations of the Department of Housing and Urban Development (24 CFR 107 and 24 CFR 570.496) issued pursuant to that Title.
 - 3.1.3 <u>Labor Standards</u>. Davis-Bacon Act, as amended (40 USC 276a-276a-7), the Contract Work Hours and Safety Standards Act (40 USC 327-333).
 - 3.1.4 <u>The Flood Disaster Protection Act of 1973</u> (PL 93-234), as amended, regulations issued pursuant to that act, and Executive Order 11985.
 - 3.1.5 <u>Architectural Barriers Act</u> (PL 90-480), 42 USC 4151, as amended, and the regulations issued or to be issued thereunder, including uniform accessibility standards (24 CFR 40) for public buildings with 15 or more residential units. RSA 275-C:10 and the New Hampshire Architectural Barrier Free Design Code (Han 100, et. seq.) also applies.
 - 3.1.6 Rehabilitation Act of 1973, 29 USC 794, Sections 503 and 504, Executive Order 11914 and U.S. Department of Labor regulations issued pursuant thereto.
 - 3.1.7 The Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (PL 91-646), as amended, 15 CFR Part 916 including amendments thereto and regulations thereunder.
 - 3.1.8 The National Environmental Policy Act of 1989 (PL 99-190): the National Historic Preservation Act of 1986 (80 Stat 915, 116 USC 470); and Executive Order No. 11593 of May 31, 1971, as specified in 24 CFR 58.



- 3.1.9 The Clean Air Act, as Amended, 42 USC 1857 et seq., the Federal Water Pollution Control Act, as amended, 33 USC 1251 et seq. and the regulations of the Environmental Protection Agency with respect thereto, at 40 CFR Part 15, as emended from time to time.
- 3.1.10 RSA 354 and rules of the New Hampshire Human Rights Commission (HUM 100, et, seq.) on discrimination in employment, membership, accommodations, and housing.

- 3.1.18 Affirmative Action Requirements. In furtherance of its covenant Grantee shall:
 - (1) take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, creed, age, sex, or national origin; such action shall be taken in conjunction with any of the Grantee's acts in the capacity of an employer including, but not limited to: employment of individuals, upgrading, demotions or transfers, recruitment or recruitment advertising; layoffs or terminations; changes in rates of pay or other forms of compensation; selection for training, including apprenticeship, and participation in recreational and educational activities;
 - (2) post in conspicuous places available to employees and applicants, employment notices, to be provided by CDFA, setting forth the provisions of this non-discrimination clause; the Grantee will, in all solicitations or advertisements for employees, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, creed, age, sex or national origin;
 - (3) keep all such information, records and reports as may be required by the rules, regulations or orders of the Secretary of Labor and furnish or submit the same at such times as may be required; the Grantee shall also permit CDFA, or the Secretary of Labor or any of their designated representatives to have access to any of the Grantee's books, records and accounts for the purpose of investigation to ascertain compliance with the aforesaid rules, regulations and orders and covenants and conditions herein contained;
 - (4) during the term of this agreement, shall not discriminate among participants under this agreement on the basis of race, color, religion, sex, handicap or national origin. For the purpose of this agreement, distinctions on the grounds of the following: denying a participant any service or benefit or availability of a facility; providing any service or benefit to a participant which is different, or is provided in a different manner or at a different time from that provided to other participants under this agreement; subjecting a participant to segregation or separate treatment in any matter related to his receipt of any service; restricting a participant in any way in the enjoyment of any advantage or privilege enjoyed by others receiving any service or benefit; treating a participant differently from others in



determining whether he satisfies any admission, enrollment quota, eligibility, membership, or other requirement or condition which individuals must meet in order to be provided any service or benefit; the assignment of times or places for the provision of services on the basis of race, color, religion, sex, or national origin of the participants to be served.

- 3.1.17 Section 3 of the Housing and Urban Development Act of 1968 (12 USC 1701u) as amended by the Housing and Community Development Act of 1974 (42 USC 5301). The contractor will ensure that to the greatest extent feasible, opportunities for training and employment arising in connection with this CDBG-assisted project will be extended to lower-income project area residents. Further, the contractor will, to the greatest extent feasible, utilize business concerns located in or substantially owned by residents of the project area, in the award of contracts and purchase of service and supplies.
- 3.1.18 <u>Drug-Free Workplace Act of 1988</u> (42 USC. 701). In carrying out this agreement, the contractor agrees to comply with the requirements of the Drug-Free Workplace Act of 1998 (42 U.S.C. 701) and to certify that contractor will comply with drug-free workplace requirements in accordance with the Act and with HUD rules found at 24 CFR part 24, subpart F.
- 3.1.19 Federal Funding Accountability and Transparency Act (FFATA). Reg. 55671 (Sept. 14, 2010)(to be codified at 2 CFR part 25) and Appendix A to Part 170 of the Requirements for Federal Funding Accountability and Transparency Act Implementation, 75 Fed. Reg. 55663 (Sept. 14, 2010)(to be codified at 2 CFR part 170). For additional information on FFATA reporting and the FSRS system, please visit the www.fsrs.gov website, which includes FFATA legislation, FAQs and OMB guidence on subaward and executive compensation reporting.
- 3.1.20 <u>Women- and Minority-Owned Businesses (W/MBE)</u>. As applicable to this grant, Grantee and Subreciplent will use its best efforts to afford small businesses, minority business enterprises, and women's business enterprises the maximum practicable opportunity to participate in the performance of this contract. As used in this contract, the terms "small business" means a business that meets the criteria set forth in section 3(a) of the Small Business Act, as amended (15 U.S.C. 632), and "minority and women's business enterprise" means a business at least fifty-one (51) percent owned and controlled by minority group members or women. For the purpose of this definition, "minority group members" are Afro-Americans, Spanish-speaking, Spanish surnamed or Spanish-heritage Americans, Asian-Americans, and American Indians. The Subrecipient may rely on written representations by businesses regarding their status as minority and female business enterprises in lieu of an independent investigation.

4. SUBRECIPIENT AGREEMENTS.

- 4.1 Grantee shall enter Into a Subrecipient Agreement with the four Subrecipients in a form satisfactory to CDFA and meeting the requirements of Attachments II-A, II-B, II-C and II-D Subrecipient Agreement, Minimum Terms and Conditions, attached hereto and incorporated herein by reference.
- 4.2 The Subrecipient Agreements shall provide for the sub-granting of \$452,700 in CDBG funds for the purposes described herein and consistent with the terms and conditions of this Agreement.

- 4.3 Grantee shall provide to CDFA for its review and approval the proposed Subrecipient Agreements prior to execution. Prior to the disbursement of grant funds, but not more than thirty (30) days following the Effective Date of this Agreement, Grantee shall provide to CDFA executed copies of said Subrecipient Agreements.
- 4.4 Grantee shall cause the applicable provisions of this Exhibit to be inserted in all Subreciplent agreements, contracts and subcontracts for any work or Project Activities covered by this Agreement so that the provisions will be binding on each Subreciplent, contractor and subcontractor; provided, however, that the foregoing provisions shall not apply to contracts for standard commercial supplies or raw materials. Grantee shall take such action with respect to any Subrecipient agreement, contract or subcontract as the State, or, where applicable, the United States, may direct as a means of enforcing such provisions, including sanctions for noncompliance.

5. PROJECT MATCHING FUNDS; ADDITIONAL FINANCING.

- 5.1 The Parties agree that no other funds are required to match the CDBG funds to be awarded for the TA/Training, Direct Grants, Down Payment Assistance Grants, Program Activity Costs and CDBG Grant Administration, pursuant to this Agreement and in connection with this Grant Project.
- 5.2 The Parties agree that CDBG funds to be used as lending capital for micro-loans to qualifying microenterprises enrolled in a Subrecipient's TA/Training programs must be matched on a 1:1 basis with other funds provided by CDFA.

6. SECURITY REQUIREMENTS.

Not Applicable to this Award.

ADDITIONAL GRANT REQUIREMENTS.

- 7.1 Grantee shall prepare and adopt a written Code of Ethics governing the performance of its employees engaged in the procurement of supplies, equipment, construction and services consistent with the requirements of 24 CFR 85.36(b)(3). The Code of Ethics shall be prepared in the form shown in the CDBG Implementation Guide and shall be formally adopted prior to requesting Grant funds. The Grantee shall also comply with the conflict-of-interest policy consistent with the requirements of 24 CFR 570.489(h) and approved by CDFA.
- 7.2 Grantee shall prepare and adopt a financial management plan, approved by CDFA, which describes Grantee's system for receiving and expending the grant funds including the internal controls, which shall ensure compliance with Section 8 of this agreement. The plan shall be formally adopted prior to requesting Grant funds.
- 7.3 Grantee shall submit to CDFA, documentation of training and technical assistance given and expenditures incurred by the Subrecipients any time on or after July 1, 2022. Reports shall be provided as set forth in Attachments II-A, II-B, II-C and II-D, Subrecipient Agreements. All reporting, including additional documentation and reporting requirements from said Subrecipient Agreements, shall be submitted via CDFA's Grants Management System (GMS).
- 7.4 In the event Grantee fails to enforce the provisions of the Subrecipient Agreements or fails to cure any event of default under the Subrecipient Agreements, Grantee shall, upon demand by CDFA, assign and convey all or part of its rights, title and interest, or delegate all or any of its obligations under the Subrecipient Agreements to CDFA.

Such assignment or delegation is to be effective only in the event of default in the Subreciplent's obligations to Grantee, under the terms and conditions of the Subreciplent Agreements.

- 7.5 CDFA shall have the right to terminate all or part of its obligations under this Agreement in the event that any official, employee, architect, engineer, attorney or inspector of, or for Grantee, or any government official or representative becomes directly or indirectly interested financially in the acquisition of any materials or equipment, or in any construction of the Project, or in the furnishing of any service to, or in connection with the Project, or any benefit arising therefrom.
- 7.6 Where the Grant Agreement is terminated or the Project is otherwise terminated due to a default, inability to perform or reason other than project completion and Grant funds are to be returned by Grantee, the disposition of Grant Funds to be returned shall be determined solely by CDFA.
- 7.7 Excessive Force by Law Enforcement Agencies.  - 7.8.2 If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard form LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.
 - 7.8.3 The undersigned shall require that the language of this certification be included in the award documents for all subawards at all tiers (including subcontracts, subgrants, and contracts under grants, loans, and cooperative agreements) and that all Subrecipients shall certify and disclose accordingly.
- 7.9 Certification of Non-segregated Facilities as required by the May 9, 1967, Order (32 FR 7439, May 19, 1967) on Elimination of Segregated Facilities, by the Secretary of Labor. 7.12 In the event Grantee fails to enforce the provisions of the Subrecipient Agreements or fails to cure an Event of a Default under the Subrecipient Agreements, Grantee shall, upon demand by CDFA, assign and convey all or any part of its rights, title and interest or delegate all or any of its obligations under the Subrecipient Agreements to CDFA, such assignment or delegation to be effective only in the event of a default in Subrecipient's obligation to Grantee under the terms of the Subrecipient Agreements In such event, Grantee agrees to pay and shall pay all reasonable costs and expenses incurred by CDFA in the enforcement of the Subrecipient obligations or in curing any Event of Default thereunder.

8. GRANTEE FINANCIAL MANAGEMENT SYSTEM.

- 8.1 Except where inconsistent with federal requirements, state procedures and practices will apply to funds disbursed by CDFA, and local procedures and practices will apply to funds disbursed by units of local government.
- 8.2 Cash Advances: Cash advances to Grantee shall be approved only to the extent necessary to satisfy the actual, immediate cash requirements of Grantee in carrying out the purpose of the approved program or project. The timing and amount of cash advances shall be as close as is administratively feasible to the actual disbursements by Grantee for direct program costs and the proportionate share of any allowable indirect costs. Cash advances made by Grantee to Subrecipient shall conform to the same standards of timing and amount as apply to advances to Grantee including the furnishing of reports of cash disbursements and balances.
- 8.3 Fiscal Control: Grantee must establish fiscal control and fund accounting procedures which assure proper disbursement of, and accounting for, grant funds and any required non-federal expenditures. This responsibility applies to funds disbursed by Subrecipient and contractors as well as to funds disbursed in direct operations of Grantee. Grantee shall be required to maintain a financial management system which complies with 24 CFR 85.20 or such equivalent system as CDFA may require. 10. REPORTS AND CLOSE OUT

- 10.1 Periodic progress reports which identify the status of Grant Activities performed, the outlook for completion of the remaining Grant Activities prior to the Completion Date, and the changes, if any which need to be made in the Project or Grant Activities, shall be submitted with each claim and by the 15th of the month in January and July via CDFA's Grants Management System (GMS).
- 10.2 Financial reports, including a statement detailing all Grant or Project Costs (as hereinafter defined) which have been incurred since the prior request for reimbursement, shall be submitted with each request for reimbursement and with the Closeout Report. Financial Reports shall be submitted on forms provided by CDFA.
- 10.3 Within thirty (30) days after the Completion Date, a Closeout Report shall be submitted which summarizes the results of the Grant Activities, showing, in particular, how the Grant Activities have been performed. The Closeout Report shall be in the form required or specified by CDFA.
- 10.4 The Audited Financial Reports shall be prepared in accordance with the regulations which implement OMB 2 CFR Part 200. A copy of the audited financial report shall be submitted within thirty (30) days of the completion of said report to CDFA.
- 10.5 Where the Grantee is not subject to the requirements of OMB 2 CFR Part 200, one of the following options will be chosen by CDFA:
 - 10.5.1 Within ninety (90) days after the Completion or Termination Date a copy of an audited financial report shall be submitted to CDFA. Said audit shall be conducted utilizing the guidelines set forth in "Standards for Audit of Governmental Organizations, Programs, Activities, and Functions" by the Comptroller General of the United States.
 - 10.5.2 CDFA will conduct a financial Review-in-Lieu of Audit within ninety (90) days after the Completion Date of the Project.
- 10.6 Where the length of the grant period exceeds twenty-four (24) months, there shall be an interim audit performed and submitted.
- 10.7 <u>Specific Subrecipient Reporting.</u> Several performance measures and goals reporting will be required from the Grantee via the Subrecipients as outlined in the attached Subrecipient Agreements for the four Subrecipient organizations: BEDC, GRDC, NCIC, and WREN.

11. RECORDS AND ACCOUNTS: ACCESS

- During the performance of the Project Activities and for a period of three (3) years after the Completion Date or the date of the final audit approval by CDFA, whichever is later, the Grantee shall keep, and shall require any Subrecipient to keep, the following records and accounts:
 - 11.1.1 Records of Direct Work: Detailed records of all direct work performed by its personnel under this Agreement.

- 11.1.2 Fiscal Records: Books, records, documents and other statistical data evidencing, and permitting a determination to be made by CDFA of all Project Costs and other expenses incurred by the Grantee and all income received or collected by the Grantee, during the performance of the Project Activities. The said records shall be maintained in accordance with accounting procedures and practices acceptable to CDFA, and which sufficiently and properly reflect all such costs and expenses, and shall include, without limitation, all ledgers, books, audits, records and original evidence of costs such as purchase requisitions and orders, invoices, vouchers, bills, requisitions for materials, inventories, valuations of in-kind contributions, labor time cards, payrolls and other records requested or required by CDFA.
- 11.1.3 Contractor and Subcontractor Records: The Grantee shall, and where applicable, Subrecipient shall, establish, maintain and preserve, and require each of its contractors and subcontractors to establish, maintain and preserve property management, project performance, financial management and reporting documents and systems, and such other books, records, and other data pertinent to the project as the CDFA may require. Such records shall be retained for a period of three (3) years following completion of the project and receipt of final payment by the Grantee, or until an audit is completed and all questions arising therefrom are resolved, whichever is later.

12. TERMINATION: REMEDIES

- 12.1 <u>Inability to Perform: Termination by Grantee</u>. As a result of causes beyond its control, and notwithstanding the exercise of good faith and diligence in the performance of its obligations hereunder, if it shall become necessary for Grantee to terminate this Agreement, Grantee shall give CDFA fifteen (15) days edvance written notice of such termination, in which event the Agreement shall terminate at the expiration of said fifteen (15) days.
- 12.2 <u>Termination Without Default</u>. In the event of termination without default and upon receipt, acceptance and approval by CDFA of the Termination Report, as referenced in the General Provisions, Grantee shall receive payment for all Project Costs incurred in the performance of Grant Activities completed up to and including the date of termination and for which payment had not previously been made including, but not limited to, all reasonable expenses incurred in the preparation of the Termination Report; provided, however, that in the event that any payments have been made hereunder in excess of Project Costs incurred up to and including the date of termination of the Agreement, CDFA shall offset any payments to be made hereunder against such payments, and if applicable, Grantee shall refund to CDFA the amount of any excess funds it retains after such offset.
- Termination for Default. In the event of termination for default or other violation of Program requirements, CDFA shall, upon receipt, acceptance and approval of the Termination Report submitted by Grantee, pay Grantee for Project Costs incurred up to and including the date of termination (subject to off-set against funds paid to Grantee hereunder and to the refund of any excess funds); provided, however, that in such event the amount of such payment shall be determined solely by CDFA; and provided, further, that in no event shall the making of any such payments relieve Grantee of any liability for damages sustained or incurred by CDFA as a result of Grantee's breach of its obligations hereunder, or relieve Grantee of responsibility to seek return of Grant Funds from any Subrecipient or Beneficiary where applicable.
- 12.4 <u>Limitation on Grantee Liability for Subgranted Funds.</u> Notwithstanding anything in this Agreement to the contrary and absent the presence of fraud or negligence on the part of Grantee in enforcing its rights and obligations under the terms of any Subrecipient agreement, the sole obligation of Grantee with respect to the return of Grant Funds, in the event of default on a grant condition or other termination of the Project or event requiring return of Grant Funds, shall be to make a good faith effort to return to the

State of New Hampshire all grant funds paid to Subrecipient through Grantee. Grantee shall make good faith efforts to enforce the legal obligations entered into with the Subrecipient as provided herein, to call upon the collateral held by itself or others, and exercise due diligence in its efforts in bringing about the satisfaction of the grant obligations and, having done so, it shall not be required to look to any other funds or its tax base to recoup grant funds not recovered from the Subrecipient.

Assignment to CDFA and Payment of Expenses and Costs. Grantee hereby agrees that, in the event it falls to enforce the provisions of any Subrecipient Agreement or falls to cure an Event of Default resulting in termination of this Agreement or the Project, Grantee shall, upon demand by CDFA, assign and convey to CDFA all or any of its rights, title and interest, or delegate to CDFA all or any of its obligations under the Subrecipient Agreement and any Mortgage, Promissory Note, Security Agreement or other agreement as applicable. Such delegation or assignment shall be effective only in the event of a default by Subrecipient or Beneficiary in its or their obligations under the Subrecipient Agreement or other agreement. In the event that CDFA assumes any of the obligations of Grantee as provided herein, Grantee shall pay all costs and expenses incurred by CDFA in the enforcement of the Subrecipient Agreement, collection upon any loan, mortgage or other security, or in curing any Event of Default.

PROJECT/PROGRAM ACTIVITY COSTS; METHOD AND TERMS OF PAYMENT

- PROJECT COSTS; PAYMENT SCHEDULE; REVIEW BY CDFA.
 - 1.1 <u>Project Costs</u>: As used in this Agreement, the term "Project Costs" shall mean all reimbursable costs incurred in performance of the Grant Activities. Project Costs shall include the following:
 - 1.1.1 Program Costs: As used in this Agreement, the term "Program Costs" shall mean reimbursable costs incurred by Subrecipient that are related to direct support of qualifying microenterprises, including technical assistance, training, grants, down payment assistance and loans.
 - 1.1.2 Program Activity Costs: As used in this Agreement, the term "Program Activity Costs" shall mean costs incurred by the Subrecipient to manage and deliver the Microenterprise program. Program Activity Costs include but are not limited to: personnel costs directly related to overall delivery and management of the Microenterprise program, advertising/marketing related to the Microenterprise program, environmental studies related to direct grants and loan processing for qualifying microenterprise clients.
 - 1.1.3 <u>Delivery Costs</u>: As used in this Agreement, the term "Delivery Costs" shall mean all reimbursable costs incurred by a Subrecipient, as set forth in Attachment I, "Sources and Uses" in connection with a regional revolving loan fund that are directly related to the preparation and execution of loan documents and to the monitoring and administration of the loan provisions, and which are ellowable by the New Hampshire Community Development Block Grant program rules.
 - 1.1.4 General Administrative Costs: As used in this Agreement, the term "General Administrative Costs" shall mean all expenses directly or indirectly incurred by Grantee in the performance of the Project Activities, as determined by CDFA to be eligible and allowable for payment in accordance with allowable administrative project cost standards set forth in OMB 2 CFR 200 as revised from time to time, and with the rules, regulations and guidelines established by CDFA. General Administrative costs include but are not limited to: preparation of environmental review, record keeping, reporting, audits and oversight of Project implementation and compliance with all federal, state and local laws, rules and regulations and this contract. In no event shall General Administrative Costs exceed fifteen (15) percent of the total Grant funds allowed. With respect to a nonprofit subrecipient, such subrecipient shall meet the requirements of OMB 2 CFR 200.
 - 1.2 <u>Payment of Costs</u>: Subject to the terms and conditions of this agreement, CDFA agrees to pay Grantee all Project, Program Activity, Delivery and General Administrative Costs, provided, however, that in no event shall the total of all payments made by CDFA pursuant to this Agreement exceed the Grant Amount as set out in Paragraph 1.8 of the General Provisions, and provided further that all Costs shall have been incurred prior to the Completion Date, except for reasonable approved Costs incurred within 90 days after the Completion Date and in connection with closeout requirements as provided in CDFA's Implementation Guide.
 - 1.3 Review by CDFA; Disallowance of Costs: At any time during the performance of the Project Activities, and upon receipt of the Progress Reports, Closeout Report or Audited Financial Report, CDFA may review all Project/Program Activity Costs incurred by Grantee or any

Subrecipient and all payments made to date. Upon such review, CDFA shall disallow any items of expense which are not determined to be allowable or are determined to be in excess of actual expenditures, and shall, by written notice specifying the disallowed expenditures, inform Grantee of any such disallowance. If CDFA disallows costs for which payment has not yet been made, it shall refuse to pay such costs. If payment has been made with respect to costs which are subsequently disallowed, CDFA may deduct the amount of disallowed costs from any future payments under this Agreement or require that Grantee refund to CDFA the amount of the disallowed costs.

2. METHOD AND TERMS OF REIMBURSEMENT FOR PROJECT COSTS.

- 2.1 CDFA shall not disburse any funds for the purposes of this Project until such time as all agreements specified in Exhibit B and any other agreements or documents specified pursuant to this Agreement are fully executed and received, and where applicable, are reviewed and approved in writing by CDFA. Agreements and documents may include:
 - 2.1.1 A Subrecipient or Business & Employment Commitment Agreement, as applicable;
 - 2.1.2 Copies of required certificates of insurance from all parties to this agreement;
 - 2.1.3 Certified payrolis documenting employment and positions in all U.S. operations and facilities, (a) no earlier than the date of application, as approved by CDFA, or (b) the date of Governor and Council approval;
 - 2.1.4 Any lease and loan documents, mortgages, liens, security instruments, municipal bonds, and similar agreements used in connection with the enforcement of beneficiary requirements, as well as any other related documents as requested by CDFA.
- 2.2 <u>Timing of Payments</u>. Upon thirty (30) days of the receipt, review, and approval by CDFA of financial reports and requests for reimbursement from Grantee specifying all Project Costs incurred, CDFA agrees to reimburse Grantee for Project Costs, except that reimbursement may be withheld until CDFA determines that a particular project activity or portion of the project activity hereunder has been satisfactorily completed.
- 2.3 Disbursement of funds by CDFA does not constitute acceptance of any item as an eligible Project Cost until all Project Costs have been audited and determined to be allowable costs.

3. REQUIRED DOCUMENTATION FOR DISBURSEMENT OF GRANT FUNDS.

Reimbursement requests for all Project Costs shall be accompanied by proper supporting documentation in the amount of each requested disbursement along with a payment request form as supplied by CDFA, which shall be completed and signed by Grantee. Documentation may include invoices and receipts for supplies, equipment, services, contractual services and, where applicable, a report of salaries paid or to be paid.

4. <u>LIMITATIONS ON USE OF FUNDS</u>.

- 4.1 Grant funds are to be used in a manner consistent with the State of New Hampshire Community Development Block Grant Program as approved by the U.S. Department of Housing and Urban Development.
- 4.2 Grant funds are to be used only in accordance with procedures, requirements and

principles specified in 24 CFR 85.

- 4.3 Grant funds may not, without advance written approval by CDFA, be obligated prior to the Effective Date or subsequent to the Completion Date of the grant period. Obligations outstanding as of the Completion Date shall be liquidated within ninety (90) days. Such obligations must be related to goods or services provided during the grant period, except that reasonable costs associated solely with grant closeout, (e.g., audits, final reports) may be incurred within ninety (90) days after the Completion Date. The funding assistance authorized hereunder shall not be obligated or utilized for any activities requiring a release of funds under the Environmental Review Procedure for the Community Development Block Grant Program at 24 CFR Part 58, until such release is issued in writing by CDFA.
- 4.4 Changes in Funding Project Activities: Grantee may submit a written request for the authority to transfer up to ten (10) percent of the full value of the grant from one approved activity to another listed in Exhibit B herein or from an approved activity within the approved project area to an approved activity located outside the project area and the Director of CDFA may approve the requested transfer.
- 4.5 Transfers over ten percent of the full value of the grant from one approved activity to other approved activities or outside the target area, or the addition of one or more new activities requires an amendment to this grant agreement. Grantee shall hold a public hearing in accordance with RSA 4: C: 14 II (b) submitting a request for an amendment involving twenty-five (25) percent or more of the full value of the grant.
- 4.6 Up to \$47,300 of Grant Funds may be applied by the Grantee for General Administrative Costs (as described in Section 1.1.4, above) in carrying out the requirements of this Agreement.
- 4.7 Up to \$452,700 of grant funds may be subgranted to Subrecipient for the purpose of providing technical assistance and training, direct grants, down payment assistance grants and loans to microenterprises, and for program activity costs as described herein pursuant to the requirements of this Agreement.

5. PERFORMANCE OF SERVICES BY GRANTEE PRIOR TO EFFECTIVE DATE; PAYMENT BY CDFA.

Any Grant Activities performed by Grantee with non-CDBG funds prior to the Effective Date shall be performed at the sole risk of Grantee, and in the event that this Agreement shall not become effective, CDFA shall be under no obligation to pay Grantee for any costs incurred in connection with any Grant Activities, or to otherwise pay for any Activities performed during such period.

PROGRAM INCOME.

- 6.1 Program income: All program income earned during the term of this Agreement shall be retained by Grantee or, in projects involving the administration of a revolving loan fund by the Subrecipient.
- 6.2 When Used for Project Activities: When program income becomes available, Grantee and, where applicable, Subrecipient shall use it for Grant Activities contained in the Project Description before drawing down additional funds unless the program income is deposited in a revolving loan account with prior approval by CDFA.
- 6.3 When Used for Eligible Activities: After completion of the Grant Activities specified in this Agreement, Grantee and, where applicable, Subrecipient shall use program income only for eligible activities which benefit primarily people from low- and moderate-income families, with

ATTACHMENT II-A

SUBRECIPIENT AGREEMENT MINIMUM TERMS AND CONDITIONS

The County of Grafton ("Grantee") hereby warrants and agrees that the Subrecipient Agreement with the Belknap County Economic Development Council (BEDC) ("Subrecipient") to be executed in conformance with the requirements of Exhibit B of the Grant Agreement shall be subject to approval by CDFA. The Subrecipient Agreement shall incorporate the entire Grant Agreement and shall include it as an attachment, and shall contain at a minimum the following terms and conditions:

1. REPRESENTATION AND WARRANTIES.

Belknap County Economic Development Council (BEDC) ("Subrecipient") shall represent and warrant:

- 1.1 Subrecipient is a duly organized and validly existing New Hampshire nonprofit corporation in good standing under the laws of this State. Subrecipient has the power and authority to undertake the grant activities as provided in the Grant Agreement. Subrecipient has the power and authority to own its properties, to conduct business as it is now being conducted, has the power to execute and deliver and perform its obligation under the Subrecipient Agreement and all other documents as applicable to this grant agreement.
- 1.2 The Subrecipient Agreement is the legal, valid and binding obligation of Subrecipient enforceable against Subrecipient, in accordance with each document's respective terms.
- 1.3 Subrecipient has complied in all material respects with all applicable federal, state and local laws, statutes, rules and regulations pertaining to the grant activities.
- 1.4 No application, exhibit, schedule, report or other written information provided by Subreciplent or its agents in connection with the grant application knowingly contained, when made, any material misstatement of fact or knowingly omitted to state any material fact necessary to make the statements contained therein not misleading, in light of the circumstances under which they were made.

2. PROJECT DESCRIPTION AND SUBGRANT ACTIVITIES.

2.1 <u>Project Description</u>. This project shall consist of the awarding of \$199,500 in Community Development Block Grant (CDBG) funds to the Grantee. The Grantee will retain \$17,300 of the grant for administrative costs associated with management of the grant and subgrant \$182,200 to the Subreciplent via this Subreciplent Agreement.

The Subrecipient's commitment is to work in pertnership with the Wentworth Economic Development Corporation (WEDCO) to increase the income and economic stability of qualifying microenterprises by helping them to access technical assistance (TA), training, capital, and expanded market opportunities. Sub-granted funds will be used by the Subrecipient and its partner to deliver Microenterprise Program services and support in the following program categories:

2.1.1 TA and Training – Subrecipient will provide technical assistance and training programs to a minimum of 38 low- and moderate-income microenterprises, primarily in Belknap, Carroll and Strafford Counties, with 100% of persons served being of low- and moderate-income status (LMI), at a pro-rata cost of \$2,500 for each qualifying and enrolled LMI beneficiary.

Subrecipient may request an additional \$2,500 per enrolled, credit-worthy microenterprise beneficiary to cover loan processing costs for loans provided by Subrecipient, or by WEDCO upon referral by Subrecipient.

- 2.1.2 <u>Direct Grants</u> Subrecipient will provide direct grants of up to \$5,000 to a minimum of four (4) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Direct grants may be used for purchase of equipment/machinery or capital improvements directly related to operation or expansion of the qualifying microenterprise. Each qualifying microenterprise may receive one direct grant of no more than \$5,000 during the Grant Period.
- 2.1.3 <u>Down Payment Assistance</u> Subrecipient will provide down payment assistance grants of up to \$10,000 to a minimum of two (2) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Down payment assistance grants may be used to support purchase of commercial property/real estate that is directly related to the affected business. Each qualifying microenterprise may receive one down payment assistance grant of no more than \$10,000 during the Grant Period.
- 2.1.4 <u>Microenterprise Lending Capital</u> Subrecipient may request up to \$25,000 in loan capital to support micro-loans to qualifying microenterprises (not more than \$50,000 per qualifying microenterprise) that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. CDBG funds must be matched on a 1:1 basis with other funds provided by CDFA. As part of its request for loan capital, Subrecipient must provide detailed information on the proposed micro-loan that addresses each of the following guidelines as stated in HUD CFR 570.482 Appendix A, specifically that:
 - (i) That project costs are reasonable:
 - (ii) That all sources of project financing are committed;
 - (III) That to the extent practicable, CDBG funds are not substituted for non-Federal financial support;
 - (iv) That the project is financially feasible:
 - (v) That the return on the owner's equity investment will not be unreasonably high; and
 - (vi) CDBG funds are disbursed on a pro rate basis with other finances provided to the project.

Detailed guidance on micro-loan management and claims is included as Attachment VI.

2.1.5 <u>Program Activity Costs</u> – Subrecipient may request up to 20% of TA/Training, Direct Grant and Down Payment Assistance funds to cover costs incurred by the Subrecipient to manage and deliver the Microenterprise program, not to exceed a total of \$26,200 during the Grant Period.

3. SUBRECIPIENT REQUIREMENTS.

- 3.1 <u>Performance Requirements</u>. The Grantee shall enter into an agreement with Subrecipient in order to satisfy the project purpose, which is technical assistance and training for 38 beneficiaries; direct grants for four (4) beneficiaries; down payment assistance for two (2) beneficiaries; and micro-loans to an unspecified number of beneficiaries, of which one hundred percent (100%) will be LMI persons, as set forth in Exhibit B.
- 3.2 Security. Not Applicable to this Award.
- 3.3 <u>Compliance with Laws</u>. Subrecipient shall comply with all applicable federal, state, and local laws, statutes, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 3.4 <u>Disbursement of Grant Funds</u>. Upon compliance with, and subject to the provisions of this Agreement and provided there shall exist no Event of Default under this Agreement, the Grant Agreement or any other agreements, in connection with the Project, and no condition or event which, with the giving of notice or lapse of time would constitute such an Event of Default, the Grantee shall, upon submittal of written requests for payment accompanied by invoices and other documentation or supporting documents

as required by the Grantee, make disbursements of grant funds. Disbursement of grant funds shall be in accordance with the terms of the Grant Agreement, including Exhibit C.

Disbursement of funds by the Grantee does not constitute acceptance by the Grantee or CDFA of any Item as an eligible Project cost until all Project costs have been audited and determined to be allowable costs. Upon the expiration of the Grant Agreement, or other termination of the project, Subrecipient shall transfer to the Grantee any Grant funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds.

4. MICROENTERPRISE ASSISTANCE LIMITATIONS.

Under HUD guidelines, specific to microenterprise assistance, microenterprise beneficiaries are limited to CDBG funding for a period of three (3) years. To determine compliance, the eligibility of microenterprise beneficiaries shall be reviewed and tracked; eligibility is based upon the date of their initial enrollment in programs. Enrollment is not required to be consecutive. Reassessment of LMI status is required if a Family Income Verification Form (FIVF) is more than three (3) years old. New beneficiaries are those enrolled at any time on or after July 1, 2022, or upon Governor and Council approval, through the Grant Period end date as outlined in Section 1.7 of the General Provisions.

5. REPORTING REQUIREMENTS: ANNUAL, SEMI-ANNUAL AND CLOSEOUT AGREEMENTS.

- 5.1 The reporting period shall begin on July 1, 2022 and end on the Completion Date specified in Section 1.7 of the General Provisions of the contract between the Grantee and CDFA. Semi-annual reports shall be submitted by the Subrecipient to the Grantee no later than January 10th, for the period of July 1, 2022 through December 31, 2022; and no later than July 10th, for the period of January 1, 2023 through June 30, 2023. Grantee shall submit these reports to CDFA by January 15th and July 15th.
- 5.2 Subrecipient Reporting to Grantee. The Subrecipient, in compilance with this Subrecipient Agreement, is required to submit technical assistance and training applicant information to the Grantee and CDFA as set forth in Section 6.
- 5.3 Closeout Agreement. Subrecipient shall enter into a Closeout Agreement with the Grantee and CDFA, which shall specify the reporting and other requirements applicable to the closing out of this Project.
- 5.4 Annual Subrecipient Financial Reporting. Subrecipient shall submit to the Grantee and to CDFA its annual audited financial statements, within 90 days of its fiscal year end.
- 5.6 All Reporting shall be submitted via CDFA's Grants Management System (GMS).

6. INITIAL SUBRECIPIENT DOCUMENTATION AND SPECIFIC REPORTING REQUIREMENTS.

- 6.1 In order to determine beneficiary eligibility and to comply with HUD's beneficiary enrollment limit of three years (described in Section 4), at the start of the program year, Subrecipient shall prepare a baseline report that includes a complete list of existing beneficiary microenterprises enrolled in that Subrecipient's training and technical assistance programs as of June 30, 2022, using the Microenterprise Beneficiary Tracking sheet, as set forth in Attachment IV. Data for the baseline report shall include information regarding each beneficiary, as set forth in the FIVF, provided on Attachment III; the Subrecipient's beneficiary intake form; and other relevant sources.
- 6.2 On a quarterly basis, Subrecipient shall submit a claim request for all Technical Assistance/Training beneficiaries served in the previous quarter, at a rate of \$2,500 per qualifying beneficiary. Each quarterly claim shall include a completed Microenterprise Beneficiary Tracking sheet with information regarding each beneficiary served during that quarter, as set forth in Attachment IV. The tracking sheet will be used to record beneficiary information for each calendar quarter of the program year (July September, October –

December, January – March, and April – June). Subreciplent shall use and submit the CDFA-provided Microsoft Excel version of the Beneficiary Tracking Sheet and no other version.

- 6.3 At the end of the program year, Subrecipient shall prepare a final report which includes the Microenterprise Beneficiary Tracking Sheet for the entire program year, as well as the following information for each Technical Assistance/Training beneficiary:
 - (a) Subrecipient's Beneficiary Intake Form:
 - (b) FIVF, signed by all participants; the FIVF documents family income status and the designation of beneficiary minority or protected class status;
 - (c) Income changes as well as notable successes for its beneficiaries as a result of their participation in Subrecipient's programs; and
 - (d A list of beneficiaries that received loans during the program year.

The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.

- 6.4 In addition to the quarterly claims described in Section 6.2, Subrecipient may submit additional claim requests for Direct Grant and/or Down Payment Assistance Grant support for qualifying beneficiaries. Each claim shall include a completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet with Information regarding each beneficiary to be served pursuant to the claim, as set forth in Attachment VI. Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Tracking Sheet and no other version. Claims for Direct Grant and Down Payment Assistance Grant support may be submitted at any time throughout the Grant Period.
- 6.5 In addition to claims processes described in Section 6.2 and Section 6.4, Subrecipient may submit additional claim requests for CDBG Micro-loan capital funds to support micro-loans to qualifying beneficiaries. Each claim shall include a completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet with information regarding each beneficiary to be served pursuant to the claim, as set forth in Attachment VI. Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Tracking Sheet and no other version. Claims for CDBG Micro-loan support may be submitted at any time throughout the Grant Period.
- 6.6 At the end of the program year, Subrecipient shall prepare a final report which includes the completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet for all qualifying beneficiaries that received direct grants and/or loans during the entire program year and a narrative describing the how the direct grant and/or loan programs were administered, issues and challenges and information that could improve future program implementation. The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.
- 6.7 All documentation shall be submitted via CDFA's Grants Management System (GMS).
- 7. TRAINING AND JOB CREATION/RETENTION BENEFIT TO PERSONS FROM LOW- AND MODERATE-INCOME HOUSEHOLDS.

The general purpose of the project is to principally benefit Low- and Moderate-Income persons as that term is defined in 24 CFR 570.483 and CDFA's Implementation Guide.

The Grantee and Subrecipient agree that the primary purpose of the Project is to provide training and technical assistance to at least thirty-eight (38) microenterprise beneficiaries; direct grants to at least four (4) microenterprise beneficiaries; down payment assistance grants to at least two (2) beneficiaries; and micro-loans to an unspecified number of beneficiaries. Of the beneficiaries served, one-hundred percent (100%) shall be persons from low- and moderate-income households, using the income limits as described above, and as provided in Attachment III, "Family Income Verification Form". Subrecipient agrees to maintain and provide documentation that it has complied with the income limits requirement using FIVFs provided by the Grantee.

8. GRANT OF FUNDS/MATCHING FUNDS.

- 8.1 Subrecipient shall use the Grant funds sub-granted to it solely for the purposes described herein and consistent with the required terms and conditions of the Grant Agreement and Subrecipient Agreement.
- 8.2 No other funds are required by the Subrecipient to match the Grant funds to be used for TA/Training, Direct Grants, Down Payment Assistance Grants and Program Activity Costs, pursuant to this Agreement and In connection with this Grant Project.
- 8.3 Subrecipient agrees that Grant funds to be used as lending capital for micro-loans to qualifying microenterprises enrolled in the Subrecipient's TA/Training programs must be matched on a 1:1 basis with other funds provided by CDFA.

9. SCHEDULE AND GRANT COMPLETION.

- 9.1 <u>Implementation Schedule</u>. The Grantee and Subrecipient have agreed to an Implementation Schedule, which will provide for the completion of all grant activities, prior to the Grant Completion Date. A schedule of major milestones shall be provided within the Subrecipient Agreement, and shall serve as a basis for enforcement of the Agreement.
- 9.2 <u>Grant Completion Date</u>. All work shall be completed prior to the Grant Completion Date as outlined in Section 1.7 of the General Provisions. All employment commitments shall be accomplished by that date. This date may be extended only with the permission of the Grantee, CDFA, and the Governor and Council.
- 9.3 <u>Project Delays</u>. Should the Project encounter delays relating to financing, construction or other events that may affect the Subrecipient' ability to serve the number of beneficiaries identified in Section 7 within the specified Grant Completion Date, the Subrecipient and Grantee shall submit a written request for a time extension to CDFA, describing the reason for delay. Grant completion time extension requests shall then be forwarded to Governor and Council for final approval.

10. INSURANCE AND TAXES

10.1 <u>Subrecipient's Liebility Insurance</u>. Subrecipient shall, at its sole expense, obtain and maintain in force Insurance in such amounts and covering such risks as are customary for entities engaged in the same or similar business to include, where applicable, comprehensive general flability covering any property development/construction activities and landlord insurance and workers compensation insurance. At a minimum, this shall include insurance against all claims of bodily injury or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate and as further set forth in the General Provisions.

All policies shall name the Grantee and CDFA as additional insureds. Subrecipient shall provide the Grantee with certificates of insurance satisfactory to the Grantee, which evidences compliance with this Section.

- 10.2 <u>Insurance Standards</u>. The policies described in this section shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. All policies shall be on an "occurrence" basis. Each policy shall contain a clause prohibiting cancellation or modification of the policy earlier than thirty (30) days after written notice thereof has been received by the Grantee and CDFA.
- 10.3 <u>Taxes</u>. If applicable, Subrecipient shall pay all taxes, assessments, charges, fines and impositions attributable to the Property, which is the responsibility of the Subrecipient. Any alternative arrangements will require the approval of CDFA, whose consideration will not be unreasonably withheld.

11. ACCOUNTING, AUDIT, AND RECORD KEEPING REQUIREMENTS.

- 11.1 Accounting Records. Subrecipient shall keep all Project-related accounts and records, which fully disclose the amount and disposition by Subrecipient of the grant funds, the total cost of the Project, and the amount and nature of any portion of the Project cost supplied by other sources, and such other financial records pertinent to the Project. Accounts and records shall be kept in accordance with an accounting system that will facilitate an effective audit in accordance with the Single Audit Act of 1984. Records to be maintained shall include Project fiscal records consisting of all books, documents, ledgers, systems and expenses incurred, including, but not limited to, purchase, requisitions, orders, invoices, vouchers, bills and receipts, inventories, and all lien documents.
- 11.2 <u>Time Period</u>. All of the records, documents, and data described above and all income verification information shall be kept during the performance of the project, and for three (3) years after its completion or until the satisfactory completion of an audit, whichever is later.
- 11.3 <u>Availability of Records</u>. Subrecipient shall make available to the Grantee, CDFA, and HUD or any of their duly authorized representatives, for the purpose of audit and examination, any books, documents, papers, and records of Subrecipient pertinent to this Agreement.

12. INDEMNIFICATION.

Subrecipient shall defend, indemnify and hold harmless the Grantee, the State of New Hampshire, and the CDFA, their officers and employees, from and against any and all losses suffered by the Grantee, the State, or CDFA, their officers or employees, and any and all claims, liabilities or penalties asserted against the Grantee, the State or CDFA, their officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of or claimed to Subrecipient out of the acts or omissions of Subrecipient.

Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State or the Grantee, which immunity is hereby reserved to the State and the Grantee. This covenant shall survive the termination or expiration of this Agreement.

13. MAINTENANCE OF CORPORATE EXISTENCE.

- 13.1 <u>Corporate Existence</u>. Subrecipient shall both preserve and maintain the legal existence and good standing of its nonprofit corporation status and its registration in New Hampshire as required to do business.
- 13.2 Scope of Mission. Subrecipient and Grantee agree that the Subrecipient's Articles of Incorporation and Corporate Bylaws ("Bylaws") as submitted with the Project application and incorporated herein by reference, provide an adequate administrative mechanism for assuring the Subrecipient's mission of providing training and technical assistance opportunities for low- and moderate-income persons, during the Grant Period, as required pursuant to this agreement.

14. EVENTS OF DEFAULT.

The occurrence of any of the following events shall constitute an Event of Default under this Agreement:

- (a) Any Event of Default by Subrecipient under the Grant Agreement, and related documents including, but not limited to, the failure of the Subrecipient to accomplish the required training and technical assistance benefit to low- and moderate-income persons;
- (b) The Subreciplent's failure to comply with the reporting requirements as specified herein;

- (c) Subrecipient attempts to assign its rights under this Agreement or any advance made or to be made hereunder or any interest therein, without the prior written consent of the Grantee;
- (d) Any representation or warranty made herein or in any report, certification, or other instrument furnished in connection with this Agreement or any advances of Grant funds made hereunder, by or in behalf of Subrecipient, shall prove to be false or misleading in any material respect;
- (e) Any mechanics', laborers', materialmen's or similar statutory liens, or any notice thereof, shall be filed against the Property and/or the Project and shall not be discharged within thirty (30) days of such filling:
- (f) Subrecipient shall default in the due observance or performance of any covenant, condition, assurance or agreement to be observed or performed by Subrecipient under this Agreement;
- (g) Subrecipient shall (i) apply for or consent to the appointment of a receiver, trustee, or liquidator of it or any of its property, (ii) admit in writing its inability to pay its debts as they mature, (iii) make a general assignment for the benefit of creditors, (iv) be adjudicated as bankrupt or insolvent or (v) file a voluntary petition in bankruptcy, or a petition or answer seeking reorganization or an arrangement with creditors or to take advantage of any bankruptcy, reorganization, arrangement, insolvency, readjustment of debt, dissolution or liquidation law or statute, or an answer admitting the material allegations of a petition filed against it in any proceeding under any such law;
- (h) A petition, order, judgment, or decree shall be entered, without the application, approval or consent of Subrecipient by any court of competent jurisdiction, approving a petition seaking reorganization or approving the appointment of a receiver, trustee or liquidator of Subrecipient of all or a substantial part of its assets, and such order judgment or decree shall continue unstayed and in effect for any period of thirty (30) days;
- (i) The dissolution, termination of existence, merger or consolidation of Subrecipient or a sale of assets of Subrecipient out of the ordinary course of business without the prior written consent of the Grantee and CDFA; and
- (j) Failure to remedy an ineligible expenditure of grant funds or to reimburse the Grantee for any !neligible costs, which are paid from grant funds.
- (k) In the event that the Subrecipient fails to serve the minimum number of Low- and Moderate-Income beneficiaries, as provided in this Agreement, then the Subrecipient shall confer forthwith with the Grantee and CDFA to develop a mutually acceptable plan pursuant to which it will rectify any reporting shortfails and maintain the required minimums. In such event, the Subrecipient shall also provide Grantee with monthly updates containing information in a form reasonably satisfactory to the Grantee, in order for the Grantee and Subrecipient to determine whether it is in compliance with such plan and its obligations as provided herein. Said monthly reports to continue until the beneficiary commitments are achieved.
- (i) The continued failure of the Subrecipient to achieve its beneficiary commitments as required herein for ninety (90) days following the date specified for such requirement shall constitute an event of default, which may give rise to any of the remedies available to the Grantee, as set forth therein.

15. GRANTEE'S RIGHTS AND REMEDIES UPON DEFAULT.

15.1 Remedies upon Default. Upon the occurrence of any Event of Default, the Grantee may take any one, or more, or all, of the actions described below. Prior to taking any of the following actions, the Grantee will give Subrecipient a written notice of default specifying the Event of Default and requiring it to be remedied within thirty (30) days from the date of notice. The following actions may be taken only if

Subreciplent has not remedied the Event of Default in a timely manner.

- (a) Terminate this Agreement, effective immediately upon giving notice of termination;
- (b) Suspend all payment of grant funds to be made pursuant to this Agreement until such time as the Grantee determines the Event of Default has been cured;
- (c) Set off against any other obligations the Grantee may owe to Subreciplent for any damages the Grantee may suffer by reason of any Event of Default:
- (d) Treat the Agreement as breached and pursue any of its remedies at law or in equity or both;
- (e) Foreclose under any available security instrument created under this agreement; and
- (f) Assume the right to seek full reimbursement of CDBG funds from the Subrecipient and the right to call on any collateral pledged under the loan with the Subrecipient.
- 15.2 <u>Judicial Enforcement</u>. Subrecipient agrees that the Grantee and CDFA have a right to seek judicial enforcement with regard to any matter arising with respect to this Agreement, to include the assurances, covenants and other conditions, which extend beyond the completion date under this Agreement.
- 15.3 <u>Disposition of Funds</u>. Where the Grant Agreement or Subrecipient Agreement is terminated or the Project is otherwise terminated due to a default, inability to perform or reasons other than project completion, Grant funds are required to be returned. The disposition of Grant Funds to be returned shall be determined solely by CDFA.
- 16. ADDITIONAL REPRESENTATIONS AND WARRANTIES. Subrecipient represents and warrants:
 - (a) Subrecipient will obtain all necessary approvals and all necessary permits for the operation of its business from all governmental authorities having jurisdiction.
 - (b) No litigation, claims, suits, orders, investigations or proceedings are pending or threatened against Subrecipient or affecting the Property or the Project at law or in equity or before or by any federal, state, municipal or other governmental instrumentality; there are no arbitration proceedings pending under collective bargaining agreements or otherwise; and to the knowledge of Subrecipient, there is no basis for any of the foregoing. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.
 - (c) Subrecipient has filed all federal, state and local tax returns required to be filed and has paid or made adequate provision for the payment of all federal, state or local taxes, charges and assessments, if applicable.
 - (d) The execution and delivery and performance by Subrecipient of its obligations under this Agreement have been duly authorized by all requisite corporate action and will not violate any provision of law, any order of any court or other agency of government, or any indenture, agreement or other instrument to which Subrecipient is a party, or by which it is bound, or be in conflict with, result in a breach of, or constitute a default under, or except as may be provided in this Agreement, result in the creation or imposition of any ilen, charge or encumbrance of any nature whatsoever upon any of the property or assets of Subrecipient pursuant to any such indenture, agreement or instrument. Subrecipient is not required to obtain any consent, approval or authorization from, or to file any declaration or statement with, any governmental instrumentality or other agency in connection with or as a condition to the execution, delivery or performance of this Agreement and all other related documents.

- (e) Subrecipient is not contemplating either the filing of a petition under any state or federal bankruptcy or insolvency laws or the liquidating of all or a major portion of its properties and has no knowledge of any person contemplating the filing of any such petition against it.
- (f) No statement of fact made by or on behalf of Subrecipient in any of the agreement or related documents or in any certificate, exhibit or schedule furnished to the Grantee pursuant thereto, contains any untrue statement of a material fact or omits to state any material fact necessary to make statements contained therein or herein not misleading. There is no fact or circumstance presently known to Subrecipient that has not been disclosed to the Grantee that materially affects adversely, nor as far as Subrecipient can foresee, will materially affect adversely Subrecipient, operations or considerations (financial or otherwise) of Subrecipient.
- (g) No Event of Default has occurred and is continuing under this Agreement and no event or condition which would, upon notice of expiration of any applicable cure, constitute an Event of Default has occurred and is continuing; Subreciplent is not in default under any note or other evidence of indebtedness or other obligation for borrowed money or any mortgage, deed to trust, indenture, lease agreement or other agreement relating thereto. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.

Subrecipient warrants that each of the foregoing representations and warranties is true and correct as of the date of this Agreement and Subrecipient shall indemnify and hold harmless the Grantee, the State and CDFA from and against any loss, damage, or liability attributable to the breach thereof, including any and all fees and expenses incurred in the defense or settlement of any claim arising therefrom against the Grantee, State or CDFA.

13. MISCELLANEOUS PROVISIONS.

- 13.1 Compliance with Laws. Subrecipient shall comply with all applicable federal, state and local laws, statutes, regulation, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 13.2 Compliance with OMB 2 Part 200. Subrecipient acknowledges that it shall meet the requirements of OMB 2 Part 200, to ensure compliance with Administrative Cost Standards.
- 13.3 No assignment. Subreciplent shall not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the Grantee and CDFA, and any attempted assignment or transfer shall be ineffective, null, void, and of no effect.
- 13.4 <u>Amendments</u>. No amendment or modification of any provision of this Agreement shall be effective unless it is in writing and executed by both parties and approved by CDFA.
- 13.5 <u>Maintenance of Project</u>. Subrecipient shall maintain, keep, and preserve in good working order and condition all of its property and assets necessary or useful in the proper conduct of its business and operation of the Project. This shall include all property improvements made as a result of this Project, if applicable.
- 13.6 Governing Law. The Subrecipient Agreement shall be governed by and construed in accordance with laws of the State of New Hampshire.

13.7 Publicity and Signage.

13.7.1 <u>Public Relations</u>. The Subrecipient shall grant CDFA the right to use the Subrecipient's name, likeness, and logo in any public relations or publicity efforts. This shall include, but no be limited to,

press releases, media interviews, website, publications, brochures, etc. CDFA's publicity efforts may also include details about Grantee's project, contract, or other publicly available information.

- 13.7.2 <u>Reciprocal Publicity</u>. The Subrecipient also shall acknowledge CDFA appropriately in all organizational and public forums as to the support, financial and otherwise, that has been provided to the project. This recognition shall include, but not be limited to, print/electronic media, publications, interviews, brochures, website, etc.
- 13.7.3 <u>Project Signage</u>. For construction/renovation projects CDFA logo must be included in signage at the job worksite. CDFA logo may not be any smaller that 50% of the size of the largest logo displayed. This requirement can be waived if no other partner/entity requires worksite signage and creating signage solely for CDFA poses a hardship. Alternative If none of these are applicable/feasible, an alternative display of the CDFA logo or public recognition must be approved by CDFA.



ATTACHMENT II-B

SUBRECIPIENT AGREEMENT MINIMUM TERMS AND CONDITIONS

The County of Grafton ("Grantee") hereby warrants and agrees that the Subrecipient Agreement with the Grafton Regional Development Corporation (GRDC) ("Subrecipient") to be executed in conformance with the requirements of Exhibit B of the Grant Agreement shall be subject to approval by CDFA. The Subrecipient Agreement shall incorporate the entire Grant Agreement and shall include it as an attachment, and shall contain at a minimum the following terms and conditions:

REPRESENTATION AND WARRANTIES.

Grafton Regional Development Corporation (GRDC) ("Subrecipient") shall represent and warrant:

- 1.1 Subrecipient is a duly organized and validly existing New Hampshire nonprofit corporation in good standing under the laws of this State. Subrecipient has the power and authority to undertake the grant activities as provided in the Grant Agreement. Subrecipient has the power and authority to own its properties, to conduct business as it is now being conducted, has the power to execute and deliver and perform its obligation under the Subrecipient Agreement and all other documents as applicable to this grant agreement.
- 1.2 The Subrecipient Agreement is the legal, valid and binding obligation of Subrecipient enforceable against Subrecipient, in accordance with each document's respective terms.
- 1.3 Subrecipient has compiled in all material respects with all applicable federal, state and local laws, statutes, rules and regulations pertaining to the grant activities.
- 1.4 No application, exhibit, schedule, report or other written information provided by Subreciplent or its agents in connection with the grant application knowingly contained, when made, any material misstatement of fact or knowingly omitted to state any material fact necessary to make the statements contained therein not misleading, in light of the circumstances under which they were made.

2. PROJECT DESCRIPTION AND SUBGRANT ACTIVITIES.

2.1 <u>Project Description</u>. This project shall consist of the awarding of \$132,000 in Community Development Block Grant (CDBG) funds to the Grantee. The Grantee will retain \$12,000 of the grant for administrative costs associated with management of the grant and subgrant \$120,000 to the Subrecipient via this Subrecipient Agreement.

The Subrecipient's commitment is to work in partnership with the Coos Economic Development Corporation (CEDC) to increase the income and economic stability of qualifying microenterprises by helping them to access technical assistance (TA), training, capital, and expanded market opportunities. Sub-granted funds will be used by the Subrecipient and its partner to deliver Microenterprise Program services and support in the following program categories:

2.1.1 TA and Training – Subreciplent will provide technical assistance and training programs to a minimum of 25 low- and moderate-income microenterprises, primarily in Coos and Grafton Counties, with 100% of persons served being of low- and moderate-income status (LMI), at a pro-rata cost of \$2,500 for each qualifying and enrolled LMI beneficiary.

Subreciplent may request an additional \$2,500 per enrolled, credit-worthy microenterprise beneficiary to cover loan processing costs for loans provided by Subrecipient, or by CEDC upon referral by Subrecipient.

- 2.1.2 <u>Direct Grants</u> Subrecipient will provide direct grants of up to \$5,000 to a minimum of three (3) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Direct grants may be used for purchase of equipment/machinery or capital improvements directly related to operation or expansion of the qualifying microenterprise. Each qualifying microenterprise may receive one direct grant of no more than \$5,000 during the Grant Period.
- 2.1.2 <u>Down Payment Assistance Grants</u> Subrecipient will provide down payment assistance grants of up to \$10,000 to a minimum of two (2) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Down payment assistance grants may be used to support purchase of commercial property/real estate that is directly related to the affected business. Each qualifying microenterprise may receive one down payment assistance grant of no more than \$10,000 during the Grant Period.
- 2.1.3 <u>Program Activity Costs</u> Subrecipient may request up to 20% of TA/Training, Direct Grant and Down Payment Assistance funds to cover costs incurred by the Subrecipient to manage and deliver the Microenterprise program, not to exceed a total of \$20,000 during the Grant Period.

3. SUBRECIPIENT REQUIREMENTS.

- 3.1 <u>Performance Requirements</u>. The Grantee shall enter into an agreement with Subrecipient in order to satisfy the project purpose, which is technical assistance and training for 25 beneficiaries; direct grants for three (3) beneficiaries; and down payment assistance for two (2) beneficiaries, of which one hundred percent (100%) will be LMI persons, as set forth in Exhibit B.
- 3.2 Security. Not Applicable to this Award.
- 3.3 <u>Compliance with Laws</u>. Subrecipient shall comply with all applicable federal, state, and local taws, statutes, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 3.4 <u>Disbursement of Grant Funds</u>. Upon compliance with, and subject to the provisions of this Agreement and provided there shall exist no Event of Default under this Agreement, the Grant Agreement or any other agreements, in connection with the Project, and no condition or event which, with the giving of notice or lapse of time would constitute such an Event of Default, the Grantee shall, upon submittal of written requests for payment accompanied by invoices and other documentation or supporting documents as required by the Grantee, make disbursements of grant funds. Disbursement of grant funds shall be in accordance with the terms of the Grant Agreement, Including Exhibit C.

Disbursement of funds by the Grantee does not constitute acceptance by the Grantee or CDFA of any item as an eligible Project cost until all Project costs have been audited and determined to be allowable costs. Upon the expiration of the Grant Agreement, or other termination of the project, Subrecipient shall transfer to the Grantee any Grant funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds.

4. MICROENTERPRISE ASSISTANCE LIMITATIONS.

Under HUD guidelines, specific to microenterprise assistance, microenterprise beneficiaries are limited to CDBG funding for a period of three (3) years. To determine compliance, the eligibility of microenterprise beneficiaries shall be reviewed and tracked; eligibility is based upon the date of their initial enrollment in programs. Enrollment is not required to be consecutive. Reassessment of LMI status is required if a Family Income Verification Form (FIVF) is more than three (3) years old. New beneficiaries are those enrolled at any time on or after July 1, 2022, or upon Governor and Council approval, through the Grant Period end

date as outlined in Section 1.7 of the General Provisions.

5. REPORTING REQUIREMENTS; ANNUAL, SEMI-ANNUAL AND CLOSEOUT AGREEMENTS.

- 5.1 The reporting period shall begin on July 1, 2022 and end on the Completion Date specified in Section 1.7 of the General Provisions of the contract between the Grantee and CDFA. Semi-annual reports shall be submitted by the Subrecipient to the Grantee no later than January 10th, for the period of July 1, 2022 through December 31, 2022; and no later than July 10th, for the period of January 1, 2023 through June 30, 2023. Grantee shall submit these reports to CDFA by January 15th and July 15th.
- 5.2 Subrecipient Reporting to Grantee. The Subrecipient, in compliance with this Subrecipient Agreement, is required to submit technical assistance and training applicant information to the Grantee and CDFA as set forth in Section 6.
- 5.3 Closeout Agreement. Subrecipient shall enter into a Closeout Agreement with the Grantee and CDFA, which shall specify the reporting and other requirements applicable to the closing out of this Project.
- 5.4 Annual Subrecipient Financial Reporting. Subrecipient shall submit to the Grantee and to CDFA its annual audited financial statements, within 90 days of its fiscal year end.
- 5.6 All Reporting shall be submitted via CDFA's Grants Management System (GMS).

INITIAL SUBRECIPIENT DOCUMENTATION AND SPECIFIC REPORTING REQUIREMENTS.

- 6.1 In order to determine beneficiary eligibility and to comply with HUD's beneficiary enrollment limit of three years (described in Section 4), at the start of the program year, Subrecipient shall prepare a baseline report that includes a complete list of existing beneficiary microenterprises enrolled in that Subrecipient's training and technical assistance programs as of June 30, 2022, using the Microenterprise Beneficiary Tracking sheet, as set forth in Attachment IV. Data for the baseline report shall include information regarding each beneficiary, as set forth in the FIVF, provided on Attachment III; the Subrecipient's beneficiary intake form; and other relevant sources.
- 6.2 On a quarterty basis, Subrecipient shall submit a claim request for all Technical Assistance/Training beneficiaries served in the previous quarter, at a rate of \$2,500 per qualifying beneficiary. Each quarterty claim shall include a completed Microenterprise Beneficiary Tracking sheet with information regarding each beneficiary served during that quarter, as set forth in Attachment IV. The tracking sheet will be used to record beneficiary information for each calendar quarter of the program year (July September, October December, January March, and April June). Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Beneficiary Tracking Sheet and no other version.
- 6.3 At the end of the program year, Subrecipient shall prepare a final report which includes the Microenterprise Beneficiary Tracking Sheet for the entire program year, as well as the following information for each Technical Assistance/Training beneficiary:
 - (a) Subrecipient's Beneficiary Intake Form;
 - (b) FIVF, signed by all participants; the FIVF documents family income status and the designation of beneficiary minority or protected class status;
 - (c) Income changes as well as notable successes for its beneficiaries as a result of their participation. In Subrecipient's programs; and
 - (d A list of beneficiaries that received loans during the program year.

The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.

6.4 In addition to the quarterly claims described in Section 6.2, Subreciplent may submit additional claim requests for Direct Grant and/or Down Payment Assistance Grant support for qualifying benefit alter. Each

claim shall include a completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet with information regarding each beneficiary to be served pursuant to the claim, as set forth in Attachment VI. Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Tracking Sheet and no other version. Claims for Direct Grant and Down Payment Assistance Grant support may be submitted at any time throughout the Grant Period.

- 6.5 At the end of the program year, Subrecipient shall prepare a final report which includes the completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet for all qualifying beneficiaries that received direct grants and/or loans during the entire program year and a narrative describing the how the direct grant and/or loan programs were administered, issues and challenges and information that could improve future program implementation. The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.
- 6.6 All documentation shall be submitted via CDFA's Grants Management System (GMS).

7. TRAINING AND JOB CREATION/RETENTION BENEFIT TO PERSONS FROM LOW- AND MODERATE-INCOME HOUSEHOLDS.

The general purpose of the project is to principally benefit Low- and Moderate-Income persons as that term is defined in 24 CFR 570.483 and CDFA's implementation Guide.

The Grantee and Subrecipient agree that the primary purpose of the Project is to provide training and technical assistance to at least twenty-five (25) microenterprise beneficiaries; direct grants to at least three (3) microenterprise beneficiaries; and down payment assistance grants to at least two (2) beneficiaries. Of the beneficiaries served, one-hundred percent (100%) shall be persons from low- and moderate-income households, using the income limits as described above, and as provided in Attachment III, "Family income Verification Form". Subrecipient agrees to maintain and provide documentation that it has complied with the income limits requirement using FIVFs provided by the Grantee.

8. GRANT OF FUNDS/MATCHING FUNDS.

- 8.1 Subreciplent shall use the Grant funds sub-granted to it solely for the purposes described herein and consistent with the required terms and conditions of the Grant Agreement and Subreciplent Agreement.
- 8.2 No other funds are required by the Subrecipient to match the Grant funds to be used for TA/Training, Direct Grants, Down Payment Assistance Grants and Program Activity Costs, pursuant to this Agreement and in connection with this Grant Project.

SCHEDULE AND GRANT COMPLETION.

- 9.1 <u>Implementation Schedule</u>. The Grantee and Subrecipient have agreed to an Implementation Schedule, which will provide for the completion of all grant activities, prior to the Grant Completion Date. A schedule of major milestones shall be provided within the Subrecipient Agreement, and shall serve as a basis for enforcement of the Agreement.
- 9.2 <u>Grant Completion Date</u>. All work shall be completed prior to the Grant Completion Date as outlined in Section 1.7 of the General Provisions. All employment commitments shall be accomplished by that date. This date may be extended only with the permission of the Grantee, CDFA, and the Governor and Council.
- 9.3 <u>Project Delays</u>. Should the Project encounter delays relating to financing, construction or other events that may affect the Subrecipient' ability to serve the number of beneficiaries identified in Section 7 within the specified Grant Completion Date, the Subrecipient and Grantee shall submit a written request for a time extension to CDFA, describing the reason for delay. Grant completion time extension requests shall then be forwarded to Governor and Council for final approval.

10. INSURANCE AND TAXES

10.1 <u>Subreciplent's Liability Insurance</u>. Subreciplent shall, at its sole expense, obtain and maintain in force insurance in such amounts and covering such risks as are customary for entities engaged in the same or similar business to include, where applicable, comprehensive general liability covering any property development/construction activities and landlord insurance and workers compensation insurance. At a minimum, this shall include insurance against all claims of bodily injury or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate and as further set forth in the General Provisions.

All policies shall name the Grantee and CDFA as additional insureds. Subrecipient shall provide the Grantee with certificates of insurance satisfactory to the Grantee, which evidences compliance with this Section.

- 10.2 <u>Insurance Standards</u>. The policies described in this section shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. All policies shall be on an "occurrence" basis. Each policy shall contain a clause prohibiting cancellation or modification of the policy earlier than thirty (30) days after written notice thereof has been received by the Grantee and CDFA.
- 10.3 <u>Taxes</u>. If applicable, Subrecipient shall pay all taxes, assessments, charges, fines and impositions attributable to the Property, which is the responsibility of the Subrecipient. Any alternative arrangements will require the approval of CDFA, whose consideration will not be unreasonably withheld.

11. ACCOUNTING, AUDIT, AND RECORD KEEPING REQUIREMENTS.

- 11.1 Accounting Records. Subrecipient shall keep all Project-related accounts and records, which fully disclose the amount and disposition by Subrecipient of the grant funds, the total cost of the Project, and the amount and nature of any portion of the Project cost supplied by other sources, and such other financial records pertinent to the Project. Accounts and records shall be kept in accordance with an accounting system that will facilitate an effective audit in accordance with the Single Audit Act of 1984. Records to be maintained shall include Project fiscal records consisting of all books, documents, ledgers, systems and expenses incurred, including, but not limited to, purchase, requisitions, orders, invoices, vouchers, bills and receipts, inventories, and all lien documents.
- 11.2 <u>Time Period</u>. All of the records, documents, and data described above and all income verification information shall be kept during the performance of the project, and for three (3) years after its completion or until the satisfactory completion of an audit, whichever is later.
- 11.3 <u>Availability of Records</u>. Subrecipient shall make available to the Grantee, CDFA, and HUD or any of their duly authorized representatives, for the purpose of audit and examination, any books, documents, papers, and records of Subrecipient pertinent to this Agreement.

12. <u>INDEMNIFICATION</u>.

Subrecipient shall defend, indemnify and hold harmless the Grantee, the State of New Hampshire, and the CDFA, their officers and employees, from and against any and all losses suffered by the Grantee, the State, or CDFA, their officers or employees, and any and all claims, liabilities or penalties asserted against the Grantee, the State or CDFA, their officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of or claimed to Subrecipient out of the acts or omissions of Subrecipient.

Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State or the Grantee, which immunity is hereby reserved to the State-and the

Grantee. This covenant shall survive the termination or expiration of this Agreement.

13. MAINTENANCE OF CORPORATE EXISTENCE.

- 13.1 <u>Corporate Existence</u>. Subrecipient shall both preserve and maintain the legal existence and good standing of its nonprofit corporation status and its registration in New Hampshire as required to do business.
- 13.2 Scope of Mission. Subreciplent and Grantee agree that the Subrecipient's Articles of Incorporation and Corporate Bylaws ("Bylaws") as submitted with the Project application and incorporated herein by reference, provide an adequate administrative mechanism for assuring the Subrecipient's mission of providing training and technical assistance opportunities for low- and moderate-income persons, during the Grant Perlod, as required pursuant to this agreement.

14. EVENTS OF DEFAULT.

The occurrence of any of the following events shall constitute an Event of Default under this Agreement:

- (a) Any Event of Default by Subrecipient under the Grant Agreement, and related documents including, but not limited to, the fallure of the Subrecipient to accomplish the required training and technical assistance benefit to low- and moderate-income persons;
- (b) The Subrecipient's failure to comply with the reporting requirements as specified herein;
- (c) Subreciplent attempts to assign its rights under this Agreement or any advance made or to be made hereunder or any interest therein, without the prior written consent of the Grantee;
- (d) Any representation or warranty made herein or in any report, certification, or other instrument furnished in connection with this Agreement or any advances of Grant funds made hereunder, by or in behalf of Subrecipient, shall prove to be false or misleading in any material respect;
- (e) Any mechanics', laborers', materialmen's or similar statutory liens, or any notice thereof, shall be filed against the Property and/or the Project and shall not be discharged within thirty (30) days of such filing;
- (f) Subrecipient shall default in the due observance or performance of any covenant, condition, assurance or agreement to be observed or performed by Subrecipient under this Agreement;
- (g) Subrecipient shall (i) apply for or consent to the appointment of a receiver, trustee, or liquidator of it or any of its property, (ii) admit in writing its inability to pay its debts as they mature, (iii) make a general assignment for the benefit of creditors, (iv) be adjudicated as bankrupt or insolvent or (v) file a voluntary petition in bankruptcy, or a petition or answer seeking reorganization or an arrangement with creditors or to take advantage of any bankruptcy, reorganization, arrangement, insolvency, readjustment of debt, dissolution or liquidation law or statute, or an answer admitting the material allegations of a petition filed against it in any proceeding under any such law;
- (h) A petition, order, judgment, or decree shall be entered, without the application, approval or consent of Subrecipient by any court of competent jurisdiction, approving a petition seeking reorganization or approving the appointment of a receiver, trustee or liquidator of Subrecipient of all or a substantial part of its assets, and such order judgment or decree shall continue unstayed and in effect for any period of thirty (30) days;
- (i) The dissolution, termination of existence, merger or consolidation of Subrecipient or a sale of assets of Subrecipient out of the ordinary course of business without the prior written consequent the Grantee

and CDFA; and

- (j) Failure to remedy an ineligible expenditure of grant funds or to reimburse the Grantee for any ineligible costs, which are paid from grant funds.
- (k) In the event that the Subrecipient fails to serve the minimum number of Low- and Moderate-Income beneficiaries, as provided in this Agreement, then the Subrecipient shall confer forthwith with the Grantee and CDFA to develop a mutually acceptable plan pursuant to which it will rectify any reporting shortfalls and maintain the required minimums. In such event, the Subrecipient shall also provide Grantee with monthly updates containing information in a form reasonably satisfactory to the Grantee, in order for the Grantee and Subrecipient to determine whether it is in compliance with such plan and its obligations as provided herein. Said monthly reports to continue until the beneficiary commitments are achieved.
- (i) The continued failure of the Subrecipient to achieve its beneficiary commitments as required herein for ninety (90) days following the date specified for such requirement shall constitute an event of default, which may give rise to any of the remedies available to the Grantee, as set forth therein.

15. GRANTEE'S RIGHTS AND REMEDIES UPON DEFAULT.

- 15.1 <u>Remedies upon Default.</u> Upon the occurrence of any Event of Default, the Grantee may take any one, or more, or all, of the actions described below. Prior to taking any of the following actions, the Grantee will give Subrecipient a written notice of default specifying the Event of Default and requiring it to be remedied within thirty (30) days from the date of notice. The following actions may be taken only if Subrecipient has not remedied the Event of Default in a timely manner.
- (a) Terminate this Agreement, effective immediately upon giving notice of termination;
- (b) Suspend all payment of grant funds to be made pursuant to this Agreement until such time as the Grantee determines the Event of Default has been cured;
- (c) Set off against any other obligations the Grantee may owe to Subreciplent for any damages the Grantee may suffer by reason of any Event of Default;
- (d) Treat the Agreement as breached and pursue any of its remedies at law or in equity or both;
- (e) Foreclose under any available security instrument created under this agreement; and
- (f) Assume the right to seek full reimbursement of CDBG funds from the Subreciplent and the right to call on any collateral pledged under the loan with the Subrecipient.
- 15.2 <u>Judicial Enforcement</u>. Subrecipient agrees that the Grantee and CDFA have a right to seek judicial enforcement with regard to any matter arising with respect to this Agreement, to include the assurances, covenants and other conditions, which extend beyond the completion date under this Agreement.
- 15.3 <u>Disposition of Funds</u>. Where the Grant Agreement or Subrecipient Agreement is terminated or the Project is otherwise terminated due to a default, inability to perform or reasons other than project completion, Grant funds are required to be returned. The disposition of Grant Funds to be returned shall be determined solely by CDFA.

16. ADDITIONAL REPRESENTATIONS AND WARRANTIES. Subrecipient represents and warrants:

(a) Subrecipient will obtain all necessary approvals and all necessary permits for the operation of its

business from all governmental authorities having jurisdiction.

- (b) No litigation, claims, suits, orders, investigations or proceedings are pending or threatened against Subreciplent or affecting the Property or the Project at law or in equity or before or by any federal, state, municipal or other governmental instrumentality; there are no arbitration proceedings pending under collective bargaining agreements or otherwise; and to the knowledge of Subreciplent, there is no basis for any of the foregoing. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.
- (c) Subrecipient has filed all federal, state and local tax returns required to be filed and has paid or made adequate provision for the payment of all federal, state or local taxes, charges and assessments, if applicable.
- (d) The execution and delivery and performance by Subrecipient of its obligations under this Agreement have been duly authorized by all requisite corporate action and will not violate any provision of law, any order of any court or other agency of government, or any indenture, agreement or other instrument to which Subrecipient is a party, or by which it is bound, or be in conflict with, result in a breach of, or constitute a default under, or except as may be provided in this Agreement, result in the creation or imposition of any lien, charge or encumbrance of any nature whatsoever upon any of the property or assets of Subrecipient pursuant to any such indenture, agreement or instrument. Subrecipient is not required to obtain any consent, approval or authorization from, or to file any declaration or statement with, any governmental instrumentality or other agency in connection with or as a condition to the execution, delivery or performance of this Agreement and all other related documents.
- (e) Subrecipient is not contemplating either the filing of a petition under any state or federal bankruptcy or insolvency laws or the liquidating of all or a major portion of its properties and has no knowledge of any person contemplating the filing of any such petition against it.
- (f) No statement of fact made by or on behalf of Subrecipient in any of the agreement or related documents or in any certificate, exhibit or schedule furnished to the Grantee pursuant thereto, contains any untrue statement of a material fact or omits to state any material fact necessary to make statements contained therein or herein not misleading. There is no fact or circumstance presently known to Subrecipient that has not been disclosed to the Grantee that materially affects adversely, nor as far as Subrecipient can foresee, will materially affect adversely Subrecipient, operations or considerations (financial or otherwise) of Subrecipient.
- (g) No Event of Default has occurred and is continuing under this Agreement and no event or condition which would, upon notice of expiration of any applicable cure, constitute an Event of Default has occurred and is continuing; Subrecipient is not in default under any note or other evidence of indebtedness or other obligation for borrowed money or any mortgage, deed to trust, indenture, lease agreement or other agreement relating thereto. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.

Subrecipient warrants that each of the foregoing representations and warranties is true and correct as of the date of this Agreement and Subrecipient shall indemnify and hold harmless the Grantee, the State and CDFA from and against any loss, damage, or liability attributable to the breach thereof, including any and all fees and expenses incurred in the defense or settlement of any claim arising therefrom against the Grantee, State or CDFA.

13. MISCELLANEOUS PROVISIONS.

13.1 Compliance with Laws. Subrecipient shall comply with all applicable federal, state and local laws, statutes, regulation, executive orders and rules as they relate to the application, acceptance and use

of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.

- 13.2 Compfiance with OMB 2 Part 200. Subreciplent acknowledges that it shall meet the requirements of OMB 2 Part 200, to ensure compliance with Administrative Cost Standards.
- 13.3 No assignment. Subrecipient shall not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the Grantee and CDFA, and any attempted assignment or transfer shall be ineffective, null, vold, and of no effect.
- 13.4 <u>Amendments</u>. No amendment or modification of any provision of this Agreement shall be effective unless it is in writing and executed by both parties and approved by CDFA.
- 13.5 <u>Maintenance of Project</u>. Subrecipient shall maintain, keep, and preserve in good working order and condition all of its property and assets necessary or useful in the proper conduct of its business and operation of the Project. This shall include all property improvements made as a result of this Project, if applicable.
- 13.6 Governing Law. The Subrecipient Agreement shall be governed by and construed in accordance with laws of the State of New Hampshire.
- 13.7 Publicity and Signage.
 - 13.7.1 <u>Public Relations</u>. The Subrecipient shall grant CDFA the right to use the Subrecipient's name, likeness, and logo in any public relations or publicity efforts. This shall include, but not be limited to, press releases, media interviews, website, publications, brochures, etc. CDFA's publicity efforts may also include details about Grantee's project, contract, or other publicly available information.
 - 13.7.2 <u>Reciprocal Publicity</u>. The Subrecipient also shall acknowledge CDFA appropriately in all organizational and public forums as to the support, financial and otherwise, that has been provided to the project. This recognition shall include, but not be limited to, print/electronic media, publications, interviews, brochures, website, etc.
 - 13.7.3 <u>Project Signage</u>. For construction/renovation projects CDFA logo must be included in signage at the job worksite. CDFA logo may not be any smaller that 50% of the size of the largest logo displayed. This requirement can be waived if no other partner/entity requires worksite signage and creating signage solely for CDFA poses a hardship. Alternative If none of these are applicable/feasible, an alternative display of the CDFA logo or public recognition must be approved by CDFA.

SUBRECIPIENT AGREEMENT MINIMUM TERMS AND CONDITIONS

The County of Grafton ("Grantee") hereby warrants and agrees that the Subrecipient Agreement with the North Country Investment Corporation (NCIC) ("Subrecipient") to be executed in conformance with the requirements of Exhibit B of the Grant Agreement shall be subject to approval by CDFA. The Subrecipient Agreement shall incorporate the entire Grant Agreement and shall include it as an attachment, and shall contain at a minimum the following terms and conditions:

REPRESENTATION AND WARRANTIES.

North Country Investment Corporation (NCIC) ("Subrecipient") shall represent and warrant:

- 1.1 Subrecipient is a duly organized and validiy existing New Hampshire nonprofit corporation in good standing under the laws of this State. Subrecipient has the power and authority to undertake the grant activities as provided in the Grant Agreement. Subrecipient has the power and authority to own its properties, to conduct business as it is now being conducted, has the power to execute and deliver and perform its obligation under the Subrecipient Agreement and all other documents as applicable to this grant agreement.
- 1.2 The Subrecipient Agreement is the legal, valid and binding obligation of Subrecipient enforceable against Subrecipient, in accordance with each document's respective terms.
- 1.3 Subrecipient has complied in all material respects with all applicable federal, state and local laws, statutes, rules and regulations pertaining to the grant activities.
- 1.4 No application, exhibit, schedule, report or other written information provided by Subrecipient or its agents in connection with the grant application knowingly contained, when made, any material misstatement of fact or knowingly omitted to state any material fact necessary to make the statements contained therein not misleading, in light of the circumstances under which they were made.

2. PROJECT DESCRIPTION AND SUBGRANT ACTIVITIES.

2.1 <u>Project Description</u>. This project shall consist of the awarding of \$81,500 in Community Development Block Grant (CDBG) funds to the Grantee. The Grantee will retain \$9,000 of the grant for administrative costs associated with management of the grant and subgrant \$72,500 to the Subrecipient via this Subrecipient Agreement.

The Subrecipient's commitment is to work to increase the income and economic stability of qualifying microenterprises by helping them to access technical assistance (TA), training, capital, and expanded market opportunities. Sub-granted funds will be used by the Subrecipient to deliver Microenterprise Program services and support in the following program categories:

2.1.1 TA and Training – Subrecipient will provide technical assistance and training programs to a minimum of 25 low- and moderate-income microenterprises, primarily in Carroll, Coos and Grafton Countles, with 100% of persons served being of low- and moderate-income status (LMI), at a pro-rate cost of \$2,500 for each qualifying and enrolled LMI beneficiary.

Subrecipient may request an additional \$2,500 per enrolled, credit-worthy microenterprise beneficiary to cover loan processing costs for micro-loans provided by Subrecipient, or by a qualified micro-loan partner upon referral by Subrecipient.

2.1.2 <u>Direct Grants</u> – Subrecipient will provide direct grants of up to \$5,000 to a minimum of two (2) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Direct grants may be used for purchase of equipment/machinery or capital improvements directly related to operation or expansion of the qualifying microenterprise. Each qualifying microenterprise may receive one direct grant of no more than \$5,000 during the Grant Period.

3. SUBRECIPIENT REQUIREMENTS.

- 3.1 <u>Performance Requirements</u>. The Grantee shall enter into an agreement with Subrecipient in order to satisfy the project purpose, which is technical assistance and training for 25 beneficiaries and direct grants for two (2) beneficiaries, of which one hundred percent (100%) will be LMI persons, as set forth in Exhibit B.
- 3.2 Security. Not Applicable to this Award.
- 3.3 <u>Compliance with Laws</u>. Subrecipient shall comply with all applicable federal, state, and local laws, statutes, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 3.4 <u>Disbursement of Grant Funds</u>. Upon compliance with, and subject to the provisions of this Agreement and provided there shall exist no Event of Default under this Agreement, the Grant Agreement or any other agreements, in connection with the Project, and no condition or event which, with the giving of notice or lapse of time would constitute such an Event of Default, the Grantee shall, upon submittal of written requests for payment accompanied by invoices and other documentation or supporting documents as required by the Grantee, make disbursements of grant funds. Disbursement of grant funds shall be in accordance with the terms of the Grant Agreement, Including Exhibit C.

Disbursement of funds by the Grantee does not constitute acceptance by the Grantee or CDFA of any Item as an eligible Project cost until all Project costs have been audited and determined to be allowable costs. Upon the expiration of the Grant Agreement, or other termination of the project, Subrecipient shall transfer to the Grantee any Grant funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds.

4. MICROENTERPRISE ASSISTANCE LIMITATIONS.

Under HUD guidelines, specific to microenterprise assistance, microenterprise beneficiarles are limited to CDBG funding for a period of three (3) years. To determine compliance, the eligibility of microenterprise beneficiarles shall be reviewed and tracked; eligibility is based upon the date of their initial enrollment in programs. Enrollment is not required to be consecutive. Reassessment of LMI status is required if a Family Income Verification Form (FIVF) is more than three (3) years old. New beneficiaries are those enrolled at any time on or after July 1, 2022, or upon Governor and Council approval, through the Grant Period end date as outlined in Section 1.7 of the General Provisions.

5. REPORTING REQUIREMENTS: ANNUAL, SEMI-ANNUAL AND CLOSEOUT AGREEMENTS.

- 5.1 The reporting period shall begin on July 1, 2022 and end on the Completion Date specified in Section 1.7 of the General Provisions of the contract between the Grantee and CDFA. Semi-annual reports shall be submitted by the Subrecipient to the Grantee no later than January 10th, for the period of July 1, 2022 through December 31, 2022; and no later than July 10th, for the period of January 1, 2023 through June 30, 2023. Grantee shall submit these reports to CDFA by January 15th and July 15th.
- 5.2 Subrecipient Reporting to Grantee. The Subrecipient, in compilance with this Subrecipient Agreement, is required to submit technical assistance and training applicant information to the Grantee and CDFA as set forth in Section 6.

- 5.3 Closeout Agreement. Subrecipient shall enter into a Closeout Agreement with the Grantee and CDFA, which shall specify the reporting and other requirements applicable to the closing out of this Project.
- 5.4 Annual Subrecipient Financial Reporting. Subrecipient shall submit to the Grantee and to CDFA its annual audited financial statements, within 90 days of its fiscal year end.
- 5.6 All Reporting shall be submitted via CDFA's Grants Management System (GMS).

6. <u>INITIAL SUBRECIPIENT DOCUMENTATION AND SPECIFIC REPORTING REQUIREMENTS.</u>

- 6.1 In order to determine beneficiary eligibility and to comply with HUD's beneficiary enrollment limit of three years (described in Section 4), at the start of the program year, Subrecipient shall prepare a baseline report that includes a complete list of existing beneficiary microenterprises enrolled in that Subrecipient's training and technical assistance programs as of June 30, 2022, using the Microenterprise Beneficiary Tracking sheet, as set forth in Attachment IV. Data for the baseline report shall include information regarding each beneficiary, as set forth in the FIVF, provided on Attachment III; the Subrecipient's beneficiary intake form; and other relevant sources.
- 6.2 On a quarterly basis, Subrecipient shall submit a claim request for all Technical Assistance/Training beneficiaries served in the previous quarter, at a rate of \$2,500 per qualifying beneficiary. Each quarterly claim shall include a completed Microenterprise Beneficiary Tracking sheet with Information regarding each beneficiary served during that quarter, as set forth in Attachment VI. The tracking sheet will be used to record beneficiary information for each calendar quarter of the program year (July September, October December, January March, and April June). Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Beneficiary Tracking Sheet and no other version.
- 6.3 At the end of the program year, Subrecipient shall prepare a final report which includes the Microenterprise Beneficiary Tracking Sheet for the entire program year, as well as the following Information for each Technical Assistance/Training beneficiary:
 - (a) Subreciplent's Beneficiary Intake Form:
 - (b) FIVF, signed by all participants; the FIVF documents family income status and the designation of beneficiary minority or protected class status;
 - (c) Income changes as well as notable successes for its beneficiaries as a result of their participation in Subrecipient's programs; and
 - (d A list of beneficiaries that received loans during the program year.

The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.

- 6.4 In addition to the quarterly claims described in Section 6.2, Subrecipient may submit additional claim requests for Direct Grants for qualifying beneficiaries. Each claim shall include a completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet with information regarding each beneficiary to be served pursuant to the claim, as set forth in Attachment VI. Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Tracking Sheet and no other version. Claims for Direct Grant support may be submitted at any time throughout the Grant Period.
- 6.5 At the end of the program year, Subrecipient shall prepare a final report which includes the completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet for all qualifying beneficiaries that received direct grants during the entire program year and a narrative describing the how the direct grant program was administered, issues and challenges and information that could improve future program implementation. The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.

6.6 All documentation shall be submitted via CDFA's Grants Management System (GMS),

7. TRAINING AND JOB CREATION/RETENTION BENEFIT TO PERSONS FROM LOW- AND MODERATE-INCOME HOUSEHOLDS.

The general purpose of the project is to principally benefit Low- and Moderate-income persons as that term is defined in 24 CFR 570,483 and CDFA's implementation Guide.

The Grantee end Subrecipient egree that the primary purpose of the Project is to provide training and technical assistance to at least twenty-five (25) microenterprise beneficiaries and direct grants to at least two (2) microenterprise beneficiaries. Of the beneficiaries served, one-hundred percent (100%) shall be persons from low- and moderate-income households, using the income limits as described above, and as provided in Attachment III, "Family Income Verification Form". Subrecipient agrees to maintain and provide documentation that it has compiled with the income limits requirement using FIVFs provided by the Grantee.

8. GRANT OF FUNDS/MATCHING FUNDS.

- 8.1 Subreciplent shall use the Grant funds sub-granted to it solely for the purposes described herein and consistent with the required terms and conditions of the Grant Agreement and Subreciplent Agreement.
- 8.2 No other funds are required by the Subrecipient to match the Grant funds to be used for TA/Training or Direct Grants, pursuant to this Agreement and in connection with this Grant Project.

9. SCHEDULE AND GRANT COMPLETION.

- 9.1 <u>Implementation Schedule.</u> The Grantee and Subrecipient have agreed to an Implementation Schedule, which will provide for the completion of all grant activities, prior to the Grant Completion Date. A schedule of major milestones shall be provided within the Subrecipient Agreement, and shall serve as a basis for enforcement of the Agreement.
- 9.2 <u>Grant Completion Date</u>. All work shall be completed prior to the Grant Completion Date as outlined in Section 1.7 of the General Provisions. All employment commitments shall be accomplished by that date. This date may be extended only with the permission of the Grantee, CDFA, and the Governor and Council.
- 9.3 <u>Project Delays</u>. Should the Project encounter delays relating to financing, construction or other events that may affect the Subrecipient' ability to serve the number of beneficiaries identified in Section 7 within the specified Grant Completion Date, the Subrecipient and Grantee shall submit a written request for a time extension to CDFA, describing the reason for delay. Grant completion time extension requests shall then be forwarded to Governor and Council for final approval.

10. INSURANCE AND TAXES

10.1 <u>Subrecipient's Liability Insurance</u>. Subrecipient shall, at its sole expense, obtain and maintain in force insurance in such amounts and covering such risks as are customary for entities engaged in the same or similar business to include, where applicable, comprehensive general liability covering any property development/construction activities and landlord insurance and workers compensation insurance. At a minimum, this shall include insurance against all claims of bodily injury or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate and as further set forth in the General Provisions.

All policies shall name the Grantee and CDFA as additional insureds. Subrecipient shall provide the Grantee with certificates of insurance satisfactory to the Grantee, which evidences compliance with this Section.

10.2 <u>Insurance Standards</u>. The policies described in this section shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business

in the State of New Hampshire. All policies shall be on an "occurrence" basis. Each policy shall contain a clause prohibiting cancellation or modification of the policy earlier than thirty (30) days after written notice thereof has been received by the Grantee and CDFA.

10.3 <u>Taxes</u>. If applicable, Subrecipient shall pay all taxes, assessments, charges, fines and impositions attributable to the Property, which is the responsibility of the Subrecipient. Any alternative arrangements will require the approval of CDFA, whose consideration will not be unreasonably withheld.

11. ACCOUNTING, AUDIT, AND RECORD KEEPING REQUIREMENTS.

- 11.1 Accounting Records. Subrecipient shall keep all Project-related accounts and records, which fully disclose the amount and disposition by Subrecipient of the grant funds, the total cost of the Project, and the amount and nature of any portion of the Project cost supplied by other sources, and such other financial records pertinent to the Project. Accounts and records shall be kept in accordance with an accounting system that will facilitate an effective audit in accordance with the Single Audit Act of 1984. Records to be maintained shall include Project fiscal records consisting of all books, documents, ledgers, systems and expenses incurred, including, but not limited to, purchase, requisitions, orders, invoices, vouchers, bills and receipts, inventories, and all lien documents.
- 11.2 <u>Time Period</u>. All of the records, documents, and data described above and all income verification information shall be kept during the performance of the project, and for three (3) years after its completion or until the satisfactory completion of an audit, whichever is later.
- 11.3 <u>Availability of Records</u>. Subrecipient shall make available to the Grantee, CDFA, and HUD or any of their duly authorized representatives, for the purpose of audit and examination, any books, documents, papers, and records of Subrecipient pertinent to this Agreement.

12. INDEMNIFICATION.

Subrecipient shall defend, indemnify and hold harmless the Grantee, the State of New Hampshire, and the CDFA, their officers and employees, from and against any and all losses suffered by the Grantee, the State or CDFA, their officers or employees, and any and all claims, liabilities or penalties asserted against the Grantee, the State or CDFA, their officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of or claimed to Subrecipient out of the acts or omissions of Subrecipient.

Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State or the Grantee, which immunity is hereby reserved to the State and the Grantee. This covenant shall survive the termination or expiration of this Agreement.

13. MAINTENANCE OF CORPORATE EXISTENCE.

- 13.1 <u>Corporate Existence</u>. Subrecipient shall both preserve and maintain the legal existence and good standing of its nonprofit corporation status and its registration in New Hampshire as required to do business.
- 13.2 <u>Scope of Mission</u>. Subrecipient and Grantee agree that the Subrecipient's Articles of Incorporation and Corporate Bylaws ("Bylaws") as submitted with the Project application and incorporated herein by reference, provide an adequate administrative mechanism for assuring the Subrecipient's mission of providing training and technical assistance opportunities for low- and moderate-income persons, during the Grant Period, as required pursuant to this agreement.

14. EVENTS OF DEFAULT.

The occurrence of any of the following events shall constitute an Event of Default under this Agreement:

- (a) Any Event of Default by Subrecipient under the Grant Agreement, and related documents including, but not limited to, the failure of the Subrecipient to accomplish the required training and technical assistance benefit to low- and moderate-income persons;
- (b) The Subreciplent's failure to comply with the reporting requirements as specified herein;
- (c) Subrecipient attempts to assign its rights under this Agreement or any advance made or to be made hereunder or any interest therein, without the prior written consent of the Grantee;
- (d) Any representation or warranty made herein or in any report, certification, or other instrument furnished in connection with this Agreement or any advances of Grant funds made hereunder, by or in behalf of Subreciplent, shall prove to be false or misleading in any material respect;
- (e) Any mechanics', laborers', materialmen's or similar statutory liens, or any notice thereof, shall be filed against the Property and/or the Project and shall not be discharged within thirty (30) days of such filing;
- (f) Subrecipient shall default in the due observance or performance of any covenant, condition, assurance or agreement to be observed or performed by Subrecipient under this Agreement;
- (g) Subrecipient shall (i) apply for or consent to the appointment of a receiver, trustee, or liquidator of it or any of its property, (ii) admit in writing its inability to pay its debts as they mature, (iii) make a general assignment for the benefit of creditors, (iv) be adjudicated as bankrupt or insolvent or (v) file a voluntary petition in bankruptcy, or a petition or answer seeking reorganization or an arrangement with creditors or to take advantage of any bankruptcy, reorganization, arrangement, insolvency, readjustment of debt, dissolution or liquidation law or statute, or an answer admitting the material allegations of a petition filed against it in any proceeding under any such law;
- (h) A petition, order, judgment, or decree shall be entered, without the application, approval or consent of Subrecipient by any court of competent jurisdiction, approving a petition seeking reorganization or approving the appointment of a receiver, trustee or liquidator of Subrecipient of all or a substantial part of its assets, and such order judgment or decree shall continue unstayed and in effect for any period of thirty (30) days;
- (i) The dissolution, termination of existence, merger or consolidation of Subrecipient or a sale of essets of Subrecipient out of the ordinary course of business without the prior written consent of the Grantee and CDFA; and
- (j) Failure to remedy an ineligible expenditure of grant funds or to reimburse the Grantee for any ineligible costs, which are paid from grant funds.
- (k) In the event that the Subrecipient fails to serve the minimum number of Low- and Moderate-Income beneficiaries, as provided in this Agreement, then the Subrecipient shall confer forthwith with the Grantee and CDFA to develop a mutually acceptable plan pursuant to which it will rectify any reporting shortfalls and maintain the required minimums. In such event, the Subrecipient shall also provide Grantee with monthly updates containing information in a form reasonably satisfactory to the Grantee, in order for the Grantee and Subrecipient to determine whether it is in compliance with such plan and its obligations as provided herein. Said monthly reports to continue until the beneficiary commitments are achieved.

(I) The continued failure of the Subrecipient to achieve its beneficiary commitments as required herein for ninety (90) days following the date specified for such requirement shall constitute an event of default, which may give rise to any of the remedies available to the Grantee, as set forth therein.

15. GRANTEE'S RIGHTS AND REMEDIES UPON DEFAULT.

- 15.1 Remedies upon Default. Upon the occurrence of any Event of Default, the Grantee may take any one, or more, or all, of the actions described below. Prior to taking any of the following actions, the Grantee will give Subrecipient a written notice of default specifying the Event of Default and requiring it to be remedied within thirty (30) days from the date of notice. - (d) Treat the Agreement as breached and pursue any of its remedies at law or in equity or both;
- (e) Foreclose under any available security instrument created under this agreement; and
- (f) Assume the right to seek full reimbursement of CDBG funds from the Subrecipient and the right to call on any collateral pledged under the loan with the Subrecipient.
- 15.2 <u>Judicial Enforcement</u>. Subrecipient agrees that the Grantee and CDFA have a right to seek judicial enforcement with regard to any matter arising with respect to this Agreement, to include the assurances, covenants and other conditions, which extend beyond the completion date under this Agreement.
- 15.3 <u>Disposition of Funds</u>. Where the Grant Agreement or Subrecipient Agreement is terminated or the Project is otherwise terminated due to a default, inability to perform or reasons other than project completion, Grant funds are required to be returned. The disposition of Grant Funds to be returned shall be determined solely by CDFA.

16. ADDITIONAL REPRESENTATIONS AND WARRANTIES. Subreciplent represents and warrants;

Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.
- (c) Subrecipient has filed all federal, state and local tax returns required to be filed and has paid or made adequate provision for the payment of all federal, state or local taxes, charges and assessments, if applicable.
- (d) The execution and delivery and performance by Subrecipient of its obligations under this Agreement

There is no fact or circumstance presently known to Subrecipient that has not been disclosed to the Grantee that materially affects adversely, nor as far as Subrecipient can foresee, will materially affect adversely Subrecipient, operations or considerations (financial or otherwise) of Subrecipient.
- (g) No Event of Default has occurred and is continuing under this Agreement and no event or condition which would, upon notice of expiration of any applicable cure, constitute an Event of Default has occurred and is continuing; Subrecipient is not in default under any note or other evidence of indebtedness or other obligation for borrowed money or any mortgage, deed to trust, indenture, lease agreement or other agreement relating thereto. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.

Subrecipient warrants that each of the foregoing representations and warranties is true and correct as of the date of this Agreement and Subrecipient shall indemnify and hold harmless the Grantee, the State and CDFA from and against any loss, damage, or liability attributable to the breach thereof, including any and all fees and expenses incurred in the defense or settlement of any claim arising therefrom against the Grantee, State or CDFA.

13. MISCELLANEOUS PROVISIONS.

- 13.1 Compliance with Laws. Subreciplent shall comply with all applicable federal, state and local laws, statutes, regulation, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 13.2 Compliance with OMB 2 Part 200. Subreciplent acknowledges that it shall meet the requirements of OMB 2 Part 200, to ensure compliance with Administrative Cost Standards.
- 13.3 No assignment. Subrecipient shall not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the Grantee and CDFA, and any attempted assignment or transfer shall be ineffective, null, void, and of no effect.
- 13.4 Amendments. No amendment or modification of any provision of this Agreement shall be effective unless it is in writing and executed by both parties and approved by CDFA.
- 13.5 Maintenance of Project. Subrecipient shall maintain, keep, and preserve in good working order and

SUBRECIPIENT AGREEMENT MINIMUM TERMS AND CONDITIONS

The County of Grafton ("Grantee") hereby warrants and agrees that the Subrecipient Agreement with the Women's Rural Entrepreneurial Network (WREN) ("Subrecipient") to be executed in conformance with the requirements of Exhibit B of the Grant Agreement shall be subject to approval by CDFA. The Subrecipient Agreement shall incorporate the entire Grant Agreement and shall include it as an attachment, and shall contain at a minimum the following terms and conditions:

1. REPRESENTATION AND WARRANTIES.

Women's Rural Entrepreneurial Network (WREN) ("Subrecipient") shall represent and warrant

- 1.1 Subrecipient is a duly organized and validly existing New Hampshire nonprofit corporation in good standing under the laws of this State. Subrecipient has the power and authority to undertake the grant activities as provided in the Grant Agreement. Subrecipient has the power and authority to own its properties, to conduct business as it is now being conducted, has the power to execute and deliver and perform its obligation under the Subrecipient Agreement and all other documents as applicable to this grant agreement.
- 1.2 The Subrecipient Agreement is the legal, valid and binding obligation of Subrecipient enforceable against Subrecipient, in accordance with each document's respective terms.
- 1.3 Subrecipient has complied in all material respects with all applicable federal, state and local laws, statutes, rules and regulations pertaining to the grant activities.
- 1.4 No application, exhibit, schedule, report or other written information provided by Subrecipient or its agents in connection with the grant application knowingly contained, when made, any material misstatement of fact or knowingly omitted to state any material fact necessary to make the statements contained therein not misleading, in light of the circumstances under which they were made.

2. PROJECT DESCRIPTION AND SUBGRANT ACTIVITIES.

2.1 <u>Project Description</u>. This project shall consist of the awarding of \$87,000 in Community Development Block Grant (CDBG) funds to the Grantee. The Grantee will retain \$9,000 of the grant for administrative costs associated with management of the grant and subgrant \$78,000 to the Subrecipient via this Subrecipient Agreement.

The Subrecipient's commitment is to work to increase the income and economic stability of qualifying microenterprises by helping them to access technical assistance (TA), training, capital, and expanded market opportunities. Sub-granted funds will be used by the Subrecipient to deliver Microenterprise Program services and support in the following program categories:

- 2.1.1 TA and Training Subrecipient will provide technical assistance and training programs to a minimum of 20 low- and moderate-income microenterprises, primarily in Carroll, Coos and Grafton Counties, with 100% of persons served being of low- and moderate-income status (LMI), at a pro-rata cost of \$2,500 for each qualifying and enrolled LMI beneficiary.
- 2.1.2 <u>Direct Grants</u> Subrecipient will provide direct grants of up to \$5,000 to a minimum of two (2) qualifying microenterprises that are currently eligible for and enrolled in Subrecipient's TA/training programs, as described in Section 2.1.1. Direct grants may be used for purchase of equipment/machinery or capital improvements directly related to operation or expansion of the

qualifying microenterprise. Each qualifying microenterprise may receive one direct grant of no more than \$5,000 during the Grant Period.

3. SUBRECIPIENT REQUIREMENTS.

- 3.1 <u>Performance Requirements</u>. The Grantee shall enter into an agreement with Subrecipient in order to satisfy the project purpose, which is technical assistance and training for 20 beneficiaries and direct grants for two (2) beneficiaries, of which one hundred percent (100%) will be LMI persons, as set forth in Exhibit B.
- 3.2 Security. Not Applicable to this Award.
- 3.3 <u>Compliance with Laws</u>. Subrecipient shall compty with all applicable federal, state, and local laws, statutes, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 3.4 <u>Disbursement of Grant Funds</u>. Upon compliance with, and subject to the provisions of this Agreement and provided there shall exist no Event of Default under this Agreement, the Grant Agreement or any other agreements, in connection with the Project, and no condition or event which, with the giving of notice or lapse of time would constitute such an Event of Default, the Grantee shall, upon submittal of written requests for payment accompanied by invoices and other documentation or supporting documents as required by the Grantee, make disbursements of grant funds. Disbursement of grant funds shall be in accordance with the terms of the Grant Agreement, including Exhibit C.

Disbursement of funds by the Grantee does not constitute acceptance by the Grantee or CDFA of any item as an eligible Project cost until all Project costs have been audited and determined to be allowable costs. Upon the expiration of the Grant Agreement, or other termination of the project, Subrecipient shall transfer to the Grantee any Grant funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds.

4. MICROENTERPRISE ASSISTANCE LIMITATIONS.

Under HUD guidelines, specific to microenterprise assistance, microenterprise beneficiaries are limited to CDBG funding for a period of three (3) years. To determine compliance, the eligibility of microenterprise beneficiaries shall be reviewed and tracked; eligibility is based upon the date of their initial enrollment in programs. Enrollment is not required to be consecutive. Reassessment of LMI status is required if a Family Income Verification Form (FIVF) is more than three (3) years old. New beneficiaries are those enrolled at any time on or after July 1, 2022, or upon Governor and Council approval, through the Grant Period end date as outlined in Section 1.7 of the General Provisions.

5. REPORTING REQUIREMENTS: ANNUAL, SEMI-ANNUAL AND CLOSEOUT AGREEMENTS.

- 5.1 The reporting period shall begin on July 1, 2022 and end on the Completion Date specified in Section 1.7 of the General Provisions of the contract between the Grantee and CDFA. Semi-annual reports shall be submitted by the Subrecipient to the Grantee no later than January 10^h, for the period of July 1, 2022 through December 31, 2022; and no later than July 10^h, for the period of January 1, 2023 through June 30, 2023. Grantee shall submit these reports to CDFA by January 15th and July 15th.
- 5.2 Subrecipient Reporting to Grantee. The Subrecipient, in compliance with this Subrecipient Agreement, is required to submit technical assistance and training applicant information to the Grantee and CDFA as set forth in Section 6.
- 5.3 Closeout Agreement. Subrecipient shall enter into a Closeout Agreement with the Grantee and CDFA, which shall specify the reporting and other requirements applicable to the closing out of this Project.

- 5.4 Annual Subrecipient Financial Reporting. Subrecipient shall submit to the Grantee and to CDFA its annual audited financial statements, within 90 days of its fiscal year end.
- 5.6 All Reporting shall be submitted via CDFA's Grants Management System (GMS).
- 6. INITIAL SUBRECIPIENT DOCUMENTATION AND SPECIFIC REPORTING REQUIREMENTS.
 - 6.1 In order to determine beneficiary eligibility and to comply with HUD's beneficiary enrollment limit of three years (described in Section 4), at the start of the program year, Subrecipient shall prepare a baseline report that includes a complete list of existing beneficiary microenterprises enrolled in that Subrecipient's training and technical assistance programs as of June 30, 2022, using the Microenterprise Beneficiary Tracking sheet, as set forth in Attachment IV. Data for the baseline report shall include information regarding each beneficiary, as set forth in the FIVF, provided on Attachment III; the Subrecipient's beneficiary intake form; and other relevant sources.
 - 6.2 On a quarterly basis, Subrecipient shall submit a claim request for all Technical Assistance/Training beneficiarles served in the previous quarter, at a rate of \$2,500 per qualifying beneficiary. Each quarterly claim shall include a completed Microenterprise Beneficiary Tracking sheet with information regarding each beneficiary served during that quarter, as set forth in Attachment VI. The tracking sheet will be used to record beneficiary information for each calendar quarter of the program year (July September, October December, January March, and April June). Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Beneficiary Tracking Sheet and no other version.
 - 6.3 At the end of the program year, Subrectpient shall prepare a final report which includes the Microenterprise Beneficiary Tracking Sheet for the entire program year, as well as the following information for each Technical Assistance/Training beneficiary:
 - (a) Subrecipient's Beneficiary Intake Form:
 - (b) FIVF, signed by all participants; the FIVF documents family income status and the designation of beneficiary minority or protected class status;
 - (c) Income changes as well as notable successes for its beneficiaries as a result of their participation in Subrecipient's programs; and
 - (d A list of beneficiaries that received loans during the program year.

The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.

- 6.4 In eddition to the quarterly claims described in Section 6.2, Subrecipient may submit additional claim requests for Direct Grants for qualifying beneficiaries. Each claim shall include a completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet with Information regarding each beneficiary to be served pursuant to the claim, as set forth in Attachment VI. Subrecipient shall use and submit the CDFA-provided Microsoft Excel version of the Tracking Sheet and no other version. Claims for Direct Grant support may be submitted at any time throughout the Grant Period.
- 6.5 At the end of the program year, Subrecipient shall prepare a final report which includes the completed Direct Grant/Down Payment Assistance Grant/CDBG Micro-Loan Tracking Sheet for all qualifying beneficiaries that received direct grants during the entire program year and a narrative describing the how the direct grant program was administered, issues and challenges and information that could improve future program implementation. The final report shall be submitted by the Subrecipient to the Grantee as part of the July Semi-Annual report.
- 6.6 All documentation shall be submitted via CDFA's Grants Management System (GMS).
- 7. TRAINING AND JOB CREATION/RETENTION BENEFIT TO PERSONS FROM LOW- AND MODERATE-INCOME HOUSEHOLDS.

The general purpose of the project is to principally benefit Low- and Moderate-Income persons as that term is defined in 24 CFR 570.483 and CDFA's Implementation Guide.

The Grantee and Subrecipient agree that the primary purpose of the Project is to provide training and technical assistance to at least twenty (20) microenterprise beneficiaries and direct grants to at least two (2) microenterprise beneficiaries. Of the beneficiaries served, one-hundred percent (100%) shall be persons from low- and moderate-income households, using the income limits as described above, and as provided in Attachment III, "Family Income Verification Form". Subrecipient agrees to maintain and provide documentation that it has complied with the income limits requirement using FIVFs provided by the Grantee.

8. GRANT OF FUNDS/MATCHING FUNDS.

- 8.1 Subrecipient shall use the Grant funds sub-granted to it solely for the purposes described herein and consistent with the required terms and conditions of the Grant Agreement and Subrecipient Agreement.
- 8.2 No other funds are required by the Subrecipient to match the Grant funds to be used for TA/Training or Direct Grants, pursuant to this Agreement and in connection with this Grant Project.

9. SCHEDULE AND GRANT COMPLETION.

- 9.1 <u>Implementation Schedule</u>. The Grantee and Subrecipient have agreed to an Implementation Schedule, which will provide for the completion of all grant activities, prior to the Grant Completion Date. A schedule of major milestones shall be provided within the Subrecipient Agreement, and shall serve as a basis for enforcement of the Agreement.
- 9.2 <u>Grant Completion Date</u>. All work shall be completed prior to the Grant Completion Date as outlined in Section 1.7 of the General Provisions. All employment commitments shall be accomplished by that date. This date may be extended only with the permission of the Grantee, CDFA, and the Governor and Council.
- 9.3 <u>Project Delays</u>. Should the Project encounter delays relating to financing, construction or other events that may affect the Subrecipient' ability to serve the number of beneficiaries identified in Section 7 within the specified Grant Completion Date, the Subrecipient and Grantee shall submit a written request for a time extension to CDFA, describing the reason for delay. Grant completion time extension requests shall then be forwarded to Governor and Council for final approval.

10. INSURANCE AND TAXES

10.1 <u>Subrecipient's Liability Insurance</u>. Subrecipient shall, at its sole expense, obtain and maintain in force insurance in such amounts and covering such risks as are customary for entities engaged in the same or similar business to include, where applicable, comprehensive general liability covering any property development/construction activities and landlord insurance and workers compensation insurance. At a minimum, this shall include insurance against all claims of bodily injury or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate and as further set forth in the General Provisions.

All policies shall name the Grantee and CDFA as additional insureds. Subrecipient shall provide the Grantee with certificates of insurance satisfactory to the Grantee, which evidences compliance with this Section.

10.2 Insurance Standards. The policies described in this section shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. All policies shall be on an "occurrence" basis. Each policy shall contain a clause prohibiting cancellation or modification of the policy earlier than thirty (30) days after written notice thereof has been received by the Grantee and CDFA.

10.3 <u>Taxes</u>. If applicable, Subrecipient shall pay all taxes, assessments, charges, fines and impositions attributable to the Property, which is the responsibility of the Subrecipient. Any alternative arrangements will require the approval of CDFA, whose consideration will not be unreasonably withheld.

11. ACCOUNTING, AUDIT, AND RECORD KEEPING REQUIREMENTS.

- 11.1 <u>Accounting Records.</u> Subrecipient shall keep all Project-related accounts and records, which fully disclose the amount and disposition by Subrecipient of the grant funds, the total cost of the Project, and the amount and nature of any portion of the Project cost supplied by other sources, and such other financial records pertinent to the Project. Accounts and records shall be kept in accordance with an accounting system that will facilitate an effective audit in accordance with the Single Audit Act of 1984. Records to be maintained shall include Project fiscal records consisting of all books, documents, ledgers, systems and expenses incurred, including, but not limited to, purchase, requisitions, orders, invoices, vouchers, bills and receipts, inventories, and all lien documents.
- 11.2 <u>Time Period</u>. All of the records, documents, and data described above and all income verification information shall be kept during the performance of the project, and for three (3) years after its completion or until the satisfactory completion of an audit, whichever is later.
- 11.3 <u>Availability of Records</u>. Subrecipient shall make available to the Grantee, CDFA, and HUD or any of their duly authorized representatives, for the purpose of audit and examination, any books, documents, papers, and records of Subrecipient pertinent to this Agreement.

12, INDEMNIFICATION.

Subrecipient shall defend, indemnify and hold harmless the Grantee, the State of New Hampshire, and the CDFA, their officers and employees, from and against any and all losses suffered by the Grantee, the State, or CDFA, their officers or employees, and any and all claims, liabilities or penalties asserted against the Grantee, the State or CDFA, their officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of or claimed to Subrecipient out of the acts or omissions of Subrecipient.

Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State or the Grantee, which immunity is hereby reserved to the State and the Grantee. This covenant shall survive the termination or expiration of this Agreement.

13. MAINTENANCE OF CORPORATE EXISTENCE.

- 13.1 <u>Corporate Existence</u>. Subrecipient shall both preserve and maintain the legal existence and good standing of its nonprofit corporation status and its registration in New Hampshire as required to do business.
- 13.2 <u>Scope of Mission</u>. Subrecipient and Grantee agree that the Subrecipient's Articles of Incorporation and Corporate Bylaws ("Bylaws") as submitted with the Project application and incorporated herein by reference, provide an adequate administrative mechanism for assuring the Subrecipient's mission of providing training and technical assistance opportunities for low- and moderate-income persons, during the Grant Period, as required pursuant to this agreement.

14. EVENTS OF DEFAULT.

The occurrence of any of the following events shall constitute an Event of Default under this Agreement:

(a) Any Event of Default by Subrecipient under the Grant Agreement, and related documents including, but not limited to, the failure of the Subrecipient to accomplish the required training and sechnical

assistance benefit to low- and moderate-income persons:

- (b) The Subrecipient's failure to comply with the reporting requirements as specified herein;
- (c) Subrecipient attempts to assign its rights under this Agreement or any advance made or to be made hereunder or any interest therein, without the prior written consent of the Grantee;
- (d) Any representation or warranty made herein or in any report, certification, or other instrument furnished in connection with this Agreement or any advances of Grant funds made hereunder, by or in behalf of Subrecipient, shall prove to be false or misleading in any material respect;
- (e) Any mechanics', laborers', materialmen's or similar statutory liens, or any notice thereof, shall be filed against the Property and/or the Project and shall not be discharged within thirty (30) days of such filling;
- (f) Subrecipient shall default in the due observance or performance of any covenant, condition, assurance or agreement to be observed or performed by Subrecipient under this Agreement:
- (g) Subrecipient shall (i) apply for or consent to the appointment of a receiver, trustee, or liquidator of it or any of its property, (ii) admit in writing its inability to pay its debts as they mature, (iii) make a general assignment for the benefit of creditors, (iv) be adjudicated as bankrupt or insolvent or (v) file a voluntary petition in bankruptcy, or a petition or answer seeking reorganization or an arrangement with creditors or to take advantage of any bankruptcy, reorganization, arrangement, insolvency, readjustment of debt, dissolution or liquidation law or statute, or an enswer admitting the material allegations of a petition filed against it in any proceeding under any such law;
- (h) A petition, order, judgment, or decree shall be entered, without the application, approval or consent of Subreciplent by any court of competent jurisdiction, approving a petition seeking reorganization or approving the appointment of a receiver, trustee or liquidator of Subreciplent of all or a substantial part of its assets, and such order judgment or decree shall continue unstayed and in effect for any period of thirty (30) days;
- (I) The dissolution, termination of existence, merger or consolidation of Subreciplent or a sale of assets of Subreciplent out of the ordinary course of business without the prior written consent of the Grantee and CDFA; and
- (j) Failure to remedy an ineligible expenditure of grant funds or to reimburse the Grantee for any ineligible costs, which are paid from grant funds.
- (k) In the event that the Subrecipient fails to serve the minimum number of Low- and Moderate-Income beneficiaries, as provided in this Agreement, then the Subrecipient shall confer forthwith with the Grantee and CDFA to develop a mutually acceptable plan pursuant to which it will rectify any reporting shortfalls and maintain the required minimums. In such event, the Subrecipient shall also provide Grantee with monthly updates containing information in a form reasonably satisfactory to the Grantee, in order for the Grantee and Subrecipient to determine whether it is in compliance with such plan and its obligations as provided herein. Said monthly reports to continue until the beneficiary commitments are achieved.
- (I) The continued failure of the Subrecipient to achieve its beneficiary commitments as required herein for ninety (90) days following the date specified for such requirement shall constitute an event of default, which may give rise to any of the remedies available to the Grantee, as set forth therein.

15. GRANTEE'S RIGHTS AND REMEDIES UPON DEFAULT.

- 15.1 Remedies upon Default. Upon the occurrence of any Event of Default, the Grantee may take any one, or more, or all, of the actions described below. Prior to taking any of the following actions, the Grantee will give Subrecipient a written notice of default specifying the Event of Default and requiring it to be remedied within thirty (30) days from the date of notice. The following actions may be taken only if Subrecipient has not remedied the Event of Default in a timely manner.
- (a) Terminate this Agreement, effective immediately upon giving notice of termination;
- (b) Suspend all payment of grant funds to be made pursuant to this Agreement until such time as the Grantee determines the Event of Default has been cured;
- (c) Set off against any other obligations the Grantee may owe to Subrecipient for any damages the Grantee may suffer by reason of any Event of Default;
- (d) Treat the Agreement as breached and pursue any of its remedies at law or in equity or both;
- (e) Foreclose under any available security instrument created under this agreement; and
- (f) Assume the right to seek full reimbursement of CDBG funds from the Subrecipient and the right to call on any collateral pledged under the loan with the Subrecipient.
- 15.2 <u>Judicial Enforcement</u>. Subrecipient agrees that the Grantee and CDFA have a right to seek judicial enforcement with regard to any matter ensing with respect to this Agreement, to include the assurances, covenants and other conditions, which extend beyond the completion date under this Agreement.
- 15.3 <u>Disposition of Funds</u>. Where the Grant Agreement or Subrecipient Agreement is terminated or the Project is otherwise terminated due to a default, inability to perform or reasons other than project completion, Grant funds are required to be returned. The disposition of Grant Funds to be returned shall be determined solely by CDFA.

16. ADDITIONAL REPRESENTATIONS AND WARRANTIES. Subreciplent represents and warrants:

- (a) Subrecipient will obtain all necessary approvals and all necessary permits for the operation of its business from all governmental authorities having jurisdiction.
- (b) No litigation, claims, suits, orders, investigations or proceedings are pending or threatened against Subrecipient or affecting the Property or the Project at law or in equity or before or by any federal, state, municipal or other governmental instrumentality; there are no arbitration proceedings pending under collective bargaining agreements or otherwise; and to the knowledge of Subrecipient, there is no basis for any of the foregoing. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.
- (c) Subrecipient has filed all federal, state and local tax returns required to be filed and has paid or made adequate provision for the payment of all federal, state or local taxes, charges and assessments, if applicable.
- (d) The execution and delivery and performance by Subrecipient of its obligations under this Agreement have been duly authorized by all requisite corporate action and will not violate any provision of law, any order of any court or other agency of government, or any Indenture, agreement or other instrument to which Subrecipient is a party, or by which it is bound, or be in conflict with, result in a breach of, or constitute a default under, or except as may be provided in this Agreement, result in the

creation or imposition of any lien, charge or encumbrance of any nature whatsoever upon any of the property or assets of Subrecipient pursuant to any such indenture, agreement or instrument. Subrecipient is not required to obtain any consent, approval or authorization from, or to file any declaration or statement with, any governmental instrumentality or other agency in connection with or as a condition to the execution, delivery or performance of this Agreement and all other related documents.

- (e) Subrecipient is not contemplating either the filing of a petition under any state or federal bankruptcy or insolvency laws or the liquidating of all or a major portion of its properties and has no knowledge of any person contemplating the filing of any such petition against it.
- (f) No statement of fact made by or on behalf of Subrecipient In any of the agreement or related documents or in any certificate, exhibit or schedule furnished to the Grantee pursuant thereto, contains any untrue statement of a material fact or omits to state any material fact necessary to make statements contained therein or herein not misleading. There is no fact or circumstance presently known to Subrecipient that has not been disclosed to the Grantee that materially affects adversely, nor as far as Subrecipient can foresee, will materially affect adversely Subrecipient, operations or considerations (financial or otherwise) of Subrecipient.
- (g) No Event of Default has occurred and is continuing under this Agreement and no event or condition which would, upon notice of expiration of any applicable cure, constitute an Event of Default has occurred and is continuing; Subrecipient is not in default under any note or other evidence of indebtedness or other obligation for borrowed money or any mortgage, deed to trust, indenture, lease agreement or other agreement relating thereto. Any exceptions to this section shall be explained in an Exhibit, attached to this agreement.

Subrecipient warrants that each of the foregoing representations and warranties is true and correct as of the date of this Agreement and Subrecipient shall indemnify and hold harmless the Grantee, the State and CDFA from and against any loss, damage, or liability attributable to the breach thereof, including any and all fees and expenses incurred in the defense or settlement of any claim arising therefrom against the Grantee, State or CDFA.

13. MISCELLANEOUS PROVISIONS.

- 13.1 Compliance with Laws. Subreciplent shall comply with all applicable federal, state and local laws, statutes, regulation, executive orders and rules as they relate to the application, acceptance and use of funds for this project, including, but not limited to, the requirements as specified in the Grant Agreement.
- 13.2 Compliance with OMB 2 Part 200. Subrecipient acknowledges that it shall meet the requirements of OMB 2 Part 200, to ensure compliance with Administrative Cost Standards.
- 13.3 No assignment. Subrecipient shall not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the Grantee and CDFA, and any attempted assignment or transfer shall be ineffective, null, void, and of no effect.
- 13.4 <u>Amendments</u>. No amendment or modification of any provision of this Agreement shall be effective unless it is in writing and executed by both parties and approved by CDFA.
- 13.5 <u>Maintenance of Project.</u> Subrecipient shall maintain, keep, and preserve in good working order and condition all of its property and assets necessary or useful in the proper conduct of its business and operation of the Project. This shall include all property improvements made as a result of this Project, if applicable.

13.6 Governing Law. The Subrecipient Agreement shall be governed by and construed in accordance with laws of the State of New Hampshire.

13.7 Publicity and Signage.

- 13.7.1 <u>Public Relations</u>. The Subrecipient shall grant CDFA the right to use the Subrecipient's name, likeness, and logo in any public relations or publicity efforts. This shall include, but not be limited to, press releases, media interviews, website, publications, brochures, etc. CDFA's publicity efforts may also include details about Grantee's project, contract, or other publicity evallable information.
- 13.7.2 <u>Reciprocal Publicity</u>. The Subrecipient also shall acknowledge CDFA appropriately in all organizational and public forums as to the support, financial and otherwise, that has been provided to the project. This recognition shall include, but not be limited to, print/electronic media, publications, interviews, brochures, website, etc.
- 13.7.3 <u>Project Signage</u>. For construction/renovation projects CDFA logo must be included in signage at the job worksite. CDFA logo may not be any smaller that 50% of the size of the largest logo displayed. This requirement can be waived if no other partner/entity requires worksite signage and creating signage solely for CDFA poses a hardship. Alternative If none of these are applicable/feasible, an alternative display of the CDFA logo or public recognition must be approved by CDFA.

Claims for direct grants, down payment assistance or CDBG micro-loan funds may be submitted at any point during the grant period (unlike the quarterly claims for Technical Assistance/Training funds). Complete claim documentation must be submitted via the "Dropbox" link (provided by CDFA) at least two (2) weeks prior to the actual claim submission through GMS. This will allow CDFA the opportunity to review the claim materials and set up GMS for the proper submittal of the full claim. Claim documentation includes:

- CDBG Microenterprise Direct Grant Assistance Agreement (Attachment V) Must be filled out
 and signed by an authorized representative of the business receiving funds and the
 Microenterprise TA Provider. The executed agreement must include an invoice (reimbursement)
 or formal vendor quote (advance).
- UEI Each business that receives a direct grant, down payment assistance or a CDBG micro loan must obtain a Universal Entity Identification, UEI (which replaces the "DUNS" number).
- 3. Environmental Review Form Must be signed by the Grantee Authorized Official confirming that appropriate environmental review has been completed for the proposed activity.
- 4. Direct Grants, Down Payment Assistance & CDBG Micro-Loans Tracking Sheet (Attachment V) CDFA has added a tab ("Direct grant-loan 2022") to the 'regular' microenterprise tracking spreadsheet to enable subrecipients to track businesses that receive direct grants, down payment assistance and CDBG micro-loans, with separate sections for each type of funding. On this tab, Subrecipient will provide a summary of information collected from each business. This spreadsheet should be updated and submitted with EVERY claim for direct grant/down payment assistance/CDBG micro-loan funds, throughout the program year.

Following submission through 'Dropbox,' CDFA will review materials to ensure that all forms and information needed to process the claim have been provided. CDFA will provide feedback and guidance to the Grant Administrator/Subreciplent if any additional information or changes are required for the claim to be submitted.

When the claim is submitted through GMS, the Grant Administrator provides all the documentation supporting the request that was pre-submitted through Dropbox, as well as any corrected or additional information requested by CDFA.

Claims for direct grants and down payment assistance grants may be made based on reimbursement of previously incurred expenses, or for advance payments. If a claim is requesting an advance payment, please consider the following:

- A Subrecipient may make advance payments provided that it maintains both written procedures
 that minimize the time elapsing between the transfer of funds (from CDFA) and disbursement by
 the Subrecipient (less than 15 days), and financial management systems that meet the standards
 for fund control and accountability.
- 2. An advance payment must be limited to the amount needed and be timed to be in accordance with the actual, immediate cash requirements of the business for the purpose outlined in the

CDBG Microenterprise Direct Grant Assistance Agreement (Attachment V). The primary goal is to ensure that payments are as close as is administratively feasible to the time that actual expenses are incurred.

- 3. While for-profit entities are not required to adhere to procurement requirements, a business requesting an advance payment must provide a formal vendor quote or cost estimate (to be attached to the CDBG Microenterprise Direct Grant Assistance Agreement). This is considered an internal control mechanism and is an important facet of a financial management system.
- Advance payments may be used ONLY for machinery or equipment purchases. Advance
 payment may not be used for minor construction/modification expenses, which must be
 reimbursement-based.

Micro-Loans - Additional Requirements

For a proposed micro-loan to a qualifying microenterprise beneficiary using CDBG Micro-Loan funds, Subrecipient must prepare/submit a detailed Loan Summary and Underwriting Review/Credit Memo pursuant to its micro-loan policies and procedures and Appendix VII, the 'Micro-Loan Underwriting Summary.' Subrecipient may use its own format or template, provided that all of the information contained withing Appendix VII is addressed. The Loan Summary and Underwriting Review/Credit Memo, Environmental Review documentation and Direct Grants, Down Payment Assistance & CDBG Micro-Loans Tracking Sheet (Attachment V) must be submitted via the "Dropbox" link (provided by CDFA) at least two (2) weeks prior to the GMS claim submission date. CDFA will review/approve all underwriting and loan documents prepared and submitted by the Subrecipient and provide feedback prior to the GMS claim submission deadline. Following CDFA review, the Grant Administrator will submit all loan documentation with the Claim request. A micro-loan to a qualifying Microenterprise beneficiary that utilizes CDBG funds may not exceed a total of \$50,000 (in combined CDBG and non-CDBG funds).

Financial Management Requirements

CDFA requires that each Subrecipient set up separate cost centers in their chart of accounts to enable documentation and tracking of the four (4) types of funds made available through the CDBG award:

- Technical Assistance and Training funds Funds used by the Subreciplent to provide technical
 assistance, training, loan assistance and other services to qualifying microenterprises. Funds
 cover the cost of providing these services through staff, consultants or partners. This funding
 does NOT flow directly to the microenterprise.

- 4) Program Activity Costs Costs incurred by the Subrecipient to manage and deliver the Microenterprise program. Program Activity Costs include, but are not limited to, personnel costs directly related to overall delivery and management of the Microenterprise program, advertising and marketing related to the Microenterprise program, environmental studies related to direct grants and loan processing for qualifying microenterprise clients. Program Activity Costs DO NOT include any indirect costs, general administration or other 'overhead' expenses.

Introduction and Project Description

"Microenterprise Development Assistance" has been a funding category in the New Hampshire State Community Development Block Grant (CDBG) program since 1998 as a sub-category of Economic Development. By HUD definition, the term "microenterprise" means a commercial enterprise that has five or fewer employees, one or more of whom owns the enterprise. Each microenterprise owner must qualify as low- or moderate-income (LMI) before receiving services. Microenterprise funding has enabled many New Hampshire small businesses to receive much-needed technical assistance for business planning, marketing, financial management and business structuring to help them develop and expand their businesses.

The CDFA CDBG Application and Program Guide allows one municipality to apply for up to \$500,000 in funding for subrecipients that provides training and technical assistance to microenterprises. For the 2022 program year (starting on July 1, 2022), eight subrecipients indicated an interest in applying for CDBG funds for support of microenterprise technical assistance programs, meaning that three municipalities applied for the funds on behalf of those subrecipients.

For 2022, based on successful experience with direct grants to microenterprises to assist with COVID-19 relief and business re-orientation, CDFA added the opportunity to request funding in three additional categories of support for Microenterprises: direct grants of up to \$5,000 per client for machinery/equipment purchases and minor renovations; up to \$10,000 per client for down payment assistance for purchase of a business-related property; and up to \$100,000 in capital for micro lending, to be matched dollar-for-dollar by low-interest loan capital from CDFA (HUD limits the size of

micro lending to \$50,000 per qualifying microenterprise client). Seven subrecipients requested funds for direct grants and down payment assistance and two subrecipients requested loan capital. The program design also enables subrecipients to request up to 20% of the total direct-service funding to help cover 'program activity costs' associated with program marketing, management and delivery.

Nexus with SBA Community Navigator Pilot Program

The <u>Community Navigator Pilot Program</u> (CNPP) is an American Rescue Plan Act initiative designed to reduce barriers that underrepresented and underserved entrepreneurs often face in accessing the programs they need to recover, grow, or start their businesses. CDFA was awarded a two-year, \$2.5 million grant from the <u>U.S. Small Business Administration</u> to launch the program in New Hampshire. CDFA is <u>one of fifty-one grantees selected</u> from more than 700 submissions nationwide. CNPP implementation began on December 1, 2021 and continues through November 30, 2023.

CDFA serves as the statewide "Hub" for implementation, working alongside many of our established microenterprise technical assistance providers (serving as on-the-ground "Spokes" for program delivery), New Hampshire's SBA office, statewide training and language-access partners, and on-the-ground community partners to achieve the goals of the program. The program design builds on years of CDFA's investment in microenterprises through technical-assistance providers, including more than \$2.6 million in CDBG funds over the past two years.

Subrecipient Discussion

1. <u>Belknap Economic Development Corporation (BEDC)/Wentworth Economic Development Corporation (WEDCO)</u>

BEDC and WEDCO are working closely together build stronger collaboration, provide more coordinated services, and increase support for microenterprise businesses in Belknap, Carroll, and Strafford counties. BEDC and WEDCO have provided technical assistance (TA) to microenterprises for 17 years from offices in Laconia and Wolfeboro (previously as part of a four-RDC coalition covering most of the North Country). Most TA services are provided on an individualized, one-on-one basis by RDC staff, NH Small Business Development Center (SBDC) business advisors, and other business resource partners. SBDC has a strong history of supporting local microenterprise businesses and has access to additional resources throughout New Hampshire to support microenterprises. All business owners participating in the program are required to meet with an SBDC representative to create a tailored plan for their business.

<u>Proposed Project</u> - CDBG funds will enable BEDC/WEDCO to continue to offer a full range of TA services and entrepreneurial training in an expanded service area (now including Strafford County), including:

- Coordinated marketing and outreach to microenterprises in northeastern NH;
- Targeted, one-on-one, in-depth counseling and mentoring to microenterprise entrepreneurs and existing micro-businesses based on an assessment of their specific needs;
- Referrals to other, specialized services provided by partners such as SCORE, Chambers of Commerce, other RDCs/Micro providers and the Community College System;
- Direct grants for machinery/equipment and down payment assistance for the purchase of business-related property; and
- Additional capital for micro-lending.

In the COVID-19 environment, the partners provided services remotely through webinars, video conferences, phone and other electronic means. In 2022, their work is complemented by the SBA Community Navigator program, for which BEDC/WEDCO serves as the 'spoke' for service delivery in

northeastern NH (in the same three counties as the Microenterprise program). Enhanced marketing to underserved business owners should result in utilization of additional Microenterprise resources.

Request Summary – The CDBG award would enable the BEDC/WEDCO team to provide assistance to LMI individuals as follows: thirty-eight clients for TA/training; two clients for loan assistance; six clients for direct-grant or down payment assistance; and BEDC/WEDCO could access up to \$25,000 of micro-loan capital, to be matched dollar-for-dollar by low-interest capital from CDFA.

2. <u>Grafton Regional Development Corporation (GRDC)/Coos Economic Development Corporation (Coos EDC)</u>

GRDC and Coos EDC are working closely together build stronger collaboration, provide more coordinated services, and increase support for microenterprise businesses in Grafton and Coos counties, using a program design that is similar to the BEDC/WEDCO approach. GRDC/Coos EDC have provided technical assistance (TA) to microenterprises for 18 years from offices in Plymouth and Lancaster (previously as part of a four-RDC coalition covering most of the North Country). Most TA services are provided on an individualized, one-on-one basis by RDC staff, SBDC business advisors, and seminars/workshops offered through the Enterprise Center at Plymouth.

<u>Proposed Project</u> - CDBG funds will enable GRDC/Coos EDC to continue to offer a full range of TA services and entrepreneurial training in northwestern NH, including:

- Coordinated marketing and outreach to microenterprises in the North Country;
- Targeted, one-on-one, in-depth counseling and mentoring to microenterprise entrepreneurs and existing micro businesses based on an assessment of their specific needs;
- Webinars, workshops and other training sessions at the Enterprise Center of Plymouth;
- Loan qualification, application, approval and servicing, and
- Direct grants for machinery/equipment and down payment assistance for the purchase of business-related property.

Similar to other micro providers, over the past two years GRDC/Coos EDC provided services remotely through webinars, video conferences, phone and other electronic means. In 2022, their work is complemented by the SBA Community Navigator program, for which the partners serve as the 'spoke' for service delivery in northwestern NH (in the same two counties as the Microenterprise program). Enhanced marketing to underserved business owners should result in utilization of additional Microenterprise resources.

Request Summary – The CDBG award would enable the GRDC/Coos EDC team to provide assistance to LMI individuals as follows: twenty-five clients for TA/training; two clients for loan assistance; and five clients for direct-grant or down payment assistance.

3. Northern Community Investment Corporation (NCIC)

NCIC is a certified Community Development Financial Institution (CDFI) working to address regional economic challenges in northern NH and northeastern Vermont, from offices Saint Johnsbury, VT. NCIC focuses on small business development, community economic development, management, and financing. NCIC provides funding and support for business planning and coaching, training, marketing, architectural and engineering designs, feasibility planning, legal assistance, and debt financing focused on strengthening and growing employment opportunities within local businesses.

<u>Proposed Project</u> – CDBG funds will support NCIC's training and technical assistance services to NH businesses including:

- Staff services directly to businesses, including financial literacy and management, technology, marketing or advertising; and
- Hiring professional consultants (after a competitive solicitation process) to provide specialized assistance to businesses that is outside the realm of expertise of NCIC staff.

Request Summary – The CDBG award will enable NCIC to assist twenty LMI individuals in the upcoming program year and provide direct grants to two qualifying micro clients. This is a slight decrease from the twenty-five clients expected to be served in the current program year due to other Micro TA capacity in the North Country. NCIC will coordinate services with other North Country Microenterprise TA providers where service areas overlap.

4. Women's Rural Entrepreneurial Network (WREN):

Since 1994, WREN has been assisting emerging and existing business owners with comprehensive training in financial planning, cash flow and budgeting, marketing and public relations, and operations management. WREN has assisted more than 1,500 business owners, mostly LMI, with a particular focus on arts and food/ agriculture businesses. WREN served thirty-five clients 2019, and twenty-five in 2020, and expects to serve twenty-five clients in the current program year (the full number awarded).

<u>Proposed Project</u> – The CDBG funds will support an extensive series of classes and workshops, as well as one-on-one advice and technical assistance, to those who want to increase their entrepreneurial knowledge and skills. As with other providers, most services have been delivered remotely, and the "marketplace" space in Bethlehem his been re-designed to allow smaller, private work spaces for WREN client-entrepreneurs. The silver lining for WREN: having to provide mostly on-line programs led to increased access for micro-businesses across the rural North Country who did not need to travel to Bethlehem to attend programs in person.

CDBG funds will allow WREN to continue a full range of entrepreneurial training services (both remote and in Bethlehem), including programs in graphic and website design, financial management, farm and food marketing, business planning, online marketing and analytics, product pricing, business start-up basics, and photography.

Request Summary – The CDGB award will enable WREN to assist twenty LMI individuals in program year 2022 (a slight decrease due to other Micro capacity in the North Country). CDBG funds will be used for staffing to provide direct microenterprise support, consultants/instructors for programs and courses that are outside WREN staff expertise, and direct grants to at least two clients. WREN coordinates with other North Country micro TA providers where service areas overlap.

5. Hannah Grimes Center, Inc. (HGC)

HGC has more than two decades of experience serving small business owners and entrepreneurs in the Monadnock Region. Through resources ranging from one-on-one coaching to intensive programs such as the business incubator, HGC strives to help entrepreneurs connect, innovate and thrive in their community. Other services include retail training at the Marketplace, an expansive offering of workshops, and the *Essentials!* course series, which is designed to provide immersive, multi-week training on business fundamentals.

HGC's programs provide a comprehensive spectrum of support and technical assistance, resulting in significant benefit to clients: one hundred and seventy-three unique participants were reported in 2021, with a 90% client satisfaction rate; 20% of LMI participants no longer

qualify as LMI at the end of the three-year Micro-TA period; and HGC business clients average 88% revenue growth in their first two years with HGC, and 50% revenue growth in year three.

<u>Proposed Project</u> – CDBG funds will enable HGC to continue to deliver one-on-one technical assistance, direct counseling via an extensive network of expert volunteer coaches, a comprehensive suite of workshops, as well as longstanding programs such as the Incubator program and the recently re-branded *Essentials!* business training course. Many programs will continue to be delivered on-line or in a hybrid approach. An agreement with REDC enables referral of HGC clients for loan assistance and financing. In 2022, their work is complemented by the SBA Community Navigator program, for which HGC and RVCC together serve as the 'spoke' for service delivery in southwestern NH (in the same two counties as the Microenterprise program). Enhanced marketing to underserved business owners should result in utilization of additional Microenterprise resources.

Request Summary – The CDBG award will enable HGC provide TA and training to fifty LMI individuals in program year 2022 (a slight decrease from 2021) along with at least twenty direct grants to qualifying clients. CDBG funds will be used primarily for staff time for delivery of classes and workshops, as well as one-on-one advice and technical assistance to those who want to increase their entrepreneurial knowledge and skills in the Monadnock region. HGC is partnering with REDC if HGC clients need assistance accessing loan capital.

6. Rockingham Economic Development Corporation d/b/a Regional Economic Development Center Southern New Hampshire (REDC)

REDC has a twenty-eight-year history successfully providing training and technical assistance to growing businesses, at least 60% of which have traditionally been microenterprises. REDC is an active SBA micro-lender, a US EDA Development District, an EPA Brownfields lender, and a CDFI, which together bring multiple layers of expertise and resources, particularly lending capacity, to clients. The REDC added staff to meet growing need but still is able to serve only half of the businesses requesting assistance.

REDC has extensive experience lending to small businesses, particularly microenterprises and business owners from underserved communities: \$28 million to small businesses, including 60% of loans to start-ups, 39% to women-owned businesses and 19% to minority-owned businesses.

REDC is serving as the "Southeast Spoke" in the Community Navigator program, which will further enhance its ability to reach underserved businesses and communities. REDC also is working to expand its 'New Americans Loan Program,' which targets loan capital to immigrants and refugees in New Hampshire.

<u>Proposed Project</u> – CDBG funds will enable REDC to continue to deliver/provide services depending on client needs/intake, including on-line, self-directed training; one-on-one counseling by staff and consultants; referrals to other providers (e.g. SBDC); workshops and other programs; and direct grants and loans.

Request Summary – The CDBG award will enable REDC to assist seventy-five LMI clients with TA/training; provide lending TA to five clients; and direct grants to four clients. CDBG funds will be used for staffing, marketing and outreach. Training and workshops will be held remotely and at the REDC Business Development and Training Center in Raymond, NH and other locations throughout Southeastern New Hampshire.

7. New Hampshire Small Business Development Center (SBDC) - Pathway to Micro

The SBDC is a nationally affiliated SBA program based at the UNH's Peter T. Paul School of Business and Economics, providing one-on-one management assistance and educational programs to more than 3,000 NH small businesses annually. Since 1984, SBDC business advisors have served more than 30,500 entrepreneurs; delivered education to at least 76,000 individuals; helped clients start more than 2,140 micro-businesses; and created or retained nearly 15,000 jobs in NH. Combined, SBDC staff have more than 200 years of combined advising and business ownership experience.

Over the past several years, SBDC has partnered with NH Employment Security on Pathways to Work (PTW), a voluntary program to enable an eligible unemployed claimant to continue to receive unemployment benefits while working full time to start their own business. Last year, SBDC expanded its program to include long-term unemployed and underemployed individuals who are not eligible for PTW, as well as PTW enrollees. The NH Economic & Labor Market Information Bureau estimates that 6.1% of the NH labor force is currently unemployed/ underemployed, which creates the client base for this "Pathways to Micro" alternative. SBDC also serves as the "statewide" spoke for the Community Navigator program, which will further enhance its ability to reach underserved businesses and communities.

<u>Proposed Project</u> – CDBG funds will allow SBDC to offer a full range of entrepreneurial training and technical assistance services to unemployed LMI clients including:

- Access to online e-courses on finance, management, marketing, social media, etc.;
- Classes on Starting a Business in New Hampshire and Financing a Business in New Hampshire;
- New courses on exporting, human resources, revenue generation and business resiliency;
 and
- One-on-one coaching by an SBDC business advisor.

Request Summary – The CDBG grant award will allow SBDC to assist thirty-five unemployed clients in program year 2022 (a slight decrease from 2021)—a combination of Pathway to Work clients through NHES and other unemployed/underemployed clients through the Pathway to Micro curriculum. SBDC services are delivered in individualized business advising sessions by nationally certified business counselors who have advanced degrees and have owned/managed a business, and through individualized education opportunities to participants.

8. River Valley Community College (RVCC)

Over the past several years, local leaders in Claremont, Newport and other parts of Sullivan County have repeatedly pointed out that the County represents a 'donut hole' in the statewide deployment of microenterprise funding. Other Micro-TA partners have been able to support a handful of Sullivan County business, but there has not been a local, place-based microenterprise TA provider focused primarily on this region of the state—until this year, when RVCC started offering technical assistance, training and other business-support services targeted to Sullivan County microenterprises.

In 2020, RVCC launched the Entrepreneurship and Innovation Program (EIP) in downtown Lebanon to provide more business training, an entrepreneurship/innovation center, and a community coworking space serving more than one hundred micro-entrepreneurs. Prior to her Lebanon assignment, RVCC's EIP Coordinator, Alison Chisolm, worked with more than one hundred and fifty micro businesses in the North Country while on the staff at WREN. A new director at Claremont

Maker Space will expand its support of the program, and a new SBDC business advisor focused on Sullivan County adds significant program capacity.

The RVCC-led program has been slow to ramp up due to several staff vacancies, but client intake is increasing in 2021. In 2022, their work is complemented by the SBA Community Navigator program, for which HGC and RVCC together serve as the 'spoke' for service delivery in southwestern NH (in the same two counties as the Microenterprise program). Enhanced marketing to underserved business owners should result in utilization of additional Microenterprise resources.

<u>Proposed Project</u> – CDBG funds will enable the RVCC team to provide technical assistance, support and resources to LMI microenterprises in Sullivan County and adjacent communities in Southern Grafton and Cheshire Counties, focused on start-up and early growth micro-entrepreneurs. Clients engage in a detailed intake and assessment by the SBDC business advisor, followed by one-on-one business coaching, training, and access to co-working/maker spaces. An agreement with REDC enables referral of RVCC clients for loan assistance and financing.

<u>Request Summary</u> – The CDBG grant award will enable the RVCC team to serve twenty qualifying microenterprise clients and provide direct grants to two clients.

CDBG Scoring

The scoring system for the Microenterprise TA program awards points in sixteen specific categories grouped into three general areas: Management Capacity (experience, expertise, organizational structure); Program Design (marketing, intake, training, # of clients served, support services); and Public Benefit (user demand, reduction on social-service need, CDFA Core Data Index score). Each subrecipient was evaluated and points awarded on a sliding scale within each of the sixteen categories. The maximum possible score is 355 points; the minimum score needed to advance to a funding recommendation is 190 points. A spreadsheet with the scoring rubric is attached as Appendix A.

The following table summarizes the total score of each of the eight subrecipients:

Recommendation

CDFA's CDBG Action Plan allocates \$2,695,596 in CDBG funding for Economic Development, including the Microenterprise Technical Assistance Program. Based on the positive experience with direct grants for COVID-19 relief, significant research and evidence that validates the benefits of investing in microenterprises as a way to build equity and family wealth, and expanded marketing to underserved microenterprises that will result from the Community Navigator program, staff recommends approval of a total of \$1,315,400 CDBG Microenterprise Technical Assistance Program funding for the program year July 1, 2022 through June 30, 2023. This amount represents an

increase of \$391,535 (42%) over the total 2021 program year award. The staff recommendation is summarized below, by county:

Final allocations reflect a number of factors:

- The subrecipient score (see attached scoring table);
- A minimum of twenty clients served as a threshold for a meaningful program;
- The population of the proposed service areas (more client capacity and funding allocated to the more populated southern half of the state);
- An increase in the funding requested for direct grants, down payment assistance and loan capital, which results in a smaller amount allocated to direct technical assistance/training; and
- The limit of \$500,000 in funding that may be awarded to any one applicant (in Grafton County, four subrecipients serve the North Country, so each subrecipient is awarded fewer dollars than requested, consistent with scoring and population, in order to stay below the \$500K funding limit).

Funding for CDBG administration represents approximately 10.5% of the program awards for each County applicant, which is a slight increase from 2021.
