REQUESTED ACTION

Pursuant to RSA 94:6, the Department of Administrative Services respectfully requests to place Gerald Rocha at Step 6 for the position of Director, Sununu Youth Services, Position #9U417, unclassified salary grade GG, earning \$105,482.00, effective upon Governor and Council approval. 100% General Funds.

EXPLANATION

The Sununu Youth Services Center (SYSC) is the State's sole secured treatment facility within the continuum of care for adjudicated and detained youth. The Director provides strategic leadership, direction, and planning; programmatic, fiscal, regulatory, physical plant, and personnel oversight; facilities management; and operational direction to ensure the provision of a continuum of high-quality services to New Hampshire's youth in a secure, trauma-informed, therapeutic residential program which includes multidisciplinary residential, educational, vocational, and clinical programs designed to rehabilitate troubled youth.

The Director is responsible for leading and sustaining a transformative multi-year initiative to plan, develop, and implement a new clinical and therapeutic model of care, inform the development of a new facility designed to complement a clinical and therapeutic model of care, and support a therapeutic and healing culture within the facility in collaboration with numerous government entities, regulatory agencies, and a wide spectrum of stakeholders. The position reports directly to the Director of the Division for Children, Youth and Families (DCYF) and has direct reports within the leadership of the SYSC, and collaborates with other senior leaders within DCYF and DHHS who interface with SYSC programming.

Mr. Rocha possess a Masters in Community Mental Health Counseling and is a NH Licensed Clinical Mental Health Counselor. He has most recently worked for Seacoast Mental Health as the Clinical Manager of Intake where he was responsible for complete oversight of access to care operations and admissions. He created a statewide community mental health center initiative called Intake Collaborative to establish processes to minimize barriers to accessing mental health services. Prior to this position, Mr. Rocha was the Director of Psychological Services for Easter Seals, providing oversight to residential and educational programming, where he successfully implemented a trauma informed model of care.
