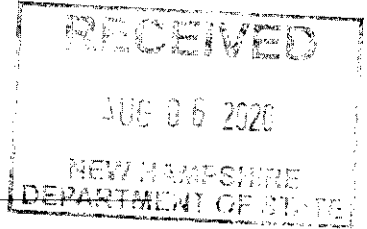

Section V
