Re: **PETITION – Derry, X-A002(975), 24861**

Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed improvements to NH 28 Bypass in the Town of Derry.

Since the Petition is not for the limitation or control of access, a Commission is requested to be appointed to hold a hearing, and, if the necessity is found, to lay out the new highway at this location.

The project will reconstruct the intersection of NH 28 Bypass, Scobie Pond Road and English Range Road and install traffic signals to improve safety. The proposed improvements to NH 28 Bypass will begin approximately 750' south of the intersection and extend north approximately 1,500'. The improvements to Scobie Pond Road and English Range Road will extend approximately 150' west and 250' east of NH 28 Bypass, respectively. This project may impact historic resources.
