PENALTY – RSA 664:21		
Any candidate who voluntarily agrees to limit campaign expenditures and exceeds that limitation in either a state primary or a state general election, shall be subject to a fine schedule based on the percentage by which the candidate exceeds permitted campaign expenditures as follows:
