REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Robert P. Freitas, Jr. (Position #9U372, Appropriation #02-20-200510-2615-014-500134) as a Criminal Investigator, at a salary level of \$80,186.08 (LG BB, Step 7) effective upon Governor and Executive Council approval or May 10, 2019, whichever is the latter. Mr. Freitas will be occupying a position that expires April 30, 2024.

EXPLANATION

Mr. Freitas is a resident of Manchester, and has more than 30 years of experience in law enforcement. Prior to joining the Department, Mr. Freitas served as a patrol officer and an investigator for the Manchester Police Department from September 1985 to November 2009. Mr. Freitas joined the Department in November 2009 as a part-time investigator with the Cold Case Unit, a joint venture of the New Hampshire State Police and the Attorney General's Office. From June 2012 through May 2014, Mr. Freitas was also an Evidence Technician for the Manchester Police Department. In May 2014, Mr. Freitas became a full-time Criminal Investigator in May 2014 in the Medicaid Fraud Control Unit, where I plan to continue his assignment. I am a certified New Hampshire Police Officer and currently employed full time by the State of New Hampshire Department of Justice as a Criminal Investigator assigned to the Medicaid Fraud Control Unit (MFCU)

Prior to the above NH DOJ position I was employed as a Part time Investigator (Sworn Position) with the New Hampshire Cold Case Unit which was collaboration between the New Hampshire Department of Justice and the New Hampshire State Police to investigate unresolved homicide, suspicious death and missing person cases.

A majority of my law enforcement career was as a sworn Police Officer with the Manchester NH Police Department for 24 years retiring in 2009.

The Evidence Division takes in over 11,000 pieces of property per year to include high-risk items including firearms, drugs, and valuables.
