Documenting ESPC Job Creation

Oceans Salon A

Energize Delaware created a Guaranteed Energy Saving Performance Contract (GESPC) job tracking program using Excel Spreadsheets. Job creation and support for construction trades is an important aspect of ESPC programs for political decision makers. The value of GESPCs program is significantly increased by showing credible job data.

Starting in 2018 Energize Delaware required Energy Service Companies (ESCs) to complete quarterly job tracking spreadsheets. ESCs for two school districts and one state agency using Energize Delaware funding participated. Together they had nearly \$20 million in contracts and logged over 75,000 job hours over the three years to completion. The program tracks job hours by job types and by subcontractors over time. Energize Delaware will present its findings, analyzing job hours by job types, subcontractors, and contract dollars.
