EXPLANATION

The National Criminal Justice Association (NCJA) was founded in 1971 to promote the development of justice systems that "enhance public safety; prevent and reduce the harmful effects of criminal and delinquent behavior on victims, individuals, and communities; adjudicate defendants and sanction offenders fairly and justly; and that are effective and efficient" (from the NCJA Mission Statement). Based in Washington, D.C., the NCJA represents state governments on crime prevention and crime control issues and is a national voice in shaping and implementing criminal justice policy. Its members represent all facets of the criminal and juvenile justice community. In addition to its efforts to educate lawmakers about the effect of policy and budgetary decisions, the NCJA provides training for grant administrators; informs agencies about grants and legislative actions of concern to the criminal justice systems; and provides monthly publications and other materials on Congressional and federal activities.


A separate attachment is being provided to answer the standard questions required for organizational dues and memberships.

Standard questions required for Governor and Council for organization dues and membership approval submissions:

1. *How long has this organization been in existence and how long has this agency been a member of this organization?*

The organization has been in existence since 1971. The agency has been a member since 1985.

2. *Is there any other organization which provides the same or similar benefits which your agency belongs to?*

The DOJ does not belong to another a similar organization.

3. *How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member?*

This organization is made up of all 50 States. The Department of Justice is the sole NH state agency belonging to this organization.

4. *How is the dues structure established?*

The NCJA dues are based on state population with states being divided into “tiers.” The increase in the rates is based on the CPI Index.

5. *What benefit does the state receive from participating in this membership?*

Based in Washington, D.C., the NCJA represents state governments on crime prevention and crime control issues and is a national voice in shaping and implementing criminal justice policy. The NCJA also provides training for grant administrators; informs agencies about grants and legislative actions of concerns to the criminal justice systems; and provides monthly publications and other material on Congressional and federal activities. It is an important resource for bringing in federal grants for New Hampshire.

6. *Are training or educational/research materials included in the membership? If so, is the cost included.*

Yes, some of the items included are as follows:
