## **REQUESTED ACTION**

1. Authorize the Department of Transportation to enter into a contract with R.M. Piper, Inc. (Vendor 174180) of Plymouth, NH on the basis of a low bid of \$1,033,907.20 for bridge preservation work on the bridge that carries NH 25 over Oliverian Brook in Haverhill, from the date of Governor and Council approval through October 4, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$103,390.72 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 10% of the contract amount.

#### **EXPLANATION**

This project is part of the State's Ten Year Transportation Improvement Plan under the Bridge T1/T2 Maintenance and Preservation Program. This project is located in the town of Haverhill, NH and performs bridge preservation and rehabilitation work on Br. No. 067/092 that carries NH 25 over Oliverian Brook. This project is located approximately 3 miles west of the Haverhill/Benton town line. Bridge work is as follows: remove existing pavement and waterproofing membrane, replace the southerly coping, replace bridge and approach highway rail components along southerly fascia (3-bar aluminum rail replaced with T3 steel rail and EAGRT terminal unit in SE quadrant), construct stub walls on existing approach slab at expansion end of bridge to facilitate moving expansion joint behind backwall, replace fixed and expansion joints, conduct repairs to the concrete deck, replace 3 expansion bearings, place new waterproofing membrane and pavement on deck, mill and place approach pavement for pavement match, paint girder ends, and conduct repairs to the abutments and wingwalls.

This bridge is currently #15 on the Maintenance and Preservation priority list and this work is intended to extend the bridge service life before full deck replacement is needed.

The Contingency amount is proposed to be 10%. This work rehabilitates a bridge that has not seen preservation work. The wingwalls, abutments and backwalls are heavily map-cracked and while 50% of the surface was estimated as needing repair, the amount could be higher. In addition, the amount of deck estimated for repair is based on the condition of the asphalt covering the deck. The full extent of the necessary repairs on both the wall/abutment surfaces and the deck won't be known until the wall can be sounded and the deck exposed by removing the existing asphalt and membrane.

Although the bid costs exceeded the Department's estimate by 17.01%, the low bid of 4 bids received is felt to be reasonable for the work involved. There were 6 items that contributed to the majority (99%) of the overage. They involved bridge pavement removal and deck repair, bridge shoes, temporary traffic control (2) and mobilization. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% Federal Funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

### SUPPLEMENTAL PROJECT INFORMATION SHEET

**DESCRIPTION:** This project is located in the town of Haverhill, NH and performs bridge preservation and rehabilitation work on Br. No. 067/092 that carries NH 25 over Oliverian Brook. This project is located approximately 3 miles west of the Haverhill/Benton town line. Bridge work is as follows: remove existing pavement and waterproofing membrane, replace the southerly coping, replace bridge and approach highway rail components along southerly fascia (3-bar aluminum rail replaced with T3 steel rail and EAGRT terminal unit in SE quadrant), construct stub walls on existing approach slab at expansion end of bridge to facilitate moving expansion joint behind backwall, replace fixed and expansion joints, conduct repairs to the concrete deck, replace 3 expansion bearings, place new waterproofing membrane and pavement on deck, mill and place approach pavement for pavement match, paint girder ends, and conduct repairs to the abutments and wingwalls.

**FEDERAL FUNDING:** 80% (Bridge-T1-2 Maintenance-Preservation) with Turnpike Toll Credits utilized for the State's 20% match

**CONTINGENCY:** The Contingency amount is proposed to be 10%. This work rehabilitates a bridge that has not seen preservation work. The wingwalls, abutments and backwalls are heavily map-cracked and while 50% of the surface was estimated as needing repair, the amount could be higher. In addition, the amount of deck estimated for repair is based on the condition of the asphalt covering the deck. The full extent of the necessary repairs on both the wall/abutment surfaces and the deck won't be known until the wall can be sounded and the deck exposed by removing the existing asphalt and membrane.


**PROJECT INITIATED:** State's 10-Year Transportation Improvement Program.



In addition, pedestrian access will be maintained across the existing sidewalk or through a temporary pedestrian access way through the work area during sidewalk construction. In addition, a temporary pedestrian crosswalk will be used to allow pedestrian to cross NH 25.
