REQUESTED ACTION

EXPLANATION

This is the fourth of five remaining requests, all to be presented to Governor & Council on June 1, 2022. This request is made retroactively because the Division of Public Health Services received permission from the Division of Personnel to apply retroactive temporary reclassifications to select staff who worked out of classification as part of the COVID-19 response.
