EXPLANATION

These modules, as part of the Bachelor in Management with a Public Administration Concentration: Defining and Communicating a Brand; Human Resource Management; Business Law; and Foundations of Financial Accounting, will benefit the employee and the Department by increasing Ms. Lacey's ability to deliver in a clear and concise manner a variety of information in order to document improvement of the state mental health system, and to effectively coordinate and collaborate with a diverse group of internal and external partners who work together to fulfill Community Mental Health Settlement Agreement (CMHA) requirements.

The Defining and Communicating a Brand and Human Resources Management modules are relevant to her position due to the leadership and strategic pathways supporting and navigating integration of the CMHA's broad scope. Business Law is relevant as she coordinates interagency teams performing CMHA related activities that intersect with contracted vendors. Foundations of Financial Accounting is important as she researches vendor related financial matters, including analyzing funding needs and the appropriateness of expenditures regarding CMHA compliance. Successful completion of the program will add to the Division's ability to achieve the goals envisioned in the CMHA; to improve its broad oversight of the state mental health system; and will add to the overall strength of the Department to perform its mission to the residents of New Hampshire.

Diana Lacey has been employed by the Department of Health and Human Services for twenty five (25) years and is currently a Program Planning and Review Specialist in the Division for Behavioral Health. She oversees and facilitates compliance with the 2014 Amanda D. v. Hassan Settlement Agreement, including coordinating a variety of activities that support progressive system improvement, monitoring and reporting on required deliverables, preparing presentations, convening stakeholder meetings, and identifying additional activities needed to further achieve CMHA goals.

The Department of Health and Human Services encourages and supports employees who wish to further their professional growth through continuing education in disciplines that are mutually advantageous. College for America at Southern New Hampshire University has partnered with the State of New Hampshire to provide state employees with low-cost, competency-based associate and bachelor degree programs.

THE STATE OF NEW HAMPSHIRE EDUCATIONAL TUITION AGREEMENT

Agreement dated this 30th day of July 2019 by and through the Department of Health and Human Services (hereinafter referred to as the "State) and Diana Lacey (hereinafter referred to as the "Recipient"). The State and the Recipient do hereby mutually agree as follows:

- 1. The State shall pay to the named institution the sum of \$1,000, which monies shall be used for the purpose of enrolling the Recipient in: Public Administration, Modules in Management (Defining and Communicating a Brand, Human Resource Management, Business Law, Foundations of Financial Accounting) (course name), which course(s) is being offered by SNHU College for America and which course(s) shall commence on September 2, 2019 and terminate on December 22, 2019.
- 2. The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.
- 3. Should the Recipient fail to complete or achieve a passing grade in each course named in paragraph 1, the Recipient shall pay to the State the sum set forth in paragraph 1, provided, however, that if more than one course is named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rata basis.
- 4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.
- 5. The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.
- 6. Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.
- 7. The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.
- 8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
