#### **REQUESTED ACTION**

The Insurance Department respectfully requests, pursuant to RSA 94:6, that the Governor and Executive Council authorize the Department to hire Maureen Mustard into the position of Healthcare Statistician, position #9U248 (an unclassified position at labor grade DD) at Step MAX with an annual salary of \$78,591.34, effective June 12, 2015.

The source of funds is 100% agency income.

#### **EXPLANATION**

RSA 94:6 states that

In case of a new appointment to fill any vacancy the entrance salary shall be at the minimum of the established range unless, upon recommendation of the appointing authority, the governor and council shall establish, after due and proper investigation as to qualifications, a different entrance salary within the established range.

This position is responsible for fulfilling statutory requirements for developing data systems, analyzing healthcare costs, and reporting on our insurance markets. It must manage both internal and external resources, including vendors responsible for providing high level economic, actuarial and statistical studies to the Department.
