REQUESTED ACTION

Pursuant to RSA 14:30-a, VI, authorize the Department of Safety, Division of Motor Vehicles (DMV), to amend Fiscal Committee item #21-311 approved October 22, 2021, and G&C item #102 approved October 27, 2021 to improve Commercial Driver License (CDL) participation rates, by reallocating \$50,000.00, effective upon Fiscal Committee and Governor and Council approval through June 30, 2023. 100% Federal Funds.

EXPLANATION

The Division of Motor Vehicles (DMV) requests authorization to transfer funds to accommodate an increase in costs for the purchase of the mobile DMV office vehicle. This vehicle will be driven to Commercial Driver License (CDL) testing locations to provide the ability to issue credentials on-site. Funding is available in the Salary for Temporary Employee line due to savings realized from full-time temporary Licensing Examiner II vacancies. The DMV is in final discussions with the vendor regarding the timelines for build and delivery of the mobile DMV office. The timelines are contingent on approval of funding and issuance of a purchase order.

The DMV has been working closely with the Department of Transportation, the Department of Public Works, and the Department of Environmental Services to continue moving forward with improvements to the CDL site in Lebanon and the establishment of CDL testing sites in Epping and at the Raymond S. Burton Training facility in Bethlehem. Estimates for needed work at the Lebanon and Epping sites are completed. Scheduling for work in Epping is underway. A Request for Bids for work on the Lebanon site is planned for release in August. Meetings with architects and site planners to determine the scope of work for the Bethlehem site are anticipated in July.

Recruitment efforts for CDL examiners are ongoing with coordinated messaging with industry partners and through advertisements. The DMV is also working with the Department of Business and Economic Affairs to attract drivers to the industry and to ensure CDL applicants are better prepared for examinations.

Funds are to be budgeted as follows:

- Class 30, Equipment – Funds are required to purchase a mobile DMV office vehicle due to increased costs.
- Class 59, Temporary Employees – Funds are available to transfer due to Licensing Examiner II vacancies.

In the event the Federal funds become no longer available, General and/or Highway funds will not be requested to support this program.

REQUESTED ACTION:

- Pursuant to RSA 14:30-a, VI, authorize the Department of Safety, Division of Motor Vehicles, to accept and expend \$3,192,099 of American Rescue Plan Act of 2021 (ARPA), State and Local Fiscal Recovery Funds (FRF), for the purpose of improving New Hampshire's Commercial Driver License (CDL) participation rates by adding testing sites, personnel, and mobile equipment. This is an allowable use of ARP FRF funds under Section 602(c)(1)(A) to respond to the public health emergency or its negative economic impacts. Effective upon Fiscal Committee and Governor and Council approval through June 30, 2023. Funding Source: 100% Federal Funds.
- Pursuant to RSA 124:15, and contingent upon the approval of requested action #1, authorize the Department of Safety, Division of Motor Vehicles to establish four full-time temporary Licensing Examiner II positions to oversee the additional CDL program functions. Effective upon Fiscal Committee and Governor and Council approval through June 30, 2023. Funding Source: 100% Federal Funds.

EXPLANATION

The COVID-19 pandemic has changed the way consumers and businesses acquire products, changing the shipping industry and putting massive pressure on the logistics industry nationwide. A shortage of commercially licensed drivers and changing federal rules in 2022 will likely accelerate these serious issues across a wide range of transportation needs, including tractor-trailers, heating oil/propane delivery, tankers, public and school buses, box trucks, and hazardous materials transports. In 2019, the state had 32,510 licensed CDL drivers. As of July, 2021 that number dropped to 29,362, reflecting a loss of 3,148 licensed CDL drivers since the start of the COVID-19 pandemic.

In order to address this, the Department of Safety, Division of Motor Vehicles (DMV) will utilize these funds to support the state's commercial transportation and logistics industries in retaining and attracting new drivers by increasing the availability of resources to ensure those candidates have a clear pathway to a commercial driver's license (CDL). The DMV will expand its ability to meet increased demand and improve efficiency by adding testing sites, personnel, and mobile equipment. New testing sites will be located in Bethlehem, Lebanon (expansion of existing site), Hillsboro, and Epping, adding to the existing locations offered including Concord, Nashua, Durham, Lebanon and Twin Mountain. This will ensure that CDL candidates that complete written test requirements and obtain a CDL permit, can expeditiously schedule a skills test examination without the need to travel to a distant testing site.

The DMV currently employs four full time Licensing Examiner II CDL positions. With the addition of four more, the number of available test appointments will increase considerably. At this time, there is no way to determine exactly how many additional knowledge and skills tests will be completed as it will be determined by number of applicants who choose to obtain a commercial driver license. These full-time temporary positions will be posted once approved and the division will utilize any and all recruitment methods available to fill these positions as quickly as possible. Selected candidates who do not currently have a CDL must obtain one within 6 months of hire date.

A total of \$3,847,869 was awarded to improve CDL participation rates effective October 1, 2021 through December 31, 2024. This item requests authorization to accept and expend the funds through June 30, 2023. The remaining \$655,770 will be budgeted in the FY24/25 biennial budget.

This is an allowable use of ARP FRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts.

Funds are to be budgeted as follows:

- Class 018 – Overtime: Used to reimburse current full time employees
- Class 020 – Current Expense: To purchase supplies, fuel and maintenance for vehicles
- Class 030 – Equipment: To purchase laptops, tablets and vehicle for CDL program
- Class 039 – Telecommunications: Represents costs for cell phones and cellular service for tablets used to conduct remote CDL driving tests.
- Class 040 – Indirect Costs: Represents the indirect cost associated amount for this request at 8.5%
- Class 041 – Audit Fund Set-Aside: Represents the audit fund set-aside associated amount for this request
- Class 059 – Salary Temporary Employees: Used to pay wages for five new full-time positions
- Class 060 – Benefits: To pay associated benefits for five new full-time positions
- Class 066 – Employee Training: To cover costs for training for CDL program employees
- Class 103 – Contracts for Operational Services: To cover costs associated contracted services as needed for the CDL Program

The following information is provided in accordance with the comptroller's instructional memorandum dated September 21, 1981:

- 1) *List of personnel involved:* Four (4) full time temporary Licensing Examiner II (LG 16). The proposed funding for these positions ends December 31, 2024.
- 2) *Nature, Need, and Duration:* These positions are needed to assist with the enhancement of the CDL program in response to the shortage of commercially licensed drivers.
- 3) *Relationship to existing agency programs:* These positions will enhance the current CDL program by adding additional availability of testing and enhanced public knowledge about the program.
- 4) *Has a similar program been requested of the legislature and denied?* No.
- 5) *Why wasn't funding included in the agency's budget request?* These funds were recently awarded and unanticipated at the time the budget was created.
- 6) *Can portions of the grant funds be utilized?* All grant funds can only be used for the eligible work described above.
- 7) *Estimate the funds required to continue this position:* Funds for these positions are estimated at \$802,673 for the duration of the grant through December 31, 2024.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.
