

BOARD OF AUCTIONEERS MINUTES

June 2, 2014, 9:00 a.m.

1. The Board of Auctioneers convened at 9:00 a.m. with, Chairman Russell R. Abbott, Vice-Chairman Roy W. Tilsley, Secretary Gregory J. Walsh, and Member Robert P. Secord present. Member Richard C. Berman was absent.
2. The Board on motion of Gregory J. Walsh, seconded by Robert P. Secord accepted the minutes of the May 5, 2014 meeting.
3. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Blake E. Benson for an Auctioneers License.
4. The Board on motion of Gregory J. Walsh, seconded by Robert P. Secord, authorized the application of Steven J. Claheta for an Auctioneers License.
5. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Donald Champney for an Auctioneers License.
6. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Jason D. Gray for an Auctioneers License.
7. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Arthur (Bucky) H. Lewis III for an Auctioneers License.
8. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Matthew C. Morrisette for an Auctioneers License.
9. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized to schedule the next two meetings as follows:

  - August 4, 2014 – 10:00 a.m.
10. The Board discussed Rules.
11. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, and further on a roll call vote as follows: Russell R. Abbott – yes, Roy W. Tilsley – yes, Gregory J. Walsh – yes, Richard C. Berman – absent, and Robert P. Secord – yes, voted to go into non-public session to discuss matters under RSA 91-A, specifically, matters which would likely adversely affect the privacy of individuals and or matters in which litigation has been threatened against the Board.
12. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord voted to come out of non-public session.

13. Further Business:

- A. Previously at the meeting of April 7, 2014, the Board made a motion to send a Cease and Desist letter to Matthew Lyman for conducting an auction without a license. Matthew Lyman claimed that he did not conduct said auction and that he was not the listed "auctioneer" for the sale. This matter was forwarded to the Attorney General's Office for review. Upon review the Board found no evidence that Matthew Lyman conducted this auction. This matter is dismissed.
- B. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, and with Gregory J. Walsh abstaining, voted to remove from the table, item # 12, which was previously tabled at the January 6, 2014 meeting.

#12           Based on the investigation and report of Gregory J. Walsh, the Board found no evidence to merit a hearing on the complaint made by Cheyl A. Wolczok. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, and with Gregory J. Walsh abstaining, voted to dismiss the complaint.
