

REQUESTED ACTION

- 1. Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of Health and Human Services, Bureau of Client Services to accept and expend Federal Funds in the amount of \$1,774,953 from the Centers For Medicare and Medicaid Services for purposes of making changes to the New HEIGHTS eligibility system to comply with federally required guidelines, assessment of New HEIGHTS based on the security and privacy controls in Minimum Acceptable Risk Standard for Exchanges (MARS-E); improving operational efficiencies through automation, and boosting client accessibility and continuity of service effective upon date of Fiscal Committee and Governor and Executive Council approvals through June 30, 2020, and further authorize the allocation of these funds in the accounts below. 100% Federal Funds.
- 2. Contingent upon approval of Requested Action #1, pursuant to RSA 124:15, authorize the Department of Health and Human Services to increase Class 046 - Consultants to amend a contract for the purposes as described in Requested Action #1 effective upon Fiscal Committee and Governor and Council approvals through June 30, 2020. 100% Federal funds.

EXPLANATION

This request is being made to ensure compliance with the federal regulations as they relate to system security, the modernization of the New HEIGHTS infrastructure, and to provide functionality to support DHHS's strategic vision for improved service delivery. The scope of work this funding provides will allow DHHS to complete remediation activities, manage risk and deploy functionality required to support efficient operations of the Medicaid program. To accommodate these changes, the Department's New HEIGHTS eligibility system requires modifications including:

- Assessment of security and privacy controls based on MARS-2.1 (Minimum Acceptable Risk Standards for Exchanges) standards
- Enhancements to Long Term Services and Supports to automate some of the processes and Case Management functionality
- Medicaid notices consolidation
- Processing Medicaid Applications using Optical Character Recognition (OCR)
- Enhancements to DHHS staff workflow management by providing a holistic "one stop shop" cases view. This will provide consolidated information related to a case including outstanding tasks and upcoming appointments

To support these efforts, the Centers For Medicare and Medicaid Services, United States Department of Agriculture, Food and Nutrition Services, and the Administration for Children and Families, Foster Care Program under Title IV-E is making available federal funds for states' efforts for these modifications. The Department has been implementing significant enhancements to New HEIGHTS under a capital budget project and the work contemplated by this funding will, with approval by Governor and Executive Council, be integrated with the work being done under the capital budget project.

This acceptance is contingent upon receiving federal approval for the Implementation Advance Planning Document Update (IAPD-U) submitted on December 9, 2019. This request is being brought forward in order to have the funds in place once the approval and award is received in order to expedite the contract amendment with the vendor.

Class 041 The funds will be used to pay audit fund set aside expense.

Class 046 The funds will be used to fund the required contract amendment.

The following information is provided in accordance with the Comptroller's instructional memorandum dated September 21, 1981.

- 1. List of personnel involved: Temporary consultants
- 2. Nature, Need, and Duration: The temporary consultants will provide for the increased needs for subject matter experts beyond the limited resources of in-house personnel.
- 3. Relationship to existing agency programs: within the New HEIGHTS system ensure compliance with the federal regulations as they relate to system security, the modernization of the New HEIGHTS infrastructure, and to provide functionality to support DHHS's strategic vision for improved service delivery.
- 4. Has a similar program been requested of the legislature and denied? No
- 5. Why wasn't funding included in the agency's budget request? At the time of budget submission it was unknown what enhancements and work would need to be completed and the amounts to ensure compliance with federal regulations as well as Department objectives.
- 6. Can portions of the grant funds be utilized? All grant dollars are being used for this request.
- 7. Estimate the funds required to continue this position(s): The consultants necessary for this work will not be permanent.

Funding for the project is 100% Federal Funds.
