Re: **PETITION – Claremont, X-MGS-STP-X-0131(039), 13248**

The Department of Transportation requests placing this item on the Consent Calendar.

Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed reconstruction of NH 12/NH 103 (Main Street) and North Street in the City of Claremont.

Since the Petition is not for the limitation or control of access, a Commission of 3 persons should be appointed by the Governor, with the advice of the Executive Council, to hold a hearing. The Commission of 3 persons shall determine whether there is occasion for the laying out or alteration of NH 12/NH 103 (Main Street) and North Street in the City of Claremont as presented at the hearing.

The purpose of the project is intersection improvement to NH 12 / NH 103 and North Street, adding exclusive left and right turn lanes, widening shoulders and improving the road profiles to alleviate periodic flooding from the Sugar River. This project may impact historic properties.

The suggested Commission Members were discussed with Executive Councilor Kenney on August 28, 2017.

In accordance with RSA 230:14, I, Victoria F Sheehan., Commissioner of the New Hampshire Department of Transportation, propose reconstruction of the NH 12/ NH 103/ North Street intersection for safety and to improve bike and pedestrian accommodations in the City of Claremont, at the locations given below:

**CLAREMONT, X-MGS-STP-X-0131(039), 13248**

This project will consist of reconstruction and safety improvements to the North Street/ NH 12/ NH 103 (Main Street) intersection. It is anticipated lane configurations may be altered to safely accommodate turning movements. It is envisioned improvements will include accommodations for bicycle and pedestrian traffic. The project will include improvements to the North Street profile and the NH 12/ NH 103 profile to alleviate periodic roadway flooding from the Sugar River.

This project will impact historic properties.

Therefore, in accordance with RSA 230:14, I, Victoria F Sheehan, Commissioner of the New Hampshire Department of Transportation, propose the improvements to NH 12/ NH 103 in the City of Claremont, New Hampshire.
