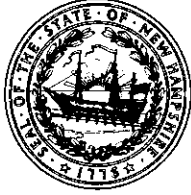



***Attachment to Addendum A, Section V**
