EXPLANATION

The Department is requesting to (i) accept additional agency federal DSHP revenue in the Bureau of Drug & Alcohol Services, (ii) transfer other funds from the Bureau of Drug & Alcohol Services to the Medicaid IDN Fund and (iii) transfer general funds from Medicaid to the State Phase Down account.

The Department seeks to accept additional DSHP revenue not budgeted in the Bureau of Drug & Alcohol Services to allow for the transfer of other funds to the Office of Medicaid Services IDN Fund. As part of the New Hampshire Building Capacity for Transformation 1115 Waiver from the Centers for Medicare and Medicaid Services (CMS), CMS has granted authority for DHHS to receive federal matching funds for costs not otherwise matched.

The Department seeks to utilize additional agency income earned in the IDN Fund to supplant general funds to lapse at year end to meet the Department's lapse target amount. The IDN Fund serves as the vehicle for Delivery System Reform Incentive payments (DSRIP) to regionally based Integrated Delivery Networks (IDNs) that furnish Medicaid services. IDNs are comprised of individual providers that form coalitions and are used as a means to foster relationships between behavioral health providers and other community health care providers to achieve the vision of a transformative integrated delivery system. IDN payments are not direct reimbursement for expenditures for services. Rather payments from the IDN fund are intended to support IDNs and their participating providers for integrating behavioral and physical health, expanding provider capacity, and reducing gaps in care during transitions.

The Department requests to transfer the general funds from 52010000 IDN Fund as the account contains a budget footnote *F. This appropriation shall not lapse until June 30, 2019.* The general funds are requested to be transferred to the State Phase Down 79390000 accounting unit where the general funds will lapse at state fiscal year end.

The following is the information specifically required when transfers are requested, in accordance with the Budget Officer's instructional memorandum dated April 17, 1985, to support the above requested actions:

- A. Justification: As noted above, this accept and expend request is utilizing available surplus. The DSHP revenue was under budgeted and Bureau of Drug & Alcohol Services has earned more than anticipated.
- B. Does this transfer involve continuing programs or one-time projects? This transfer involves continuing programs.
- C. Is this transfer required to maintain existing program levels or will it increase the program level? This transfer is required to maintain existing program levels and to lapse surplus general funds at state fiscal year end.
- D. Cite any requirements which make this program mandatory.
 The programs of the Department are mandated by various state and federal laws.
- E. Identify the source of funds on all accounts listed on this transfer. 047-5201 is 50.63% federal funds, 43.8% general funds and 5.57% other funds; 047-7939 is 100% general funds; 092-3382 is 17% federal; 36% general funds; 47% other funds
- F. Will there be any effect on revenue if this transfer is not approved? Yes, the surplus funds currently reside in a non-lapsing account. If this transfer is not approved, the surplus general funds would be carried forward into state fiscal year 2019 and would not lapse.
- G. Are funds expected to lapse if this transfer is not approved? AU 3382 Bureau of Drug and Alcohol and AU 5201 IDN Fund are non-lapsing accounts
- H. Are personnel services involved?No positions are being transferred as a result of this request.
