EXPLANATION

The Federal Emergency Management Agency (FEMA) Public Assistance (PA) Grant Program under the Crisis Counseling Immediate Services Program (ISP) provides crisis counseling services to the survivors of Coronavirus Disease 2019 ("COVID-19") for which the President declared a major disaster on April 3, 2020. This declaration, designated FEMA-4516-DR-NH, was amended on April 30, 2020 to authorize the Crisis Counseling Program.

This request will fund the ISP in New Hampshire, which is designed to assist individuals and communities in recovering from the effects of natural and human-caused disasters through the provision of community-based outreach. The ISP supports short-term interventions, providing emotional support and encouraging linkages with other individuals and agencies who may help survivors in their recovery process.

In order to maintain current efforts, the State plans to contract with Granite United Way as our partner to answer crisis calls and warm transfer to DBHRT full-time staff, and/or the SAMHSA Disaster Distress Helpline. These services will be provided using the 211 system as a conduit for callers to connect with crisis counselors. The crisis counseling will be conducted as outreach services which will be provided telephonically to workers under stress caused by the COVID-19 crisis. The NH 211 system already employs this facilitation model to connect callers seeking assistance with opioid or other substance use disorder treatment to the Doorway-NH Program which has doorways to treatment located throughout the State of New Hampshire. This crisis counseling initiative will serve as virtual a psychological first aid station for our callers. If we are unable to meet the immediate needs of the callers, we will assist them in connecting to the expanded capacity created within the State's Community Mental Health Center

network by the NH Rapid Response grant, the National Suicide Prevention Lifeline, SAMHSA Disaster Distress Helpline, the Veteran and First Responder Healthcare COVID-19 effort, and others. Outreach to the community of healthcare workers, first responders and funeral service workers will take the form of increased media, social media and web presence. These services will be provided by Granite United Way as our partner agency under contract with the State.

Additionally, under their auspices, care packages will be assembled and disseminated to the front line workers which will contain information on self-care, a brochure about crisis counseling services, and a take-away with logo and call line information. The State has a current system of distribution for PPE to first responders, healthcare providers and funeral service workers. We plan to utilize this well-choreographed effort as a delivery system for our care packages. When facilities arrive to retrieve their PPE, they will be provided with a supply of care packages for dispersal within their facility or network. We will distribute our care packages with advance request to the locations that they place the bags in areas such as day rooms and break rooms where staff might be drawn to them. Granite State Healthcare Coalition and the regional Public Health Networks will assist with the dissemination and delivery of these materials to our target population. The staffing structure will be as follows: Granite United Way (GUW) will provide staffing and oversight for the marketing activities as well as coordination with 211 for connection
