REQUESTED ACTION

Pursuant to RSA 94:6, the Insurance Department respectfully requests the Governor and Executive Council to authorize the Department to establish the salary for Colin Wilkins, Chief Financial Examiner (Group GG) at Step 4 (\$89,389.98) effective upon Governor and Council approval with an effective date of 12/12/14".

The source of funds is 100% agency income.

EXPLANATION

This is an unclassified position that is being filled through a promotion from within the Insurance Department. The appointee, Colin Wilkins, has served with distinction since February, 2005 in the financial regulation division of the Insurance Department as a Financial Examiner. In the last year, after retirements in the unit, Mr. Wilkins was asked to take on the additional responsibilities of acting as the Chief Financial Examiner, managing not only staff but also the efforts of consultants that were brought in on various financial examinations. He has done an excellent job of handling the additional responsibilities and of adapting to his shifting role. Mr. Wilkins is currently compensated at \$82,797 (LG 31, Step 8). If this new position was a classified position, then this promotion would be governed by Per 901.08, which states that "[w]hen a qualified employee is promoted, the appointing authority shall assign the lowest step in the salary range of the new class which is at least the equivalent of one salary increment in the salary range of the former class." Applying this same principle that a promotion with increased responsibility ought to result in a pay raise of at least one increment, Mr. Wilkins would start at Step 4 (\$89,389.98) of Group GG. The Council's authority to approve this salary as Mr. Wilkins's starting salary rests in RSA 94:6. For further details on Mr. Wilkins's qualifications, please see the attached resume.
