REQUESTED ACTION

Authorize the Department of Justice to enter into sub grants totaling \$15,375 with the agencies listed below, from the United States Department of Justice's Office of Juvenile Justice and Delinquency Prevention's FFY 2010 Enforcing Underage Drinking Laws (EUDL) Block Grant Program for increased enforcement of New Hampshire's underage drinking laws from the date of Governor and Executive Council approval through August 31, 2013. These supplemental sub grants will allow the sub grantees to continue their educational and enforcement-related activities in their communities and in their regions.


