### **EXPLANATION**

The Water Division's Dam Bureau Engineering & Construction (E&C) Section performs routing inspections, repairs, and maintenance on 278 state-owned dams in New Hampshire. This work sometimes requires underwater inspections, maintenance, and construction. For safety reasons on larger projects, or in the event of personnel illness or injury, it is prudent to have four trained divers available to the Section. The E&C Section currently only has two certified SCUBA divers. These four divers would then be available for emergency repair work, including repairs of a larger nature or at multiple facilities that would require a second team of certified personnel. The

E&C Section is currently only able to safely perform smaller tasks at one location for underwater inspections or construction activities.

Mr. Robert W. Gordon, Jr., an E&C Construction Foreman, has expressed interest in obtaining SCUBA certification. The proposed course is directly related to Mr. Gordons' work. Mr. Gordon has signed a contract, which obligates him to work for the State for six months after satisfactory completion of the course. He must also complete and achieve a passing grade for the course. If he does not comply with the terms of the contract, he will be liable for returning the amount paid. It should be noted that the course will be held from 6:30 to 9:30 p.m. one night per week and will not affect the normal workday.

A separate request for Mr. Jason Bisson, an E & C Construction Technician, is being routed at the same time. Together, these two individuals will fill the third and fourth diver slots. It is preferable to have the two divers take the course together, so that they can develop their diving skills as a team, which will allow them to work more efficiently together in performing the work of the Section.

The inspection and repair of dams is a specialized field. Commercial diving services, that are capable of performing this specialized work, are expensive and difficult to schedule. When the Dam Bureau has investigated the feasibility of using commercial diving services in the past, it has received quotes of over \$1,500.00 per day for two divers. Having qualified, experienced diving personnel working on the Dam Bureau's E&C crew provides both a significant cost savings to the State as well as the ability to respond rapidly to emergency situation at State-owned dams.

	Agreement dated this day of October 2014 by and through					
the Department of Environmental Services (hereinafter referred to as the "State) and						
	Robert W. Gordon, Jr. hereinafter referred to as the "Recipient").					
	The State and the Recipient do hereby mutually agree as follows:					
1.	The State shall pay to the named institution the sum of be used for the purpose of enrolling the Recipient in:					
PADI Open Water Diving						
	which course(s) is being offered by Divers Den Dive Shop, Inc and which course(s)					
	shall commence on <u>November</u> 6 <u>14</u> and terminate on <u>December</u> 18 <u>14</u>					
2.	The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.					
3.	. Should the Recipient fail to complete and achieve a passing grade in each course named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rata basis.					
4.	Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.					
5.	The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.					
6.	Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.					
7.	The Recipient shall not raise any setoff or counterclaim against the State in any action					

brought by the State to collect any amount due under this agreement.

8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
