EXPLANATION

These courses, Economic Theories; Introduction to Ethics; Decoding Media; and Introduction to Psychology will benefit Ms. Hodge and the Department by allowing Ms. Hodge to develop professional research skills, discover new approaches to problem solving, and engage in analysis for a deeper understanding of cultural issues. Economic Theories will look at irrational versus rational decision making, market structure, market failure, resource markets, and other economic principles. Modern theory of consumer behavior will be discussed, along with optimization models for achieving and analyzing productive, allocative, and distributive efficiency. Decoding Media covers mass media, culture, and society, and focuses on how and why the US media operate as they do, as well as, on how media performance might be improved. Introduction to Psychology provides an introduction to the scientific study of behavior and mental processes and discusses how to evaluate research within the discipline. Introduction to Ethics discusses ethical theory or the study of how people make decisions about how to treat one another. These skills are necessary for Ms. Hodge to be effective as a Family Services Specialist I and will enhance her case management skills.

Holly Hodge has been employed by the Department of Health and Human Services (DHHS) for four (4) years and is currently a Family Services Specialist I in the Bureau of Family Assistance, Division of Economic and Housing Stability. She also currently serves as the Medicare Buy-In Coordinator for DHHS. Her duties entail interviewing a diverse array of clients and making referrals for assistance as needed, often in emergency situations which are extremely stressful for her clients. She must also evaluate information to assess eligibility while applying complex state and federal policies. She is also expected to testify at Administrative Appeal Hearings when necessary.

The Department of Health and Human Services encourages and supports employees who wish to further their professional growth through continuing education in disciplines that are mutually advantageous. Successful completion of the program will add to the overall strength of the Department to perform its mission to the residents of New Hampshire.

This course will not be taken on State time.

THE STATE OF NEW HAMPSHIRE EDUCATIONAL TUITION AGREEMENT

Agreement dated this 21st day of March, 2019 by and through the Department of Health and Human Services (hereinafter referred to as the "State) and Holly Hodge (hereinafter referred to as the "Recipient"). The State and the Recipient do hereby mutually agree as follows:

- 1. The State shall pay to the named institution the sum of \$1,500.00, which monies shall be used for the purpose of enrolling the Recipient in: Modules in Business Management: Economic Theories; Introduction to Ethics;

 Decoding Media; and Introduction to Psychology (course name), which course(s) is being offered by SNHU College for America and which course(s) shall commence on May 1, 2019 and terminate on October 31, 2019.
- 2. The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.
- 3. Should the Recipient fail to complete or achieve a passing grade in each course named in paragraph 1, the Recipient shall pay to the State the sum set forth in paragraph 1, provided, however, that if more than one course is named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rata basis.
- 4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.
- 5. The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.
- 6. Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.
- 7. The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.
- 8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
