REQUESTED ACTION

PURSUANT to RSA 228:31, AUTHORIZE the Commissioner of the State of New Hampshire, Department of Transportation, to quitclaim whatever interest the State of New Hampshire may have in a one and seventeen hundredths (1.17) +/- acres parcel of land located on the westerly side of Harris Road in the Town of Windham to the Estate of Joseph Jarosky, Jr., Joanne Morrison, Executor. This transfer will be effective upon Governor and Executive Council approval. This is a no cost transaction.

EXPLANATION

As part of the Windham-Salem NHS-RS-RUR-M-STP-F-T-0381(005), 10075 project, the Department acquired property in 2003 from Joseph Jarosky, Jr. for the construction of this project. The Department acquired a larger parcel from Joseph Jarosky, Jr. and then reserved back to Joseph Jarosky, Jr. three (3) parcels that would not be required by the Department as part of the project.

Recently the Estate of Joseph Jarosky, Jr. has been surveyed in order to sell Mr. Jarosky's holdings. It was discovered that one of these properties was not reserved correctly to the estate, with the ownership of the parcel still being in the State of New Hampshire, placing a cloud on the title. The State did not intend to purchase the subject parcel and did not compensate Mr. Jarosky for the subject parcel.

The attorney for the Estate of Joseph Jarosky, Jr. has requested that the State of New Hampshire issue a Quitclaim Deed to the Estate of Joseph Jarosky, Jr. to correct this title defect.


This will be a no cost transaction as the Department wishes to act in good faith as part of the negotiations of the Windham-Salem 10075 project at the time to reserve this property back to Joseph Jarosky, Jr. as was contemplated during the original transaction in 1993. Moreover, the Department has not processed this as a disposal of State owned property as this transaction is merely intended to correct the title oversight that occurred during the original transaction. The Attorney General's Office has reviewed this matter and agrees that this will resolve this title issue.

Authorization is respectfully requested to quitclaim the State's interest in a one and seventeen hundredths (1.17) +/- acres parcel of land in the Town of Windham to the Estate of Joseph Jarosky, Jr., Joanne Morrison, Executor, as outlined above.




