EXPLANATION

This request is **retroactive** because a purchase order was not issued prior to the contractor being given authorization to perform the services. In addition, the item comes before Governor and Council because this invoice brings payment this vendor over the \$10,000 threshold for the fiscal year. The item was also **sole source**. There was an immediate need to repair of the front and main doors of the Department of Safety as they had failed and employees and visitors could not access the building. We hired Northeast Door because they had originally installed the doors and all the electronic hardware. For items less than \$2500, this process is not uncommon.

Because of this and a similar item on today's agenda, we have reviewed with relevant staff the requirements around purchase orders and the RQ10 process as well the MOP requirements that require items that are cumulatively more than \$10,000 to go through the Governor and Council process.
