**REQUESTED ACTION**

The Department of Transportation (DOT) requests placing this item on the Consent Calendar.

In accordance with the requirements approved by Governor and Executive Council on June 19, 2019 (Item #91), DOT is submitting an annual accounting of payments made during fiscal year 2020 pursuant to RSA 217-A, to the Department of Natural and Cultural Resources (DNCR) for reviews of rare plants and exemplary natural communities, as well as rare wildlife associated with DOT construction projects and maintenance activities. Attached please find a detailed reporting for the fiscal year ending June 30, 2020.

**EXPLANATION**

Pursuant to RSA 217-A:7, "All state agencies, consistent with their authority and responsibilities, shall assist and cooperate with the [DNCR] commissioner to carry out the purpose of this chapter. To the extent possible actions funded or carried out by state agencies shall not jeopardize the continued existence of any protected plant species or exemplary natural community." In addition, RSA 217-A:7-a establishes that the DNCR commissioner may charge a fee for screening NHB records for instances of protected species or environmental reviews.

**EXPLANATION**


Pursuant to RSA 217-A:7, "All state agencies, consistent with their authority and responsibilities, shall assist and cooperate with the [DNCR] commissioner to carry out the purpose of this chapter. To the extent possible actions funded or carried out by state agencies shall not jeopardize the continued existence of any protected plant species or exemplary natural community." In addition, RSA 217-A:7-a establishes that the DNCR commissioner may charge a fee for screening NHB records for instances of protected species or environmental reviews. The NHB has established a fee of \$25.00 for access to these records.

REQUESTED ACTION

1. Authorize the Department of Transportation (DOT) to retroactively make payments to the Department of Natural and Cultural Resources (DNCR) (Vendor #177887) Natural Heritage Bureau (NHB) for reviews of rare plants and exemplary natural communities, as well as rare wildlife associated with DOT construction projects and maintenance activities for FY 2019, in compliance with RSA 217-A, and NH Code of Administrative Rules Res 1105.02 Projects by State Agencies, effective upon Governor and Council approval through June 30, 2019.

Funding for this request is available for FY 2019 based upon the source of funds for each particular project or activity.

2. Further authorize the Department to enter into a Data Sharing Agreement (DSA) with NHB for \$532.00 for access to NHB data, which enables DOT to self-screen and review certain construction projects and maintenance activities in order to streamline environmental reviews, in compliance with RSA 217-A, and NH Code of Administrative Rules Res 1105.02 Projects by State Agencies, effective upon Governor and Council approval through January 23, 2020. 100% Highway Funds.

EXPLANATION

This item is retroactive because DOT began making periodic payments to NHB for environmental reviews beginning on July 1, 2018, with DSA data transmitted in September of 2018. It wasn't until after this time that DOT realized the \$10,000.00 interagency transfer threshold had been reached. The NHB is mandated by the Native Plant Protection Act of 1988 (RSA 217-A) to determine protective measures and requirements necessary for the survival of native plant species in the state, to investigate the condition and degree of rarity of plant species, and to distribute information regarding the condition and protection of these species and their habitats. The Nongame & Endangered Wildlife Program of the NH Fish & Game Department coordinates protection efforts for the state's wildlife that are not hunted, fished, or trapped. The Nongame Program works closely with NHB to maintain a database of rare and imperiled wildlife populations throughout the state.

Pursuant to RSA 217-A:7, "All state agencies, consistent with their authority and responsibilities, shall assist and cooperate with the [DNCR] commissioner to carry out the purpose of this chapter. To the extent possible actions funded or carried out by state agencies shall not jeopardize the continued existence of any protected plant species

or exemplary natural community." In addition, RSA 217-A:7-a establishes that the DNCR commissioner may charge a fee for screening NHB records for instances of protected species or environmental reviews. The NHB has established a fee of \$25.00 for access to these records.

The DSA further streamlines DOT's review of construction projects and maintenance activities by allowing DOT Bureau of Environment staff to access a subset of data for self-screening of projects/activities where:

- Construction is located within 15 feet of a paved roadway on paved/gravel or mowed areas; and
- All work is within the existing right-of-way; and
- Permits pursuant to RSA 482-A are not required; and
- Drainage work is conducted in-kind; and
- Coverage under the US Environmental Protection Agency's Construction General Permit is not required; and
- There is no change in the footprint of paved areas.

Having the flexibility for these payments is crucial to the nature of the work performed and completed by DOT.

Below is a summary of the payments made by the DOT to DNCR pursuant to RSA 217-A, and NH Code of Administrative Rules Res 1105.02 for the past two (2) fiscal years:



1. The data provided in this release will be available only to the following named users:

**NHDOT Bureau of Environment Staff**

All of these data are CONFIDENTIAL – FOR INTERNAL USE ONLY.

The provided digital data will not be copied, distributed, or made accessible in any form to other parties. By signing this agreement, the user affirms the ability to maintain the data in a secure environment. Any requests to the recipient by other parties for these data will be referred directly to NHHNB.

2. Temporary in-house copies of the data (e.g. to a flash drive or e-mail attachment) must be limited to the users named in term 1 above. They must be deleted from temporary storage locations as soon as the transfer is completed.
3. Any products derived from the data provided in this release (e.g., publications, reports or maps) *that are made available to anyone other than staff of the signatories to this agreement* will not show, describe or otherwise depict the location of NHHNB element occurrences.

The mapped locations (GIS polygons) that NHHNB is providing under this Agreement shall not be made public. However, elements can be listed or mapped as 'present' in a defined area as long as that area is at least two square miles in size (e.g., town, HUC10 watershed, etc.).

4. The data provided in this release will not be modified in any way except as needed to make them compatible with the recipients' geographic information systems.
5. The recipient agrees to provide NHHNB with documentation of any rare species or exemplary natural communities found during the course of this Data Sharing Agreement, unless prohibited from doing so by other agreements. The recipient will use reporting forms as provided by NHHNB.
6. The digital data provided is to be used only for the purposes specified above. Access and use for other purposes, including by the named user, will be made only with prior expressed, written consent of the NHHNB and in accordance with NH RSA 217-A.
7. The recipients agree to delete all copies of NHHNB digital data provided under this Agreement on or before one year from the date the Agreement is fully signed.


**The recipient also acknowledges that:**

- a) This agreement takes effect and is valid for one year from the date of signature.

- b) NHHNB has data use license fees to help support the maintenance of the database. Rates for one year of access to the data are \$0.50 per record for "fuzzed" data (only approximate location provided). Best-available location data are \$10.00 per record for federally listed species, \$2.00 for all others. Processing time is charged at \$60/hour. NHHNB may apply a discount to non-profit and federal agency requests.
- c) Access to NHHNB digital data as described under this Agreement does not eliminate the need to consult with the US Fish & Wildlife Service and/or to submit an Environmental Review request through the NHHNB when state and federal permitting requires such documentation.
- d) Comprehensive surveys for rare species and exemplary natural communities have not been conducted for most of NH, and most NHHNB records have not been visited recently. On-site surveys are the only way to definitively determine whether rare species or exemplary natural communities are currently present at a site.
- e) The NHHNB data are continually being revised and expanded. The data provided in this release will, therefore, become outdated. Should a discrepancy develop between the data provided to the recipients and the data in the NHHNB databases, the data in the NHHNB databases are the correct data.
- f) Accurately interpreting NHHNB data requires a good understanding of Natural Heritage protocols. Users must read the metadata provided. Any questions should be directed to staff at NHHNB (plants and natural communities) and/or NHFG (animals).
- g) **Non-compliance with any provision of the agreement by any recipient may result in the immediate withdrawal of authority to use the digital data provided by NHHNB, and may result in the denial of all future data release requests by the recipient.**
