

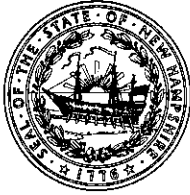

Section V
