Requested Action

Authorize the Department of Justice (DOJ) to accept and expend \$6,000 from the American Bar Association Antitrust Law Section, Janet D. Steiger Fellowship, for the purpose of providing funds to support an intern in the Consumer Protection and Antitrust Bureau for the summer of 2015. This request will be effective with the approval of Governor and Council through September 30, 2015. **100% Agency Income**


Explanation
