The Governor and Council on motion of Councilor Warmington, seconded by Councilor Gatsas, authorized to **retroactively** amend the Cooperative Project Agreement (CPA) with the University System of New Hampshire by exercising the renewal options to extend the end date from July 14, 2021 to July 14, 2025, and increasing the amount by \$4,038,380.00 from \$7,043684.00 to \$11,082,064.00 to implement the iLeanNH System, effective upon Governor and Council Approval. The original CPA was approved by Governor Christopher T. Sununu on July 22, 2020, and mended on October 29, 2020 and submitted to Governor and Council as Informational Item R on February 3, 2021. **100% Federal Funds**
