EXPLANATION

This request is for **Retroactive** payment to ASC for registration expenses incurred during the height of the COVID-19 pandemic. The OPLC has only recently become aware of the unpaid invoices and is seeking approval to pay fourteen (14) unpaid invoices for the registration of Real Estate Appraisers on the ASC National Registry that were overlooked during the pandemic.

The ASC has been in existence since 1989. Registration of Real Estate Appraisers on the ASC National Registry is required by Title XI of the Federal Financial Institutions Reform, Recovery, and Enforcement Act of 1989. Financial institutions accessing federally funded housing programs are required to have property appraisals completed only by appraisers listed in the ASC National Registry.

Real Estate Appraisers who paid licensing and associated fees to the OPLC did so in good faith that the fees associated with the ASC National Registry would be paid on their behalf. Unfortunately, the COVID-19 global pandemic made it difficult to keep up with these federal
