Requested Action

Authorize the Department of Safety, Division of State Police, to accept and expend an additional \$49,780.00 of federal funds from the NH Highway Safety Agency entitled DWI Patrols for the purpose of combating the DWI problem statewide. Effective upon Governor and Council approval through September 15, 2014. Funding Source: 100% Agency Income.

Explanation

In an effort to combat the DWI problem, the NH State Police will hire, on an off-duty basis, currently employed State Police troopers who have completed training in the identification of intoxicated drivers. These troopers will conduct DWI enforcement patrols on evenings when the impaired driver is felt to be most prevalent.

As a result of the patrols, it is anticipated that Troopers will make a total of 175-225 arrests for alcohol and drug impaired driving. The motoring public will also perceive an increased enforcement effort on our highways.

Additional funds are to be budgeted as follows:

Additional funds in Class 18 are needed to pay the overtime for details as approved by the approving Federal Agency.

Additional funds in Class 40 are needed to pay the indirect cost on the remaining appropriations.

Additional funds in Class 60 are needed to pay for benefits associated with the overtime for the details as approved by the approving Federal Agency.

This grant was budgeted, but due to budgeting two years in advance of receiving the grant, the anticipated amount was underestimated, therefore resulting in the above requested action.

In the event that Agency Income Funds become no longer available General and/or Highway funds will not be requested to support this program.




